HB 252	RELATING TO CONVEYANCE TAXES FOR SPECULATIVE SALES. Increases conveyance tax rates.	WLH, EDB, FIN
HB 507	RELATING TO BOATING. Prohibits the transfer of the small boat harbors to a county without legislative approval.	WLH, LMG, FIN
HB 251	RELATING TO WATER CONSERVATION. Prohibits use of potable water to irrigate new golf courses effective 7/1/10, except where there is no reasonably available source of nonpotable water or use of nonpotable water poses a threat to public health and safety or other surface and ground water uses. Defines potable and nonpotable water. Emphasizes role of nonpotable water in programs for the development, conservation, protection, control, and regulation of water resources.	WLH, EDB, FIN
HB 652	RELATING TO DAM SAFETY. Establishes requirements for dam inspection and safety. Establishes penalties for failure to comply. Creates dam safety fund. Creates dam rehabilitation loan program.	WLH, JUD, FIN


DECISION MAKING TO FOLLOW
