| HB 1581 | RELATING TO OCEAN HEALTH CONSENSUS.
Appropriates funds for the center for conservation research and training at the University of Hawaii to develop and implement an ocean health consensus project to build community based consensus in Hawaii for managing ocean ecosystem resources. | WLH, FIN |
| HB 903 | RELATING TO REAL PROPERTY LEASES.
Requires the lessor of commercial and industrial properties to pay the lessee the market value of improvements made by the lessee in the event that the lessor does not renegotiate the lease with that lessee. | WLH, CPC |
| HB 1602 | RELATING TO INFRASTRUCTURE.
Establishes the county infrastructure capacity construction loan revolving fund and appropriates moneys to support the counties' infrastructure improvement efforts by loaning funds for capital improvement costs from the revolving fund. | WLH, FIN |
| HB 1621 | RELATING TO HIGHWAYS.
Directs department of land and natural resources to determine ownership of certain private lanes in urban Oahu. | WLH, FIN |
| HB 1667 | AUTHORIZING THE ISSUANCE OF REVENUE BONDS FOR THE PURCHASE OF LAND TO DEVELOP KALAELOA COMMUNITY DEVELOPMENT DISTRICT.
Authorizes the issuance of revenue bonds in the amount of \$ for the acquisition of land within the Barbers Point Naval Air Station by the Hawaii community development authority to develop the Kalaeloa Community Development District. | WLH, FIN |

HB 844 MAKING AN APPROPRIATION FOR THE PURCHASE OF REAL PROPERTY IN WAHIAWA, OAHU. WLH, FIN
Makes an appropriation for the purchase of land in Wahiawa, Oahu, underlying Lake Wilson or in the event of grant of the land by the landowners, an appropriation to maintain the Wahiawa dam.

HB 832 RELATING TO HOUSING. WLH, FIN
Requires the land survey division of the department of accounting and general services to establish the boundaries of the Del Monte employee housing at its Kunia camp comprising of approximately 50 acres of TMK: 1st Div: 9-2-005:002. Makes an appropriation to purchase the housing area for eventual resale to former Del Monte employees and retirees presently inhabiting the housing.


