Pursuant to Senate Concurrent Resolution 107, Senate Draft 1, House Draft 1, the 2015 Legislative Family Caregivers Working Group is convening to examine and assess issues related to family caregivers, including but not limited to: the role of family caregivers; the current practice of designating family caregivers; notification of family caregivers when a hospital discharges a patient or transfers a patient to another licensed facility; family caregivers' involvement in discharge planning and instruction; the role of hospitals and hospital staff in the instruction of family caregivers; the role of insurance plans in paying for the instruction of family caregivers by hospitals and hospital staff; and legislative and regulatory recommendations on how best to involve family caregivers in the patient-discharge process and prepare family caregivers for post-discharge tasks.
