Representative McKelvey rose to speak in support of the measure, stating:

"In strong support, comments to the Journal."

Representative McKelvey's written remarks are as follows:

"This historical company began on Maui 140 years ago. It is the last remaining sugar plantation in our state. HC&S is a big part of our heritage that spurred ethnic diversity, culture, and the business community we have

today. Regretfully, HC&S will stop farming sugar at the end of 2016, and will instead pursue a diversified agricultural model for the 36,000 acres presently in cultivation. This is a tragic loss for our community and our hearts, prayers and thoughts are with the employees during this difficult time. Sadly, closings of sugar plantations are not new, and many well know the struggles families face when this happens, especially in families where members have worked for the plantation for generations.

"Many of these loyal and dedicated workers affected have worked for the company for decades, have English as a second language, are not computer literate, need assistance putting together resumes and applying for other positions, and need significant retraining to qualify for the jobs available. This funding will be of great assistance in that regard as our community looks to address those needs, along with the employee's financial, health, mental health, and social needs.

"Mr. Speaker, the announcement by HC&S on the same day as a similar announcement by Hamakua Springs of their closure clearly demonstrates the challenges faced by commercial agriculture. Yet, Hawaii wants to see agriculture as part of their plan for increased self-sufficiency, and sustainability.

"There is a lot to be done, and I support HB 2186, HD 1 for these additional reasons.

1. The reality of HC&S's shutting down hits home with the first wave of layoffs on March 7th affecting 95 employees, culminating with their entire workforce of 675 being reduced to 15 by the end of the year.
2. While the transition to diversified agriculture on HC&S's lands may afford these workers future employment, these plans coming to fruition are years away. The ramifications of HC&S's shutdown are exponential and affect more than the 675 workers directly impacted, therefore it is crucial to get these individuals back to work.
3. Training, retraining and workforce assistance programs offered by state and federal agencies are imperative in assisting the workers directly impacted as well as those indirectly impacted. Furthermore, according to the U.S. Department of Labor Secretary Perez, these job-driven training programs have a positive track record of providing jobs in many different industries.

"Based on the aforementioned, I strongly support House Bill 2186, HD 1, making this as smooth of a transition as possible for our affected families, neighbors, and community members."

No. 2714, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WORKFORCE DEVELOPMENT," passed Third Reading by a vote of 48 ayes, with Representatives Kong, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 689-16) recommending that H.B. No. 2199 pass Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 2199 pass Third Reading, seconded by Representative Evans.

Representative Thielen rose to speak in opposition to the measure, stating:

"Thank you. Mr. Speaker, I am standing to speak against Stand. Com. Report 689, House Bill 2199. Mr. Speaker, what this bill would do is establish a transit-oriented development authority within the Department of Business, Economic Development & Tourism. And that authority, that new authority, would oversee and manage development of infrastructure on state lands within a one-quarter-mile radius of the rail stations.

"I think there are a number of reasons this bill and this concept doesn't make sense. Budget and Finance made a determination that the nexus between the TOD and the TAT, which would be funding it, is not very clear. And then the TAT also was not meant to support projects like this transit-oriented development authority. DBEDT isn't particularly the right department to handle this, and the jurisdiction given to the State in the bill would take away the control of economic development from the private sector and from the city and county.

"The other thing that is puzzling of this, a lot of the state land is within a half-mile radius of the rail stations. The bill only would set up an authority to deal with half of some of those parcels, and that doesn't make sense. The other thing, requiring a memorandum of understanding with the State through DBEDT for any TOD project adds more red tape and delay.

"So if the point is we need to move ahead with rail, which I am sorry we're doing, but we are. But if we need to move ahead with the rail, the development radius that's been established by the city and county I think makes more sense. We don't need to create another layer of bureaucracy over that. This is one time that I understand the city and county has its act together and things are moving quite smoothly for that development.

"Now we at the State Capitol step in and start to muddy the waters, and I think there's some serious problems with this and I would urge Members to rethink this. It will be going to the Senate, but we may or may not have another shot at it, and I just think it's not a good idea. Thank you."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. Mr. Speaker, using Japan as an example, if done correctly, this has enormous potential. The transit-oriented development around the stations in Japan literally ended up paying for the mass transit in a number of the areas that they developed, without any taxpayers' money. My fear is, this bill in DBEDT has a high chance of doing very, very poorly.

"This has to be done vigorously, has to be done accurately, and if it's not, we are just pretending that we are going to actually do this. Because it has to be done aggressively, and as my colleague said, it has to be done with the private sector leading it, but we have to facilitate it, not get in the way. So far what I've heard, the city's properties and the State's properties have been a bottleneck to this development, not a facilitation.

"So this is good intended, but I think we've got to watch it and make sure it works properly. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2199, entitled: "A BILL FOR AN ACT RELATING TO TRANSIT ORIENTED DEVELOPMENT," passed Third Reading by a vote of 47 ayes to 1 no, with Representative Ward voting aye with reservations, with Representative Thielen voting no, and with Representatives Kong, Saiki and Tupola being excused.

Representative McKelvey's written remarks are as follows:

"Lay caregivers play an important but often highly challenging and stressful role in supporting the health of their loved ones during their worst of times. Mr. Speaker, taking care of a loved one goes far beyond just the hospital including trips to the store and other activities of daily living where the caregivers and their loved ones may be put in hazardous situations because they haven't received the appropriate information and instructions prior to discharge.

"Engaging caregivers in a patient's discharge planning process is essential to successfully transitioning a patient back home. Patients can benefit when their lay caregiver is identified and receives appropriate information and instructions prior to discharge. Mr. Speaker, this measure will assist patients and their caregivers in the transition from the hospital back to the community setting.

"I sincerely hope that further work can be done to develop community supports for lay caregivers. There are a myriad of concerns that caregivers face in the home setting. However, I believe this bill represents a deliberative process to provide comprehensive recommendations that

address some of the root issues facing family caregivers. Therefore, I support HB 2252, HD 1."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2252, HD 1, entitled: "A BILL FOR AN ACT RELATING TO DISCHARGE PLANNING," passed Third Reading by a vote of 48 ayes, with Representatives Kong, Saiki and Tupola being excused.

On motion by Representative Souki, seconded by Representative Evans and carried, the report of the Committee was adopted and H.B. No. 2744, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOUSING," passed Third Reading by a vote of 48 ayes, with Representatives Kong, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 707-16) recommending that H.B. No. 1958, HD 1 pass Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 1958, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Tokioka rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Tokioka's written remarks are as follows:

"Thank you, Mr. Speaker, for allowing me to insert written remarks with reservations to HB 1958, HD 1. Mr. Speaker, I understand the intent of this bill and the incentives for people who are using the low income subsidies. However, there are currently no conditions on how the monies after the five year period will be spent by the citizens utilizing this subsidy. I do not believe it is in the best interest to incentivize the renting of units to Section 8 holders by exempting rental subsidy payments for Section 8 and Housing First Programs from the general excise tax without setting a clear framework of conditions on how the monies accrued will be used."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1958, HD 1, entitled: "A BILL FOR AN ACT RELATING TO A GENERAL EXCISE TAX EXEMPTION FOR LOW INCOME RENTAL SUBSIDIES," passed Third Reading by a vote of 48 ayes, with Representative Tokioka voting aye with reservations, and with Representatives Kong, Saiki and Tupola being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 708-16) recommending that H.B. No. 2638, HD 1 pass Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 2638, HD 1 pass Third Reading, seconded by Representative Evans.

Representative Jordan rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Jordan's written remarks are as follows:

"I would like to express my reservations on HB 2638, HD 1. This bill authorizes the Public Housing Authority to impose maximum rental periods of five years for state low-income housing projects which receive state funds for repair and maintenance or capital improvement, provided that the maximum rental periods do not apply to tenants who are disabled or 65 years of age or older; requires rates for the five-year rentals to be fixed for entire term of lease; and establishes a trust account for the Authority to provide matching funds for tenants who are required to participate in the Family Self-Sufficiency Program for those five-year rentals.

"I don't believe this bill is the correct approach to address this concern, with an estimated 800 units available for this program and about 75% of those used by elderly or disabled, does not provide enough inventory to address a Public Housing waiting list of over 10,000 applications. Currently the Hawaii Public Housing Authority already provides the Family Self-Sufficiency Program to qualified tenants and should focus on promoting the program to current tenants.

"I also acknowledge what the Executive Director of the Hawaii Public Housing Authority noted in his testimony, 'that multigenerational public housing is an issue that should be addressed and is one of the main reasons for long waiting lists.' I don't believe this bill is the correct approach to address this concern."

Representative Rhoads rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, thank you. With reservations as well. I don't like to inhibit innovation, but I think the proposal has some serious hurdles to overcome, probably the most difficult being that I'm not sure where these people are going to go live after they're out of the public housing projects. But I will withhold judgment since it's still a work in progress. *Mahalo*."

Representative Oshiro rose in support of the measure with reservations and asked that the remarks of Representative Rhoads be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2638, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC HOUSING," passed Third Reading by a vote of 48 ayes, with Representatives DeCoite, Jordan, Oshiro, Rhoads and Tokioka voting aye with reservations, and with Representatives Kong, Saiki and Tupola being excused.

Representative Jordan's written remarks are as follows:

"I would like to express my reservations on HB 2311. This bill amends Act 27, Session Laws of Hawaii 2014 and authorizes the Department of Health (DOH) to continue to disclose, including through electronic means, lists of names of persons whose deaths have been recorded by DOH to state agencies that maintain official lists of persons.

"While I acknowledge that the administration is requesting an extension of the sunset for sharing this vital information between agencies of the State, my concerns are the lack of progress and funding for the Department of Human Services (DHS) to complete the build-out of electronic interfaces and enhanced match programs with the DOH to access the death vital statistics to compliment online eligibility applications of the DHS electronic platform aka KOLEA. The DHS to date has not begun this vital build-out, nor requested the 10% state funds to bring in federal matching dollars of 90% to complete this platform build-out. The completion of the electronic platform is critical to information collection and transfer between state departments for program savings, correct eligibility matching for applications, and aligning multiple programs for applications."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2311, entitled: "A BILL FOR AN ACT RELATING TO REPORTING DEATHS TO STATE AGENCIES," passed Third Reading by a vote of 48 ayes, with Representative Jordan voting aye with reservations, and with Representatives Kong, Saiki and Tupola being excused.

I think this would be premature to not get insight or download from what that case actually settles as. Thank you, Mr. Speaker."

Representative McDermott rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition on this measure. Mr. Speaker, my good friend the Chairman of the Judiciary Committee and I just have an ideological disagreement. I respect him enormously. But this one, although well intended, and certainly I've been as hard on terrorism as anybody, in fact I wore the uniform of our country in the first Gulf War, so I know a little bit about sacrificing, servicing and protecting our country.

"But here, Mr. Speaker, it's been admitted that 28% of this nebulous terrorist watch list is inaccurate. Twenty-eight percent, fully one-third. Now, the watch list is different from the terrorist no fly list. In fact, the watch list has 700,000 people on it. What is the criteria to get on the watch list, Mr. Speaker? Rhetorical question asked and answered, of course you don't know and neither do I.

"So, we do not know what it takes to get on the terrorist watch list, which is this huge, voluminous list. In fact, 200,000 people on that list have no ties or relationships to any terrorist-related organization. Not even, I'm married to my sister-in-law's brother whose cousin lives in Detroit and goes to a mosque that has terrorist-related folks. That's how tangential you can be to get on this list.

"And we know this because classified documents were obtained by an internet media publication called Intercept, and published last April. The fact is, the Federal Government doesn't do a very good job of this. And I would notice that, we never heard of this before until the attacks in San Bernardino. And then the Obama Administration said, terrorists on the no fly list shouldn't get weapons. That was the solution to the San Bernardino attack.

"But it had nothing to do with San Bernardino, because the people who committed the attacks weren't on the terrorist watch list, weren't even on the no fly list. And their buddy got them the guns.

"What we're doing is making burdens harder on law-abiding citizens. We're making it more difficult for law-abiding citizens to own weapons.

"And if we're concerned about terrorism, why isn't there a provision in here for bulk purchases of fertilizer? A thousand pounds of fertilizer, you got to register with somebody, right? Because you're going to do more damage with that than you are with a weapon.

"And if someone wants to buy guns to commit a criminal act, guess what? They're criminals. You pass a law, I'm just going to go around it. I'm in Los Angeles, I'm going to go to a L.A. gang or the Mexican mafia if I want a fully automatic weapon. I'm not going to go down to the gun store, sign up, put my picture in there. Yeah, I want an AR-15. And then find some gun smith who converts it to fully automatic. I'll just go buy an AK-47. I'll pull up to the Pirus or the Crips or the Bloods and say, look, I need an AK-47. And they'll charge me a lot, and they'll sell it to me, and I'll get that weapon.

"There is a tension between public safety and individual rights, and I understand that. I think here we cross the line. I think this is, the intention is wonderful, protect people. But 700,000 folks and there is no criteria. And then you don't know how to get off. How do you get off? Write a letter. Oh, we know how good that works. Write a letter to who? Who? Who do you write the letter to? The President? I mean, I don't know.



"And so to take away someone's constitutional right, to infringe upon that articulated constitutional right, not a made up one that we often make up, an articulated one, because someone suspects them of some unreasonable act. That's a pretty high burden. And it shouldn't be done willy-nilly, and I think this is a political bill designed to chip away at our gun rights.

"And I will tell you that in my 10 years in this body, these are the most gun bills I have ever seen in one session. So I don't know what's going on, but I stand in opposition to this. Thank you very much."

Representative Choy rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I know it's second reading, but it's an important bill and I just want to point out a couple of things. First of all, I don't believe that there was any testimony that said that the watch list had a 28% error rate at this point. But remember what we're talking about, we're talking about suspected terrorists.

"I would also point out that the United States Government Accountability Office, which is Congress' investigative arm, the statement was made by a previous speaker that the terrorist won't just walk into a gun store and try to buy a gun. That's not true. GAO found that there were 2,233 attempts, and that 91% of those attempts were successful, that people on the terrorism watch list purchased guns at a legal store. I don't think that's good policy.

"I would also note that the bill itself says, it doesn't necessarily say that if you are on it, it's a temporary, basically it's a hold. If you're applying for a gun and you're on the terrorism watch list, it's a hold until you're off, or until the Federal Government tells local authorities that, okay, we recognize that we've got this person on the watch list, there is no reason not to sell them a gun, go ahead and sell it to them. So there is a safety built into it.

"But again, let's get back to the underlying point. These are people that the Federal Government believes are terrorists, and giving them guns just doesn't make any sense at all. *Mahalo.*"

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Thielen rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations. I would like to just respond to a few things that the Judiciary Chair said. I agree with him that terrorists should not be able to be armed, and I fully support that. But the difficulty is that we know that there are inaccuracies on this list. Some included having a three-year-old on the list. So, we know that there are problems.

"The other thing is, I think the bill is very weak on how the person who is not a terrorist can regain her or his weapon, because this bill would prohibit them from possessing, controlling, owning. And then it says, until the Federal Government otherwise indicates. Well, my goodness, trying to get the Federal Government, who and what are they indicated, is such a waffly type of a thing.

"I would be much more comfortable if we had a provision in here saying that there could be a court appeal of the weapon owner to be able to go right to our state court. Or, if they have to, to federal district court. But something that would allow them to be able to get back something that they legitimately had when they are not a terrorist but were placed on the list erroneously.

"So I am with reservations, and I think the bill certainly needs more work, in particularly to protect the constitutional rights of law-abiding gun owners. Thank you."

Representative McDermott rose to respond, stating:

"Here's the good news, I probably won't talk much on third reading, I'll get it out of my system. So that's as a courtesy to the Members. But again, we're talking about suspected. Suspected. Well, you could suspect I drank this morning before I came in here, it doesn't mean I did. You could suspect I used medical marijuana this morning, it doesn't mean I did. Suspected. Twenty-two hundred suspected. Doesn't mean they were terrorists, they just had their rights jacked around.

"Now, I will note that the San Bernardino terrorists weren't on the no fly list, weren't on the terrorism watch list. The Boston bombers weren't on the no fly list, not on the watch list. Bad people do bad things. And to have some nameless, faceless bureaucrat somewhere sitting in a building, suspecting me of something with no criteria that I am aware of which will not be shared, to infringe upon my constitutional rights.

"Now, we get a little sensitive in this building about constitutional rights, when it fits our political flavor of the day. But this one, oh, this is no good. But it is an articulated constitutional right, and to have that infringed upon, or suspended, just because some bureaucrat suspects you in some office somewhere because you went to Idaho and you attended some militia meeting with your cousin, you didn't know what the heck it was, you're on the watch list.

"And by the way, 700,000 people, that's who we are. And I would find it ironic that probably the folks who are supporting this stuff would also welcome Syrian refugees with open arms, they're not terrorists. Just the rednecks who are living in the Midwest are terrorists. So, I just don't support this. I think we are infringing upon a constitutional right.

"The Federal Government does very few things well. One of them they do well is fight wars. But keeping data and keeping accurate data and providing recourse to get off that list, it'd just be a nightmare. So, again, I stand against it."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ito rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Pouha rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, in support. I'll just say two things now since this is when the debate's happening and I'll say nothing tomorrow, or whenever it is. But I wanted to just note that with the number of attempts being made by those on the terrorism watch list happening all around the country, including here in Hawaii, it is only a matter of time until one of those, and when 91% are successful, actually goes through, and you end up having an incident because of that. The day that happens, which this bill could potentially prevent, those deaths are on us. Thank you, Mr. Speaker."

Representative Oshiro rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I'm not a gun owner, but many of my constituents are gun owners, hunters. I'd like to cast a reservations vote and have the words of my friend from Kailua entered into the Journal as my very own. Thank you," and the Chair "so ordered." (By reference only.)

Representative LoPresti rose to speak in support of the measure, stating:

"I stand in support. I just ask that the words of the Representative from Kailua be entered into the Journal as if they were my own. And I believe many of my constituents are gun owners as well, but I don't think that many of them are terrorists, and I don't think it's going to affect them in this way. That's why I am in favor. Thank you," and the Chair "so ordered." (By reference only.)

Representative Fukumoto Chang rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I also wasn't going to talk on second reading, but since everybody else is. My comments are just basically, I know George W. Bush had actually introduced a similar measure to this, so I think we should give it some due consideration. Perhaps my vote will change within the next couple of days, but I want to look into that a little bit further, because I believe it was actually congressional Republicans that killed this bill when it went through Congress under George W. Bush. So I'd like to make sure that we are not too quickly trying to kill something that might be a good thing. Thank you."

Representative Ing rose to speak in support of the measure with reservations, stating:

"In support of the measure with some slight reservations. Some human rights groups across the nation have recognized that the terrorist watch list can disproportionately represent minorities and, more particularly, immigrants. There's probably a lot of work to be done to clean up that list to make sure that it's fair. The last thing that I want to see is us infringing on the rights of minorities and oftentimes underserved populations in our state. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, in support until I see a better bill. The reality is, our nation is under threat. The reality is, we are in a state of emergency, whether we realize it or not. It's not if, but when. Because of that, we have to err on the side of caution. That's what this bill is doing. Now if there's a better way to nuance it, fine. But right now, we do not know what's going to happen in this state, in Europe, on the mainland, in any place where there's a soft target, and there's a lot of soft targets, Mr. Speaker.

"You know this building is open to anybody, any time, for any device, because we don't inspect anybody in here. I am not saying it's going to happen, but we have to as a nation be aware there's a lot of people out there who hate us, a lot of people out there just waiting for a vulnerable place. So this bill errs on a side of a caution. It probably could be better written, but I think it's the right prudent path to take. Thank you."

Representative McKelvey rose in support of the measure and asked that the remarks of Representative Ward be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Lowen rose to speak in support of the measure, stating:

"In support, but I'd also like the words of the speaker from Kihei entered in the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative San Buenaventura rose to speak in support of the measure, stating:

"In support. I am deeply aware of the Representative of Kihei's concerns, especially in my district where there's been a lot of false arrests. However, we had testimony from Major Robinson at the hearing, and he talked about his personal, his brother being in this watch list and was denied access, and how relatively easy it was to correct that error. And as such, I believe the Second Amendment rights of those who are falsely accused is taken into account by this bill. And like the Representative from Hawaii Kai, we err on the side of caution. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1813, HD 1, entitled: "A BILL

FOR AN ACT RELATING TO FIREARMS," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Choy, DeCoite, Har, Ing, Ito, Jordan, Matsumoto, Oshiro, Pouha, Thielen and Tokioka voting aye with reservations, with Representative McDermott voting no, and with Representatives Kong, Saiki and Tupola being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 721-16) recommending that H.B. No. 2773, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 2773, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am going to vote no on this. Here we have criminals. Criminals. We're going to allow them to vote. We just talked about suspending the constitutional rights of God fearing, God abiding American citizens, because someone suspected something. And now we're going to say, well, you committed a crime, but you're in the pokey here, you're in jail, so we're going to let you vote.

"Why don't we give them guns, too? Teach them how to responsibly care for them. Make them law-abiding citizens. Clean your weapon, put it away at night, show us that you're rehabilitated. I mean, what are we doing here? What are we doing? Constitutional rights, and now we've got this. We're going to let prisoners vote. Makes no sense. No sense at all."

Representative Takayama rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kawakami rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, no vote and a brief comment. Mr. Speaker, as others have said, this clearly enfranchises, gives the right to vote to people who are prisoners in prison. The law now is, if you've paid your dues, you get out, you can vote. That is the way that, I guess, the system is working.

"As Kat Brady reminds us, there are 6,000 people incarcerated in the State of Hawaii, or on the mainland 1,800, she almost has it down pat to where we are reminded how many people this bill would affect.

"But let's talk about the 200,000 who don't vote, who are healthy, who are free. You know what the voter turnout was in the last election, Mr. Speaker? Fifty percent, give or take a couple of points depending on where you are in the State at any given time. Mr. Speaker, we have to incentivize those people who are legitimate.

"And the other thing on a personal level, every Sunday I work with prisoners. I have a Sunday school class with prisoners. I have never heard a view of, I'm being deprived of my vote. I'm paying my dues to society, and when I get out, I want to be a proud citizen.

"But there's never been a demand that I've ever heard or a study that I've seen that says we ought to get, I would say they would probably vote for better chow than they'd vote for the right to vote. Life in prison is not a

pleasant thing. Voting is probably the last thing on their mind. And for us to say that we are going to seek out, to bump up our participation by giving prisoners the right to vote. People are probably going to want us to examine who we are and what we're here for. Thank you, Mr. Speaker."

Representative Ing rose to speak in support of the measure, stating:

"In support, just a few comments. So, I introduced this bill on behalf of some members of the Office of Hawaiian Affairs. Give it a fair hearing. And the response has been alarming. It has also been very encouraging. People reach out to me from prison saying, we're probably more engaged than most people are in the general public, we're always in the law library, we're more interested in our own constitutional rights than the average citizen. And rightfully so, obviously so.

"On a libertarian side, denying anybody any constitutional right is just wrong. The Fifteenth Amendment or right is an inalienable one, period. So we've got to reexamine why are we denying these people the right in the first place. That's from a libertarian stance.

"Now, from a conservative stance, the system is not working. People are going into prison, they're coming out, they're committing more crimes. They're not rehabilitating. People are recognizing this across the nation. This isn't a Democrat thing, this isn't a Republican thing. Red states have prison reform more, they're moving a lot quicker than most of the blue states, as a matter of fact. And the reason why is because it's very expensive to put somebody in prison, over \$60,000 a year in Hawaii if you account for all the costs.

"So, this is beyond just compassion. This is in the interest of A) public safety, because people are more likely to commit crimes if they don't feel like they are part of society, rather than I am against society.

"In the interest of fiscal responsibility, this could save our state millions. And the reason why is because there is no better way to let somebody feel like they're part of the society, as opposed to against it, than getting them civically engaged. And they are not going to be civically engaged if they can't vote. This is demonstrated time and time again.

"There is a massive incarceration movement across the nation right now, and the low hanging fruit of policy proposals supposed to be letting out low level drug offenders. If that's low hanging fruit, in Hawaii we're not doing that. This should be like the fruit already on the ground and we just got to pick it up. The *liliko'i* that you can pick up, if you ever have a *liliko'i* tree.

"That's all that this bill is. It's very simple. So, if you're not going to vote on it in interest of compassion from the liberal side, then at least vote on it through the conservative view of fiscal responsibility, or through the libertarian view of an inalienable constitutional right. Thank you."

Representative DeCoite rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I speak in opposition of HB 2773, HD 1. This bill does not address the needs of the general public. People that do not follow the law should not be allowed to participate in a process that makes those laws possible. When a person commits a crime, they not only commit these crimes against the victim, but against our entire community."

Representative Choy rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Cachola rose to speak in support of the measure with reservations, stating:

"With reservations with a little bit of comments. I understand that those who are incarcerated, the city prosecutor has a hand on it. And they are

elected officials. So it's more or less a way where in those who are incarcerated might end up banding together against a city prosecutor.

"Those are the things that I can see as a negative part of this. Then we are going to change our laws that allow the Attorney General's Office to be more or less like elected officials. If they hate the Governor they might end up looking at banding together. In a close vote, they can make a big difference. That's the reservations that I have. Thank you."

Representative Ito rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of the measure, stating:

"In support. Hawaiians are disproportionately incarcerated. This bill allows for, it's a limited amount of criminals that are going to be allowed to vote. It doesn't allow for violent criminals, it only allows for certain Class C, not even for voter fraud. It's a limited amount of criminals that's going to be allowed to vote. It is a constitutional right.

"We are now seeing with medical marijuana dispensaries in the light that we are starting to progress towards penal reform. And those people who have been relieved of their right, the constitutional right to vote because of what was once a felony and is no longer a felony, should now be allowed to vote. And this bill would allow for that, would allow them to be part of society again. Thank you."

Representative Souki rose to speak in support of the measure, stating:

"Mr. Speaker, I wish to speak strongly in favor of this measure. I wish to adopt the words of the Representative of Kihei and words from the Representative from Puna. Thank you very much," and the Chair "so ordered." (By reference only.)

Representative Ward rose to respond, stating:

"Mr. Speaker, second time. Regarding the words from the Representative from Puna, I believe that there's better ways to help the Hawaiian community. There are so many ills that we've allowed or neglected. Atop of the hierarchy is obviously not voting, but how about \$28 million from this body to get housing? How about educational opportunities? How about drug treatment? In fact, that's the one issue that I would have issue with the Representative from Kihei who has teaching regarding what a conservative position is. Having been a conservative, I appreciate his advanced learning in this regard.

"But what we really need is to rehabilitate those who are on drugs. To give them training. To give them a job. We just passed a bill here yesterday, or at least in the committee, that allowed the prisoners to make products to sell to the public, which, duh, we should have done years ago. So we are failing as a state to rehabilitate those who are in prison. We lock them up, we give no rehabilitation to them. In fact, it's probably the better place to learn crime, according to some sociologists. You will learn more about crime by being locked up with criminals than anything else.

"So, Mr. Speaker, if you do the crime, you do the time. But we've got to get these drug rehabilitation and otherwise vocational and otherwise outreach training, if we're going to do it. Otherwise, I would say, if this is a Hawaiian bill, I would trade it for a lot more education, income, housing, homelessness, and all the other ills in the Hawaiian community, which I'm sure OHA would not have as one of its priorities. Thank you."

Representative Tokioka rose, stating:

"Thank you, Mr. Speaker. Point of information. Is this the section of the second reading bills?"

The Chair addressed Representative Tokioka, stating:

"You're correct, it's second reading bills."

Representative Tokioka continued and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative LoPresti rose in support of the measure and asked that the remarks of Representatives Ing and San Buenaventura be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Pouha rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Johanson rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Fukumoto Chang rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2773, HD 1, entitled: "A BILL FOR AN ACT RELATING TO VOTING," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Cachola, Choy, Fukumoto Chang, Ito, Johanson, Kawakami, Matsumoto, McKelvey, Pouha, Takayama and Tokioka voting aye with reservations, with Representatives DeCoite, Har, McDermott, Thielen and Ward voting no, and with Representatives Kong, Saiki and Tupola being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 722-16) recommending that H.B. No. 2645, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 2645, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I wanted to register a no vote because of the way the bill is constructed. If you steal someone's bicycle who is on their way to work or uses it for work, you become more of an aggravated assault, or it becomes an intensifier.

"Mr. Speaker, what about bus passes, if you steal somebody's bus pass? That's essential. A car. I go campaigning on a Segway, what if somebody steals my Segway? Does that mean they're denying me my right to reelection?

"Mr. Speaker, I am not sure what is behind this, but it looks a little frivolous the way it says if it's somebody's bicycle. Now if this is a sympathy vote for the homeless, I can see, yeah, the homeless probably use bicycles to get to work, if they are working. But I don't understand the logic of why we are down at this level of granularity that if someone steals a bicycle we are going to exponentially increase the intensity of the felony or the misdemeanor, however we are going to punish those who did thievery. For those reasons, Mr. Speaker, I await clarification. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2645, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THEFT OF BICYCLE," passed Second Reading and was placed on the calendar for Third Reading, with Representative Ward voting no, and with Representatives Kong, Saiki and Tupola being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 723-16) recommending that H.B. No. 625, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 625, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am going to cast a no vote on this. How does anyone vote against this? Includes misdemeanor stalking and sexual assault among the offenses that disqualify a person from owning a firearm. How can you vote against that?

"Well, I don't think the bill is needed, Mr. Speaker. If someone is stalking or harassing, if you are stalking me, for example, I would get a temporary restraining order against you. At least I hope I would, that would be the first step. And your guns are immediately removed. They're gone.

"If you're stalking me or harassing me, I get a TRO, we take your guns away. That's already in the law. So, why is this here? Why are we doing this? So, I guess we haven't educated the public on the recourse that they already have to protect themselves.

"But let's be frank. A TRO doesn't protect anybody. You can take my guns, I can go get another one. I can get a gun this afternoon. Not from a gun store, I know some people I can get a gun from.

"So, this gives us a false sense of protection, like TROs give us a false sense of protection. You can get a TRO against somebody, doesn't mean you're protected. Quite often, it makes them more angry, more irrational. But they take their guns away. But they can still get guns. I mean, they can.

"And I'd like to paraphrase what the Judiciary Chairman said during the hearing. And it's not an exact quote, so please don't get mad at me if I misquote you, but kind of a paraphrase. He asked the AG a question. Is it good legislative policy to have guns taken away, even if stalking didn't involve physical violence or the threat of physical violence? The AG's answer, we're not sure, we're looking at the issue right now.

"So, we don't know if it's good public policy to proceed down this path. We don't want anybody stalking people. We don't want bad people to have guns, of course not. But we are chipping away at constitutional rights that law-abiding citizens have, and empowering those with other rights. So I am going to vote no on this. It is a little convoluted and I can understand why some people will vote yes for it. I don't have a problem with that, but I am going to go no. Thank you."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. Actually, the quote was pretty close. But I would point out that the AG does support the bill. They've thought about it and they do support the bill. And we are not talking about law-abiding citizens here, these are people who have been convicted of crimes. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 625, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIREARMS," passed Second Reading and was placed on the calendar for Third Reading, with Representative McDermott voting no, and with Representatives Kong, Saiki and Tupola being excused.

Representative Rhoads, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 724-16) recommending that H.B. No. 626, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

Representative Souki moved that the report of the Committee be adopted, and that H.B. No. 626, HD 1 pass Second Reading and be placed on the calendar for Third Reading, seconded by Representative Evans.

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am going to vote no. This bill, of course another well-intended measure, but the hunter who cleans his weapon can't have a beer in his possession while he is in his garage.

"Now we heard a horrible story about an accident that happened where a guy was drinking a beer and killed himself. Accidents do happen. But a hunter can't drink a beer and clean his rifle. Well, that's what hunters do. If a young lady goes to a party, has a designated driver, has couple of drinks, comes home, and an intruder bursts in her home and she pulls out her pistol from her night drawer and blows this individual away, she is guilty of a crime because she is intoxicated.

"So, I don't know why all these gun bills are coming up this year. I just don't know. I've never seen anything like it in the 10 years I've been here. But I am going to vote no on this one as well. Thank you."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I would just suggest to Members that they read the bill before third reading, because most of what the previous speaker said is not true. Thank you."

Representative McDermott rose to respond, stating:

"Point of personal privilege. That's his opinion. I just disagree with him intellectually. I haven't attacked him personally. I haven't said he said anything untrue. I did read the bill. I watched the hearings. I was there, I heard the questioning go back and forth.

"You cannot test to see if the person is intoxicated. There is no voluntary limit to do that. So I would appreciate the personal antagonism be shelved. If you disagree with me, that's fine. But no attacks on my veracity, okay? Thank you very much."

Representative Rhoads rose to respond, stating:

"Mr. Speaker, still in support. I didn't mean it in a sense that I thought that I was accusing the previous speaker of lying. I'm just saying that the way he characterized the bill is inaccurate, and if you read the bill carefully, most of the points that he raised are not supported by the language in the bill."

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I think the state of the art of the bill, it's too loosey-goosey, you can't define, you can't enforce. It's gotta have some clarity and some coagulation, if you will, with the logic. The intention is there, but it's still loosey-goosey the way it's being presented, Mr. Speaker. Thank you."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."
