Representative Ito introduced his friend, Deacon Alfred "Sonny" Kanoho and his wife Marian Kanoho; and his staff, George Okuda.

At 11:47 o'clock a.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 11:58 o'clock a.m.

ORDER OF THE DAY

SUSPENSION OF RULES

On motion by Representative Evans, seconded by Representative Pouha and carried, the rules were suspended for the purpose of considering a certain Senate Bill for Third Reading by consent calendar. (Representative Tupola was excused.)

UNFINISHED BUSINESS

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1613-16) recommending that S.B. No. 2554 pass Third Reading.

Representative Saiki moved that the report of the Committee be adopted, and that S.B. No. 2554 pass Third Reading, seconded by Representative Evans.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. Mr. Speaker, this is a well-intended amendment, because we have a huge unfunded liability. We have a big bond and debts to pay. But Mr. Speaker, this bill kills the 1978 Constitutional Convention clear message to the taxpayers that whenever there is an excess of any funding, they will have it in return.

"Presently we have \$15 billion or so of unfunded liabilities. What is this bill being passed for, in the sense that will we ever get to that point where there will ever be again a taxpayer refund? Mr. Speaker, the people in 1978 were very clear, that when government does its job well it returns its excess funds to the people. And unfortunately, we have rigged the constitutional convention system to where blank votes are no votes, and therefore the probability of ever having the taxpayers again speak to having excess revenues go into their pockets is very, very far and in the future.

"In fact, Mr. Speaker, this effectively kills the 1978 Constitutional Convention return of money to the taxpayers. Or, if you're optimistic and say, well, in 30-some years we will have the unfunded liabilities paid off and then we'll talk about taxpayers return, Mr. Speaker, that's wishful thinking, this in effect is a death knell for the taxpayers for any excess refund in the future of the State of Hawaii. Thank you."

Representative Rhoads rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I've lived in Hawaii about 20 years now and we did get tax refunds a few years back because we were running surpluses at the end of fiscal years, but I never got a tax refund of more than \$1. And the way it was set up, that having a \$1 tax refund probably cost more money to send it out than it was worth, I think that's why this came about and I don't see a disadvantage. Unfortunately, the Member from Hawaii Kai is correct, in my lifetime there's going to be big pressure on the state budget because of the EUTF and ERS obligations. *Mahalo*."

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. This constitutional amendment, the constitution was already changed a few years back where the public had opportunity to vote whether they wanted a credit or allow the Legislature to put money into the rainy day. The public has already spoken and they said, they spoke very loud and clear with a pretty majority amount of vote, that the public wanted the Legislature to have the option instead of a credit to put money into the rainy day, so that when we have a deficit situation we don't close down the schools again. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, one thing I forgot to mention is that I would prefer that this be an incentive for the 2018 constitutional convention, so we have an opportunity to give people the reason why not to have a blank vote, but say yes, as the majority of the people have said they want another constitutional convention, but somehow we've rigged it, or the black robes have rigged it, to where if you blank it, it's a no vote. The merits of the constitutional convention, I am speaking against. In terms of the merits of this bill, I think it takes away the taxpayers 1978 will, and the probability of having another constitutional convention because of the blank votes is a very, very remote possibility. Thank you."

Representative McKelvey rose to speak in support of the measure, stating:

"Just in support and I would like to note, by that logic this probably won't pass either. Thank you very much."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 2554, entitled: "A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE VII, SECTION 6, OF THE HAWAII CONSTITUTION, RELATING TO THE DISPOSITION OF EXCESS REVENUES," passed Third Reading by a vote of 50 ayes to 1 no, with Representative Ward voting no.
