Representative McKelvey rose to speak in support of the measure, stating:

"Mr. Speaker, just in strong support, and would like to thank the Labor Chair and the Finance Chair for diligently working on this issue for our hospital. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, support, brief comment. Mr. Speaker, a very deserving bill for those who work for the State of Hawaii. They deserve fair compensation, timely compensation, and I think this bill lays out a lot of options. But I think as a member of the Finance Committee, and a question that I asked when this went on the floor for the amendment two days ago, I

said, well what might it cost? And I was asking if the chairs might respond to that. And to this day I would repeat, is there a price tag that is what otherwise looks like an excellent bill? That's the question, Mr. Speaker. Thank you."

Representative Jordan rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and S.B. No. 2077, SD 1, HD 2, CD 2, entitled: "A BILL FOR AN ACT RELATING TO SEPARATION BENEFITS," passed Final Reading by a vote of 50 ayes, with Representative Jordan voting aye with reservations, and with Representative Hashem being excused.

The Chair addressed the Clerk who announced that the record of votes for the appropriate measures had been received which indicated that the requisite number of House conferees appointed had agreed to the amendments made by the Senate, and had cast affirmative votes to report said measures to the floor for final disposition.

# H.B. No. 799, HD 2, SD 1:

In accordance with the Conference Committee Procedures agreed upon by the House of Representatives and the Senate, the managers on the part of the House recommended that the House agree to the amendments proposed by the Senate to H.B. No. 799, HD 2, on the following showing of Ayes and Noes:

Ayes, 4 (Yamane, Rhoads, Kawakami and Pouha). Noes, none. Excused, none.

Representative Saiki moved that H.B. No. 799, HD 2, SD 1 pass Final Reading, seconded by Representative Evans.

Representative Jordan rose to speak in support of the measure with reservations, stating:

"With strong reservations, Mr. Speaker. Thank you."

Representative DeCoite rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition and just a few comments. In an area of rural low economic development and for those that have remained living off the land in these rural areas, they depend on these resources to live off of. My fear of the aerial hunting would incur more impacts to those areas of high tourist travel, of area helicopters visiting with tourists. My feeling is that if these areas are very hard to get to in getting rid of a lot of

these animals, then I believe that we should have a strategic plan to track these animals to come out into the open where it is safer for both the department as well as the hunters themselves. For those reasons, I'm in opposition. Thank you."

Representative McKelvey rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I too am in opposition to the measure. I would like the words of the previous speaker entered into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative McKelvey continued, stating:

"For West Maui, hunting, Mr. Speaker, is an important tool of management, but it's also a sustainability thing. Our hunters provide food through the work that they do to keep our rainforests clean of invasive species. So I would rather see us pursue this through measures that unfortunately may not have passed to work and use the hunting community to create sustainability and true ecological removal of pests in a way that won't endanger our visitors who also use this area. Thank you very much."

Representative Yamane rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Thank you. Mr. Speaker, this measure before you was a result by the 1998 court issuing a stipulation requiring the State of Hawaii to incorporate arrow shooting in accordance to the 1979 US district court ruling that requires and stated failure to remove said feral animals, sheep and goats, from the critical habitat, constitutes an unlawful taking of the Palila, in violation of section 9 of the Endangered Species Act. So, Mr. Speaker, the department needs to do this, because we were being required and issued by the federal government.

"But I do want to assure the other members that we've worked with this issue for the last year and a half with the hunters from the various islands. And as part of this uniform aeronautics act is also tied into the gaming commission that we passed for the first time on the floor on Tuesday. In accordance, we are trying to work, have the department as well as the hunters from all islands work together, not only to use this as only a specific tool, but also to support all hunters and game areas throughout the State. So, Mr. Speaker, in support."

Representative Onishi rose to speak in support of the measure, stating:

"Mr. Speaker, in support. Mr. Speaker, it's taken us a while to address this issue for the hunting community and those people that support themselves through subsistence hunting. The need for aerial shooting also addresses invasive species issues, and especially in those very, very hard to reach areas in which it would be dangerous for us or it would be too time consuming for us to send people in to address the invasive species. So, this bill is very much necessary. We already have county legislation that prohibits this activity, and this bill will protect our state employees in doing their jobs.

"We have vetted this with the hunting community, and they understand that the newly formed hunting commission will be engaged in looking at future aerial shooting projects, and will have input into the department and the land board in regards to these projects. So this is a very important bill, I think, to protect our employees and also to help support the hunters in our communities. Thank you."

Representative Evans rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. In support with slight reservations. First of all, I want the words of the Chair of Water & Land and the Vice Chair of Agriculture in the Journal as my own," and the Chair "so ordered." (By reference only.)

Representative Evans continued, stating:

"But the reason I have a slight reservation is because I really know that the hunters are very passionate about animals that are left to die. And if you read the language of the bill, it really is kill or attempt to kill any wildlife. And I'm really hoping, because we do have the chair and the deputy of DLNR in the gallery, that, just to be passionate, because what happens is it's very possible when they do the aerial hunting that they're going to leave animals there just partially wounded and it may take a while for them to die.

"So I just want to point that out that, hopefully we're very diligent in making sure we take care of animals. And the other piece to this is not let the carcass lay there and rot. I think that's always been a concern of the hunters, so I do want to point that out and make it of record. Thank you."

Representative Lowen rose to speak in support of the measure, stating:

"Thank you. In support. I'd like the words of the Chair of Water & Land and the Representative from Volcano entered into the Journal, and I just want to add that it shouldn't be a matter of hunters versus conservationists. There is a lot of ways these two groups can work together, and here at the Legislature we support the access to hunting and conservation efforts, but we need this tool, especially looking at the threat posed by Rapid 'Ōhi'a Death and what that could do to our watersheds on the Big Island. We need every tool possible to try to combat that. So, in support. Thank you."

Representative Tupola rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Creagan rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support. This is a difficult issue. It's difficult for hunters, it's difficult for people who are harvesting animals for food and hate to see them wasted or hate to see them dying while wounded. So it's a difficult position, but I support the efforts of the Chair of Water & Land to resolve this issue and I think he did a great job. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 799, HD 2, SD 1, entitled: "A BILL FOR AN ACT RELATING TO THE UNIFORM AERONAUTICS ACT," passed Final Reading by a vote of 47 ayes to 3 noes, with Representatives Evans, Jordan and Tupola voting aye with reservations, with Representatives DeCoite, McDermott and McKelvey voting no, and with Representative Hashem being excused.

#### INTRODUCTION OF RESOLUTIONS

The following resolutions (H.R. Nos. 176 and 177) were announced by the Clerk and the following action taken:

H.R. No. 176, entitled: "HOUSE RESOLUTION AUTHORIZING AND EMPOWERING THE SPEAKER TO PERFORM AND CARRY OUT ANY OFFICIAL LEGISLATIVE BUSINESS DURING THE INTERIM BETWEEN THE 2016 AND 2017 REGULAR SESSIONS," was jointly offered by Representatives Saiki and Fukumoto Chang.

Representative Saiki moved that H.R. No. 176 be adopted, seconded by Representative Evans.

Representative Ward rose, stating:

"Mr. Speaker, point of Information. Mr. Speaker, this is a usual and customary resolution, it looks to be the same as last year. Except last year there was a possible misinterpretation that if in the event that there was a legal challenge, which the Native Hawaiian Legal Corporation had for DHHL, you had an intervention. And some question as to whether that was allowable in the resolution. And as I had foreshadowed, predicted yesterday or the day before yesterday, it's likely there will be a legal challenge. So my question is, Mr. Speaker, will this resolution empower you again to hire a lawyer and challenge what is alright?"

The Chair addressed Representative Ward, stating:

"This resolution will provide me with the tools to do what I need to do. Otherwise, I don't think your question is appropriate at this time."

At 1:06 o'clock p.m., Representative Saiki requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:07 o'clock p.m.

The motion was put to vote by the Chair and carried, and H.R. No. 176 was adopted, with Representative Hashem being excused.

H.R. No. 177, entitled: "HOUSE RESOLUTION INFORMING THE SENATE AND THE GOVERNOR THAT THE HOUSE OF REPRESENTATIVES IS READY TO ADJOURN SINE DIE," was jointly offered by Representatives Souki and Mizuno.

On motion by Representative Saiki, seconded by Representative Fukumoto Chang and carried, H.R. No. 177 was adopted, with Representative Hashem being excused.

## ANNOUNCEMENTS

At this time, the Chair stated:

"If you don't mind giving the Speaker a little leverage here, we're going to have a presentation to Representative Kawakami because he's leaving us. Representative Kawakami, will you please rise and maybe give a few remarks."

Representative Kawakami: "Thank you, Mr. Speaker. First and foremost, there are few thank yous that are in order. To all of the hard working staff, the offices, *mahalo nui loa* for your tireless work for the State of Hawaii. You guys are the very thread that holds this quilt together, and on behalf of myself, the 14th District, the Island of Kauai, and all of us here, we'd like to say thank you for all that you do.

"To my staff who is my family, all of them that have been here from the very beginning, Merissa, Tammy, Lahela, Rise, Matthew, Marissa, Kristi, Polly, Ben, Jason, and of course, Aunty Gini who's been like a second mother to me, thank you for your tireless work, patience, support, patience, love, and patience that you have given me and my family. Thank you, I love you, I'll always consider you folks as 'ohana.

"To the people of the beautiful 14th District, a big *mahalo nui loa* for allowing me to serve as your Representative for the last five years. I truly look forward to being at home with all of you. And to my family and friends, my wife Monica, my daughter Hailee, my son Christopher, my dad, my mother-in-law, my father-in-law, my family, thank you for all of your love and support. Thank you for believing in me and for standing by me at all times. I love you and I look forward to being at home with you as well, and I look forward to making up for some lost time.

"And to my colleagues here in the House, I've truly been blessed and I truly believe that I'm one of the luckiest guys in the world to have be able to have my path on this journey of life to have been able to have intersected with yours. And to the current and past House leadership, I am thankful for your guidance and for your courage to lead us through some of the roughest times that our state has been faced with in recent history. And I would have never imagined that in my short time I would have been able to serve under two Governors, two great Speakers of the House, two great Finance Chairs and three Majority Leaders, and I am fortunate and blessed to have had this experience.

"The ocean, the sea has been my sanctuary and my church at times, it's the place where I can feel my mom's presence, and it has taught me so many lessons. When you're in the ocean, you can't help but to be humble and to feel, well, small. And today for example, I paddled out, caught a few waves, and on the third or fourth wave I wiped out and pop, my contact lens popped out of my eye. And so I'm here and there's a south swell coming, Mr. Speaker, so I'm sure a few of my friends are excited about that. But here I am, out in the middle of the ocean, and my closest friends know how blind I am without my contacts or eye glasses. So I'm out there with one eye, and it's so challenging to be able to time the waves. And your perception of depth is totally lost and with one eye it became difficult, it became tiresome, and it became quite dangerous. And so I paddled in, got another contact lens in my eye and paddled back out and everything became so very clear.

"Oftentimes, I think we go through periods of life like that, with perhaps only one eye open. And at times, myself included, it causes us to have a distorted view on life. But then we experience what I would call, like today, an eye opening experience. In moments like this, things become very clear. There are many things that have happened to me over the course of the year that have made me open my eyes and to see things clearly, and one of those things is, as hard as it is for me, to come to the conclusion that my time here is coming to an end. And believe me, it's not easy, because I absolutely love this place. I absolutely love all of you. I love the people, and I am truly blessed and thankful to have each and every one of you in my life. Some of you drive me crazier than others, but I love you nonetheless, unconditionally.

"And I would pray that if you are like me and perhaps walking through this life, that you don't forget to actually live. Go get out into the ocean, go get into the mountains. Love your children. Children are funny. You cannot tell them you love them, you've got to show them you love them, and they can't be bought. So do what you've got to do. Call in sick, have a hooky day, but live life. And don't forget, as we're walking through this journey, to actually live it.

"Mr. Speaker, as some of you may have noticed, my invocations are usually sprinkled with some of my mom's wisdom. She was an ocean lover, she was a nature lover, and she passed down a ritual to me that I still do when I come out of the sea. She'd tell me, when you get out, you wash your eyes out with that salt water with the ocean. Clean your eyes, so that you only see the positive things in people. And wash your mouth out with the sea to clean your mouth out, so that you only say good things about people and places. And she said finally, to wash your ears out, so that you can actually listen and learn.

"I've learned so much from all of you, and I've only seen beautiful things from each and every one of your hearts. And I absolutely have only positive things to say about my colleagues and my family here in the House. So finally, to all of you, I am truly blessed, and I never meant to cause you any sorrow, I never meant to cause you any pain. Aloha aku, aloha mai. I give my love to you, aloha, God bless and mahalo."

Speaker Souki: "Thank you Representative, for the very, very emotional speech. Now we have some things to give you, can we have the lei given to you by Cindy and the gavel by Mizuno. We also have Representative Ichiyama with a certificate from your classmates, your legislative classmates, who's going to give you the presentation."

Representative Ichiyama: "Thank you very much, Mr. Speaker. I just wanted to share with Derek and all of our colleagues, this is a really big goodbye card from us who are your classmates from the class of 2010. Representative Dee Morikawa, Representative Jo Jordan, Representative Mark Hashem, Representative Johanson, Representative Cullen, and now Senator Riviere, because we're really going to miss you, Derek. And we know how eager you are to get home and be a loving father and caring husband that you are, and we just want to let you know how much we're really going to miss you."

Speaker Souki then gave his closing remarks as follows:

"Thank you very much. For the Speaker's remarks, I simply want to say thank you for being good Representatives, for writing good legislation. I'm very proud of you. I hope you have a good, long recess during the interim and we can see you back come fall. So again, thank you very much. Mr. Clerk, would you please have my speech be incorporated in the Journal, please. Thank you very much."

Speaker Souki submitted the following closing remarks:

"Fellow Representatives, in January I asked you to use the momentum created from our last session to keep us and Hawaii moving forward.

"During this session, you did just that with hard work and perseverance.

"You helped shape a budget that is fiscally prudent, forward looking, and addresses the state's priorities on:

- The homeless and affordable housing,
- · Our classrooms and education,
- · Our public hospitals and healthcare,
- · Our prisons and public safety, and
- Hawaiian home lands and our host culture.

"You provided assistance for the homeless that will allow the city, the State, and the many private agencies to continue their coordinated approach to helping these individuals.

"At the same time, you provided for more affordable homes and rentals that will help us short circuit homelessness in the future—providing \$36.6 million for the Rental Housing Revolving Fund and \$25 million for the Dwelling Unit Revolving Fund.

"You also put us on a path toward building affordable Housing units on state-owned parcels along our future rail system. This effort offers great potential for not just home building but community building.

"An essential part of community building is to make that community sustainable for the long term. That's why it was important for us to protect prime agriculture land between Wahiawa and Waialua and invest \$31.5 million to purchase those lands from Dole Food Co.

"As we look to open state-regulated dispensaries, you helped fine-tune the ground rules to ensure we provide safe and reliable access to medical marijuana for those who require it for health reasons.

"You took action that will allow us to complete the groundbreaking private-public partnership with Maui's hospitals, which could provide a formula for other facilities in our statewide public hospital system. And you listened to the health concerns of the people of Central Oahu and provided \$2.5 million to assist Wahiawa general hospital. You also provided \$160.5 million to help rebuild the Hawaii State Hospital for the mentally ill.

"Because of your actions this session, the DOE has \$100 million to aggressively move on heat abatement for our classrooms, making it easier for teachers to teach and students to learn. You also made it easier for teachers and others to accompany students on field trips that enrich their educational experience.

"You helped our *kūpuna* by passing a measure that ensures their health and safety in care facilities throughout the State, and you passed a bill that will help family members care for their seniors after they come home from the hospital. More importantly, it will provide the kind of medical training for caregivers that is so essential to keep our *kūpuna* healthy.

"In addition, you provided help for Maui workers and their families affected by the closure of Hawaiian Commercial & Sugar Company.

"On another Valley Isle matter, you helped sort out a fair way of dealing with the highly emotional issue of water rights among competing interests on Maui.

"It is never an easy task to deal with competing interests and priorities. Each priority seems so obvious in isolation. But the devil is never in a single priority, but always in the prioritization process itself. It's easy enough to throw your hands up and call them no-win situations. But our job is to provide leadership and make the difficult decisions.

"In doing so, you may not win any popularity contest. But you will have earned the respect and appreciation from those who see the big picture, and understand your position and your responsibility to all the people of Hawaii.

"And for that reason, let me add my own personal thanks to each of you for doing your job in workmanlike fashion—every day of this 2016 session. Well done!

"Thank you and aloha."

Representative Saiki gave his closing remarks on behalf of the Majority as follows:

"Thank you, Mr. Speaker. I just wanted to make four acknowledgements today. So first of all, thank you to all of the residents of our communities who have given us the opportunity to represent them in the Legislature.

"Second, thank you to the staff who have worked really hard this past session to bring us to this point. Specifically, thank you to the Legislative Reference Bureau, Sergeant-at-Arms, the Printshop, the Chief Clerk's Office, our research offices, and also our individual staff members. I'd like to request that their names be incorporated into the Journal.

"Third, thank you to our colleagues across the aisle who have worked, I know, worked very hard and diligently with us and who have been, I

believe, very responsive to the public interest, and who have been very constructive throughout this entire, not just this past session, but also last session as well. So, thank you very much to our Republican Caucus.

"And finally, Mr. Speaker, thank you to the members of your Majority Caucus. It was a privilege to work with each and every one of them. I will say that the members did exactly what we said we would do at the start of this session, and that was to address infrastructure issues. And that is what happened, when you look at the legislation that was approved this year. Whether it was in a form of classrooms, or state hospital, fresh water, affordable housing, that's exactly what happened. And all of this was done within the context of a state budget that addressed long-term investments, particularly with respect to our rainy day fund and our OPEB benefits, our employee benefits. And it was also done within the context of a budget that is balanced and that secures a positive balance in the future years ahead of us.

"So once again, I like to just thank you, Mr. Speaker, and all of the members for a very productive year. I know that the accomplishments of this legislature will benefit all of the residents of our state. Thank you very much."

Representative Fukumoto Chang gave her closing remarks on behalf of the Minority as follows:

"Thank you, Mr. Speaker. I hope you'll indulge me, my remarks are slightly longer, but I think this is only the second speech I've made all session. First of all, I wanted to start by acknowledging the staff of the House Minority Caucus. Thank you for all your hard work and tireless dedication to our members. The work we accomplished this session could not have happened without you. And thank you to all House staff, whose work makes everything that takes place in this building possible.

"To all of my colleagues, congratulations on your work this session. Our job is more than just speeches that the public sees on this floor, and it's more than what gets covered in the media. The real work takes place in the countless hours we spend in communities, in committees, and at our desks. Our job is to find practical and actionable solutions to our state's problems. Thank you all for doing that hard work.

"To the members who gave me the opportunity to be their minority leader, thank you for always valuing our diversity, thank you for respecting each other despite our many differences, and thank you for giving me the freedom to aggressively redefine what it means to be a minority member in this body. Every criticism we received was outweighed by encouragement from Hawaii voters who are tired of partisan politics, who don't want to hear token opposition, and who want their leaders to be constructive, not destructive.

"And to the majority leadership team, thank you for giving us a seat at the table. Thank you for utilizing our solutions, for passing our bills, and providing for our schools. A minority cannot be productive participants unless it's accompanied by a majority that's willing to ignore labels and listen. This majority was. And together, we've done what Washington can't.

"Finally, Mr. Speaker, I want to end by thanking the people of Hawaii for giving each of us the opportunity to play a small role in this sometimes messy, 200 year experiment called democracy."

Representative Say: "Mr. Speaker, I just wanted to ask the members of this body that if I may incorporate the words from the Representative from Waimanalo, Keolu Hills, in regards to thanking all of the legislative agencies. And secondly, may I be permitted to submit written comments in the ending of this great session? So, Speaker Souki and the House majority leadership, minority leadership, congratulations on a great session. And Speaker Souki, congratulations. *Aloha*."

Representative Say submitted the following:

"Mr. Speaker, I would like to share with the Members of the House the story of James Funaki, an individual who has dedicated his life to the State House of Representatives for more than half a century.

"Mr. Funaki was born on the Olaa Sugar Camp on Hawaii Island on May 20, 1930, and graduated from Hilo High School. He went to law school on the mainland, passed the Hawaii State Bar, and began his career in the State House of Representatives as a session counsel under the administration of Speaker Elmer Carvalho. He worked for eight Speakers of the House of Representatives: Speakers Cravalho, Tadao Beppu, James Wakatsuki, Henry Peters, Richard Kawakami, Daniel Kihano, Joseph Souki and Calvin Say.

"Understanding and comprehending the legal aspects of legislation with Mr. Funaki's expertise, and with all of the State programs and projects past and present in Hawaii, it would be fair to say that Mr. Funaki made a lasting mark on the laws of our state. Drafting, reviewing and vetting the issues with his legal background and understanding of constitutional law, Mr. Funaki had a big part in facilitating the passage of many bills by the Legislature.

"He was actively involved in the Constitutional Convention of 1978, also referred to as ConCon. He was a chief counsel to the leadership team in developing the State Constitution into what it is today.

"When I worked with Mr. Funaki, I found him to be quiet, focused, a realist and a great listener. He has a commonsense approach to understanding problems and discussing the solutions within the legislative framework of our branch of government. I am proud to say that he is one person who always protected our backs and was not afraid of tackling difficult societal issues.

"On behalf of the past and present legislators, chief clerks and assistant clerks, the sergeant-at-arms and their staff, the directors and deputy directors of the House Majority Staff Office, and all past and present employees of the House, we offer a big *mahalo*, *xie xie*, *arigato* and thank you for your contributions to the people of the state of Hawaii.

"The State House of Representatives anoint you solicitor, lawyer and justice of your courtroom, "The House Chamber."

Representative Ward: "Mr. Speaker, I would be remiss if we didn't, on behalf of those who didn't speak on the Kauai Representative's behalf. Be remiss if we didn't say, back at you, we love you, we wish you the best. Thank you, Derek, for being a part of this body. We're going to miss you. *Aloha.*"

Representative Tokioka: "Mr. Speaker, I was going to make the same request as Speaker Emeritus, because I didn't know if we could insert comments into the Journal during announcements, but I would like to do that. I did bring Kleenex just in case I was going to talk, but I know the Representative from North Kauai knows how much I appreciated him and love him, and we're going to miss him. Thank you."

Representative Tokioka submitted the following:

"Mr. Speaker, today is a sad day. Mr. Speaker, for the last five and one-half years I got to work side-by-side with a friend, a colleague, a great committee chair, but most importantly a great husband and a great dad. The only reason I say it's sad is because it's obvious how much he will be missed in the State House of Representatives but I know his decision to be back on Kauai is the best decision for he and his family. We've had a lot of great times during his tenure in the State House. This body and the State will lose one of the greatest advocates for the business community and individuals with disabilities, a leader who could work with both sides of the aisle, our Senate colleagues and the administration to get things done for the betterment of the people of the state of Hawaii.

"Mr. Speaker the State House of Representatives may be losing a great Representative, but in his next journey in public service I'm confident that he will be able to bring the same style of leadership to the Kauai County Council, and as the people of Kauai know, his collaborative style of leadership is definitely needed on the Kauai County Council. So we say

aloha and mahalo for now, but I'm sure, Mr. Speaker, we have not seen the last from the Representative of District 14."

Representative Fukumoto Chang: "Thank you, Mr. Speaker. I forgot that I was going to do this. I was speaking the other day with our minority whip who complained that her birthday is in August, so we never get to wish her happy birthday. So, if we could wish her a happy birthday for her birthday in August, that would be wonderful."
