"According to the hearing, at least on the House side for the House bill, there's no scientific evidence that says there is a lack of supplies of these particular fish. There's no need for the moratorium, even though in the House it said a moratorium, of which the chair, fortunately, pulled out of it.

"This one is worse than a moratorium, it's a ban. If you don't have a license now, you're never going to get one. So, Mr. Speaker, this is not good policy and it's against our fishermen who, for some of them, do it for their sustenance, their livelihood and their subsistence. Thank you, Mr. Speaker."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."
