

THIRTY-EIGHTH DAY

Tuesday, March 28, 2017

The House of Representatives of the Twenty-Ninth Legislature of the State of Hawaii, Regular Session of 2017, convened at 12:05 o'clock p.m., with Speaker Souki presiding.

The invocation was delivered by Mr. Aukai Walk of the Office of Representative Sean Quinlan, after which the Roll was called showing all Members present with the exception of Representatives Aquino, McDermott and McKelvey, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Seventh Day was deferred.
