The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:10 o'clock p.m., with Speaker Saiki presiding.

The invocation was delivered by former Governor Neil Abercrombie, after which the Roll was called showing all members present with the exception of Representative DeCoite, who was excused.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition with a very, very brief comment. This needs more study before we actuate it. I request further comments in the Journal, please. Thank you."

Representative Ward's written remarks are as follows:

"Mr. Speaker, I stand in opposition to this bill because I believe that it's essential to preserve the traditional and historic custom of walk-in voting on Election Day. Many people across this state take pride in the fact that they go to their local school or city hall, on Election Day, to make their voice heard. Although supporters of vote-by-mail emphasize its apparent convenience for voters, there have been concerns raised about relying on the U.S. Postal Service. Here in Hawaii, we already provide various methods of voting, and it's imperative that we always give people the choice, to vote how they would like to vote. *Mahalo*."

Representative Lee rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Lee's written remarks are as follows:

"Empowering members of the public to vote has long been a democratic virtue. This measure begins with extending the time of polling places from 6:00 p.m. to 7:00 p.m. to offer more flexibility and accessibility to voters. It then establishes a vote-by-mail system in Hawaii; these two changes would go a long way toward accomplishing our goal of empowering voters and encouraging voter engagement. By providing eligible members of the public the option to vote from the comfort and privacy of their own home, those who would otherwise not have an opportunity to physically visit a polling place due to schedule, accessibility, or otherwise are still afforded a way to make their voice heard. Voting at home puts voters' needs and convenience first by letting voters decide when, how, and where they vote.

"States have seen significant increases in voter turnout after implementing election-by-mail. For example, in 2016, 21 of 29 counties in Utah conducted the general election by mail. A study on turnout statistics using vote propensity scores to control for voters' pre-existing differences showed that voter turnout in vote-by-mail counties increased by five to seven percentage points. A 2013 study in Washington State also showed an increase in voter participation by two to four percentage points. In addition, states that have adopted a vote-by-mail system experience higher voter turnout specifically amongst younger, older, poorer, and minority voters. A vote-by-mail system in Hawaii would be a crucial step toward increasing voter turnout and empowering voters."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, opposition. I stood here on Opening Day and I said, if the minimum wage is reasonable, I will vote for it. This one goes above and beyond what's reasonable. And I know we have another bill that's going to talk about the actual amount. This one goes outside the purview of being a State of Hawaii. It's kind of a balkanization bill, if you remember how Yugoslavia broke into pieces because everybody said, me first, me too, we're subsidizing you, Slovenia, or Slovenia is subsidizing Croatia and Macedonia and all the other parts of the country. So, they broke up.

"Having a minimum wage compete county to county I think is a bit of foolishness. We pride ourselves on being the first centralized DOE, everybody is equal and everybody gets treated equal. To give the different counties this minimum wage differential, do you want them to compete? And I know we have a TAT that's going to do that same balkanization.

"So, Mr. Speaker, I don't see the logic, so much as maybe trying to get a little bit of a competitive edge, which from an entrepreneurial point of view may be good. But from the point of view of having an inconsistency, I think you should leave it to the private sector, not a public issue. If employers on the Big Island want to charge or pay more for their employees, or Kauai, let them do it. But to have this in statute I think is going above and beyond, of which I don't think any other state has done such a thing. For those reasons, Mr. Speaker, a no vote. Thank you."

Representative Johanson rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Just as a quick clarification, there are multiple states who have jurisdictions who all have different minimum wages. This is also a home rule issue and might permit our counties to be able to do what is in their best interest. So just as a point of clarification to the members, we would not be the first state that allowed counties to enact a higher minimum wage based on jurisdiction. Thank you."

Representative Todd rose to speak in support of the measure, stating:

"Just in strong support. I just wanted to briefly point out that the median home price in Honolulu is roughly three times East Hawaii. So, this sort of discretion may be appropriate."

"Mr. Speaker, in opposition, please. Thank you, Mr. Speaker. In fact, commenting on being ahead, we have 220 bills, which generally we do at crossover, it's a bit of a quick study, if you will, on an agenda of some 40 pages, which we usually do on an all-day on Monday caucus.

"Being that is the case, on 990, we have basically state employees paying a percentage for 0.01 of their gross salary to do training. Mr. Speaker, I know there are some progressives in this body who would say we should get free tuition at the university, and to say now we should be paying, our public employees should be paying to get training, just doesn't make any sense. So, if this is a revenue enhancement issue, I think it's barking up the wrong tree. Thank you."

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 991) recommending that H.B. No. 867, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 867, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 992) recommending that H.B. No. 901, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 901, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GOVERNMENT PUBLICATIONS," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 993) recommending that H.B. No. 978, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 978, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND DEFINITIONS," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 994) recommending that H.B. No. 979, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 979, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND COMPLIANCE WITH FEDERAL AND STATE LAWS," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 995) recommending that H.B. No. 981, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 981, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 996) recommending that H.B. No. 1008, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1008, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE OFFICE OF COLLECTIVE BARGAINING AND MANAGED COMPETITION," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 997) recommending that H.B. No. 1191, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1191, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kong rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations and a brief comment, please. Mr. Speaker, this minimum wage bill may affect those that I actually try to help the most, or I used to try to help the most. As a small businessman, at \$15 an hour I really try to help the students of my community. At \$15 an hour, they may no longer be able to have the experience of getting a job and being hired because, as you know, I used to own a florist and I would bring them in and be trained to get that job experience. As you may well know that people actually used to pay me to learn how to do *ikebana* arrangements. But now the tables will be turned where I would actually have to pay them at \$15 an hour, and I would get second thoughts in doing so.

"So, that would actually make it much more difficult for them to be employed. And that's just one career field, so that would be giving, I'm not sure how many other career fields would be affected for our students.

"But I don't want to digress too much on that subject, but the reason why I'm going with reservations is it's not necessarily the minimum wage that I'm standing up against, it's the fact that we need to increase the living wage in the state and not necessarily the minimum wage. So, how do we go addressing the living wage? And it's not by mandating the minimum wage. We need to send a message to the businesses of this community and help them understand that we understand business. By increasing the minimum wage, we have to let businesses know that we understand them, that on the back end, if we increase minimum wage, that ties into the workman's comp, TDI, and that on the back end of business, that will increase the insurance.

"So, by getting this message out to businesses that we understand how they do business, that's going to let them understand that they can actually look at their bottom line to look at how they can help their employees by increasing their living wage. We have to send a message that people like our chair in IAC is looking at reducing fees in construction, realty, cable, and that this is a message this legislative body needs to send to the business community. That we're looking to cut costs to businesses. This is how we as a body look to help businesses grow the economy.

"We're last in doing business in the nation. We need to send a message to businesses that we can number one in doing business in this nation. This is how we help the economy, we help businesses grow, so instead of mandating things like minimum wage we can help businesses grow and this is a place to do business instead. So, if we can get this message out, we can actually help our communities, our businesses, our employees actually gain the right wages that they need to have. Thank you, Mr. Speaker."

Representative Matsumoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"Mr. Speaker, I rise with strong reservations.

"As a member of the House Committee on Labor & Public Employment, I had the opportunity to hear arguments in support and in opposition of this measure. Increasing the minimum wage is a topic that generates robust and passionate discussion. In balancing the potential positive and negative effects of this bill, Mr. Speaker, I am still not convinced that increasing the minimum wage is the solution to combating cost of living.

"Mr. Speaker, have we explored every option?

"While I sympathize with the plight of minimum wage earners, I have been working on ways to reduce our cost of living. For example, I introduced House Bill 1592 to eliminate the general excise tax from food, medical services, and feminine hygiene products. Nonprofits who serve our vulnerable community members emphasize that feminine hygiene products are among the items 32 states plus the District of Columbia exempt groceries from their sales taxes. Forty-one states generally exclude medical services from their sales taxes. It's been time for Hawaii to join this majority. This is one step we can take as a state to mitigate the cost of living. The people of Hawaii should not be taxed for a basic necessity.

"In thinking of ways we can be more effective as a government, I introduced House Bill 1593 in order for us to have a better understanding of how taxpayers' monies are being spent. We can use the data to tighten up where we need to as opposed to spending our way out of a problem. I also introduced House Bill 1591 to reduce our income tax burden.

"In making decisions as a body, we need to think of creating a sustainable future for our *keiki* as well as our *kūpuna* and neighbors who are on a fixed income. Unintended consequences of raising the minimum wage include the increase in the price of goods and services. How will our *kūpuna* afford another expense?

"For many businesses, a mandated increase in wages will mean a decrease in the money that employers are able to spend on health benefits, sick leave, vacation time, and other benefits to the employee. Due to the high tax rates, increasing the minimum wage will certainly increase costs to the employer, but employees will only see a marginal increase in their pay.

"Due to the unreasonably high costs of housing, transportation, food, and medical services in our state, increasing the minimum wage is not an effective way to offset the financial burden for our state. Raising the minimum wage is a bandage type of fix for a much bigger systemic issue of a lack of resources and an increasing demand. Simply increasing wages may actually cause the cost of living to increase even more, as more funds will be needed to offset the new burden on the employers. This issue becomes cyclical and the people most hurt will be the middle class workers in the minimum wage jobs.

"Mr. Speaker, for these reasons, I have strong reservations on this measure. Thank you, Mr. Speaker."

Representative Cabanilla Arakawa rose to disclose a potential conflict of interest, stating:

"Ruling on a potential conflict. I am an employer."

The Chair addressed Representative Cabanilla Arakawa, stating:

"There's no conflict. It will remain in effect through *sine die*."

Representative Cabanilla Arakawa continued to speak in opposition to the measure, stating:

"Thank you. In opposition, Mr. Speaker. I understand that we want to take care of our people. We want to raise the minimum wage, we want to raise the living wage. However, there is a portion of this bill that it does not address.

"As an employer and owner of medical facilities, I have to deal with sequestration from the Federal Government, meaning they keep lowering the fees and adding additional taxes to it, but they call it sequestration. And insurance companies there's something called capitation, where you cannot bill anybody any higher than that, and other sorts of fee limitation with Quest insurances. So, I'm in opposition of this because we're just looking at the workers, how about the employers that has to deal with those fees and being caught in between? So, those are my reasons, Mr. Speaker."

Representative Perruso rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker, I stand in strong support. According to a 2016 report from DBEDT, a single adult in Hawaii required an income of \$32,950 to achieve self-sufficiency, while a single parent with only one child required \$56,157. Yet at our current statewide minimum wage rate at \$10.10 an hour, the full-time employee earns only \$21,000 annually. According to census bureau data, the number of people living below the poverty level in my district is 25% higher than the state average. For their sake and for the well-being of all working families in our state, I strongly support this measure's effort to provide economic justice to those who need it most."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. On Opening Day, Mr. Speaker, I stood here and said, if there is a reasonable increase, I will definitely support it. I have

six reasons why this is not reasonable, Mr. Speaker. May I proceed? Number one, it's a job killer. Employers know that they can cut back employees or they can cut back hours. I mean, that happens all the time, so this is just an invitation to do that.

"The second reason is that it's going to increase the cost of living because, as you know, employers pass on expenses to the customers. Therefore, the price of goods go up, the cost of living goes up, and, as you know Mr. Speaker, we have the highest cost of living next to New York or San Francisco in the nation.

"So, a job killer, a cost of living increaser, and thirdly, an AI incentivizer. AI, artificial intelligence, you know and I know that mechanization, computers are taking over where we humans are no longer going to be necessary. Some restaurants have totally, like McDonalds in Arizona, have totally become a mechanized phenomenon. If we push employers out, and I think the unions are aware of this, if we keep pushing for the wages that squeeze employers from the human side to the mechanical and the metal and computer side, we will in the end lose.

"Fourthly, market forces are already actively doing that. There's a lot of places that are fast foods paying \$12, \$13, \$14 an hour just to compete or pinch employees from other companies. So, letting the market do this is actually doing a good job already and doing that now.

"Fifthly, and this is according to some of the restaurateurs who told me that, if you guys push it too far, we're going to increase the already underground, under the table payments. Hey, you work for me for ten bucks an hour, I won't take any taxes out, you don't have to report anything, and we get a black market underground economy. That, Mr. Speaker, is not wise.

"And sixthly and lastly and probably more statistically accurate, over the past 10 years there has been in the State of Hawaii an average 29 cents per year increase in the minimum wage. Over the last 20 years in the State of Hawaii, it's been about 25 cents increase. From the national point of view, it's been 0 and 11 cents in the last 20 years, so we're way, way ahead of the federal. But the point is, if we go from 29 cents a year over the last 10 years to now \$1 a year, we're pumping it up four times the average over the last 20 years.

"Is that reasonable, Mr. Speaker? What happened? What has magnified four times in the last 10 years that we should increase it so fast? So unreasonable. Again, I repeat, it was 29 cents a year for the last 10 years, 25 cents a year for the past 20 years. This is exceeding and going well beyond that.

"The bottom line is, Mr. Speaker, in the short run there may be a gain but in the long run I think we're really hurting the employees of this state, and as our good colleague has said, we need to help the small businesses and their employees. Thank you, Mr. Speaker."

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I would like entered into the record the words of my esteemed colleague from Wahiawa as my own and I would like to speak out as a small employer who already pays a \$15 minimum wage that we need a minimum wage bill and I strongly support this bill. Thank you," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1191, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MINIMUM WAGE," passed Third Reading by a vote of 46 ayes to 4 noes, with Representatives Kong, Matsumoto and Tokioka voting aye with reservations, with Representatives Har, Okimoto, Quinlan and Ward voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 998) recommending that H.B. No. 1275, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1275, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Okimoto's written remarks are as follows:

"Thank you, Mr. Speaker. In support with reservations for House Bill 1275, HD1. The subject of teacher salaries merited a hearing before the Committee on Lower & Higher Education. While I am in strong support of providing teachers livable wages, I believe subjects concerning the number of incremental and longevity steps should be negotiated through the collective bargaining process."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1275, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EDUCATION," passed Third Reading by a vote of 50 ayes, with Representative Okimoto voting aye with reservations, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 999) recommending that H.B. No. 1343, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1343, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FAMILY LEAVE," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1000) recommending that H.B. No. 1537, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1537, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Perruso rose to speak in support of the measure with reservations, stating:

"I have strong reservations, given the audit reports over the past decade related to the management of Mauna Kea and the fact that the FTE positions included in this legislation, the number is unspecified. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1537, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE OFFICE OF MAUNA KEA MANAGEMENT," passed Third Reading by a vote of 47 ayes to 3 noes, with Representative Perruso voting aye with reservations, with Representatives Har, Say and Tokioka voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1001) recommending that H.B. No. 1582, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1582, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CONCESSIONS ON PUBLIC PROPERTY," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1002) recommending that H.B. No. 631, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 631, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition and a brief comment of this is the same balkanization of the counties for competing that hotels may be on one island may be a higher taxation to our visitors and lesser on another one. And it goes contrary to want to spread the wealth around between getting visitors on the neighbor islands, whose economies may not be as strong as Oahu. So, this gives a chance for again, competitively, entrepreneurly, but in terms of actual consistency of taxation, not probably a very good policy. May I have additional comments inserted into the Journal, please? Thank you."

Representative Ward's written remarks are as follows:

"Mr. Speaker, I stand in opposition to this bill, because I don't want to see a taxation domino effect fall upon our already unaffordable living situation here in Hawaii. This body, two years ago allowed a 1% surcharge on the TAT tax to go to the rail, and now we are going to open the possibilities to more surcharge taxes? Enough with the taxes! There will always be a need, departments and counties will always need more money, but that doesn't mean we go out and tax the public to fill the void, how about we start being good stewards of what we already collect?"

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 631, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Third Reading by a vote of 48 ayes to 2 noes, with Representative Okimoto voting aye with reservations, with Representatives McDermott and Ward voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1003) recommending that H.B. No. 467, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 467, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE KUPUNA CAREGIVERS PROGRAM," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. "Mr. Speaker, this is a bill that we've had before. I'm still against it, so I rise in opposition with a request for comments in the Journal. And for the sake of, again, I point out there is big differential of about 30% between the Majority Research Office and the Minority Research Office, and this is going to hide it and make parity a much more difficult proposition. Thank you, Mr. Speaker."

Representative Ward's written remarks are as follows:

"Mr. Speaker, we need to understand that we work for the people of this state; we serve at their pleasure. Any time taxpayer money is being used, they have a direct right to see where their money is going and how much is being spent. We should be passing laws that make government more transparent, not less. Let me also mention the fact that the research staff on the majority side receive 30% more in salary than the research staff on the minority side. This bill will cloud the disparity between majority and minority staff even further. For these reasons, Mr. Speaker, I oppose this bill. *Mahalo.*"

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 362, HD 1, entitled: "A BILL FOR AN ACT RELATING TO INFORMATION PRACTICES," passed Third Reading by a vote of 45 ayes to 5 noes, with Representatives Matsumoto, McDermott, Okimoto, Thielen and Ward voting no, and with Representative DeCoite being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1014) recommending that H.B. No. 950, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. "Mr. Speaker, once more if it's possible just to go with reservations and to maybe someday ask the chair of LMG to give us a break down of what the A funds are for TAX105 and TAX107. And the only reason why is the process of how we are developing this budget. That's all. Because right now it's blank. Do we have any appropriations for these particular positions that are presently filled and their operating budget as far as overall? So, just for Stand. Com. Report 1015 and 1016, because it's just A funds and B funds, and there's no number attached to it. Thank you."

"Thank you, Mr. Speaker. I would like to speak with reservations, please. Mr. Speaker, this is relating to the Department of Agriculture's operating budget. And while hemp may not be specifically within that budget, the department itself has the overall responsibility for it, and they are doing a very, very poor job. I find it hard to vote in favor of a budget for an ineffective department.

"Under their mismanagement of the hemp program, there are only 10 approved licensees, and they will not consider any new applications for the following quarter. Unfortunately, a farmer from the Big Island named Mr. Wirick, who is part of a group called Hawaii Island Hemp Collective, was told by the program manager, Shelley Choy, that, don't bother going ahead because she has too many applications and will not be taking any more. She also tells him that most likely their inspectors will be too busy after the harvest of the upcoming quarter and there is little chance that she'll be taking applications even in June.

"So, when the Department of Agriculture comes before us asking for their budget to be approved, I just find it hard to say, sure, because I think they are doing a very ineffective job. We all know that we're trying to become at least somewhat food self-sufficient in our islands. We're not getting that direction from the top floor, we're not getting it from the Department of Agriculture. And I don't think we have many months and years ahead of us to turn that balance to where when we have a disaster, and California has a disaster, and we're looked at like you're not going to get the ships coming over to you. What's going to stock the produce sections in our markets? What's going to happen?

"You know, I'm probably one of the only members in the whole body that had a victory garden during World War II, and we took that seriously. I was quite young, but I was alive then, and we had victory gardens.

"We're almost at a point where our Department of Agriculture is so ineffective and so obstructionist that we may need to go out to our constituents and to ourselves and say it's time to start planting a preservation garden to be able to feed ourselves, our neighbors, and be able to be somewhat self-sufficient. Because we sure aren't getting the leadership from up there.

"And I think, Mr. Speaker, we ought to think very seriously. I know I give the Finance Chair a lot of credit because she's calling these departments to task to say, prove what you're doing. Well, agriculture and food self-sufficiency is life and death for us. It really is. And they're not doing their job. We need to do our job. Thank you."

When the decision was made by the Chair of Finance to try a different method known as a zero-based budgeting, it doesn't seem to me that the Chair took the time to check with the administrators of the budget at B&F to truly understand what the consequences of her decision would be and how it would impact the budget for the entire state. That would, in my opinion be the first mistake.

"The second mistake would be sending the budget to the Senate less than 3 weeks into session without inserting the program IDs that the committee chairs took out of HD 2 and worked with their respective departments to give input from many of the chairs that worked with division heads. I do think most chairs worked hard to do what they felt was best for the departments that they oversaw but, again, the Chair of Finance sent the budget over to the Senate early and did not understand how her decision would impact the state budget. As it is right now, 33,000 positions from the state budget are not included in HD 2, 33,000 positions!! I would compare this to an incredibly difficult puzzle, taking it apart, removing pieces, cutting some of them in half, then asking B&F to put them back together. This is why I have strong reservations on this bill."

"During that time, the foreclosure process was extended because of the FEMA hold on such foreclosure process. There were FEMA monies available, but for some reason despite incentives, the foreclosing owners refused to rent when there were so many people in need. And that's the reason why this bill was constructed, solely for the limited period during the foreclosure process. Again, it incentivizes foreclosing owners, foreclosing people, from preventing or forcing out homeowners as well as incentivizing affordable housing. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

"Thank you, Mr. Speaker. I stand in opposition to this measure. To begin with, the Board of Education already has a policy in place, 301.8, that allows for this to happen, for people to work with schools and the board to name facilities after benefactors. Even with this policy in place, there has not been an outpouring of donations from the wealthy benefactors seeking to provide financial assistance to schools in exchange for naming rights. Even if there was, would we be content to see companies like Coca-Cola and McDonalds use our local schools as an opportunity to brand their products to the young? How would we feel to drive by the golden arches of education?

"This measure is not a solution to the chronic underfunding of public education in our state school system. The Department of Education school facilities are over six years old on average. Each classroom in every building should be staffed by a qualified teacher, and yet today our school system is struggling to fill over 1,000 vacancies today. We are facing an education emergency. Rather than allowing corporations to use school campuses for branding campaigns, we must support comprehensive solutions to increasing public school funding. Like raising the general excise tax or higher earner income taxes, which would generate hundreds of millions of dollars to serve the schools our *keiki* deserve. Thank you."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Woodson rose to speak in support of the measure, stating:

"In support. Thank you, Mr. Speaker. This bill is not meant to address all the issues that we have within the Department of Education as relates to funding. This proposal is simply meant to allow for private sector individuals to participate in the process by allowing for naming rights for particular buildings, so that we can bring in more income to the Department of Education. Furthermore, the board policy that was referenced, that is only specific to certain circumstances, so as this proposal is drafted it would allow for the naming rights for buildings of all sorts and entities. Thank you."

Representative Hashem rose to speak in support of the measure, stating:

"Mr. Speaker, I stand in support. First of all, I want to thank my colleagues for funding one of the new locker rooms that we have at Kalani High School. It's a brand new girl's locker room, and unfortunately, they're not going to name it after me, they're going to name it after one of the former Kalani graduates, and that person went on to become very wealthy. Him and his wife went to Kalani. His wife recently passed away. He is offering Kalani \$100,000 a year in perpetuity for scholarships for Kalani school graduates, and in exchange, he wishes to put his wife's name on the building. So, with that, Mr. Speaker, I am in full support of this bill. Thank you."

Representative Cabanilla Arakawa rose to speak in support of the measure, stating:

"In full support, Mr. Speaker, and I would like to credit the vice principal of Campbell High School for giving me the idea of this measure, because they are in partnership with other high schools on the mainland, and that's what they do. And I think this is a wonderful idea. Yes, there is a board policy. It's a policy, Mr. Speaker, and I would like it to be codified into law. Because that would intensify the appeal of such measure. Into law as opposed to just a board policy that can be changed at any time.

"Furthermore, with the participation of big companies, like there's a lot of rich people in the state, Oracle, Bruno Mars, that can come and help us out. It's very clear, Mr. Speaker, that our state cannot provide for the infrastructure of our schools. It can never do. So this means we can now recruit those people who have gotten far beyond, that they can come and the thing that we can offer is for them to see their names in our schools. I'm not talking about small donors, Mr. Speaker, although they can donate as well.

"And furthermore, this bill would allow for a sub account for the high schools in their name, so they can work harder to get donations. And furthermore, if you take out the big-ticket items from the DOE budget, that would leave more money for school teachers' raises and supplies and other things that the DOE can use the money for. So, again, if you take out big items, more money in the pot. Thank you, Mr. Speaker."

Representative Quinlan rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. I'm very blessed to represent the representative district that has more NFL players than probably any state representative district in the entire nation. These guys have made a lot of money in their careers and they want to help out, and I think this is a great way to allow them to do so. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, in support. Mr. Speaker, I sense that the future of government is public-private cost sharing, partnerships, or whatever you want to call it, because I don't think government has been able to do it on its own, particularly as the needs for so many issues. So everything that was said I think is very well taken, particularly the Kalani High School option. I mean, that's tremendous, that's really philanthropy. And for the DOE purpose. However, I would say for those who are for this bill, please consider naming rights for the new stadium, which would be worth millions of dollars and there are corporations all over the world that would be willing to do that if we, in this body, would open it up to naming rights. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 745, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SCHOOL SPONSORSHIP NAMING RIGHTS," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Okimoto voting aye with reservations, with Representative Perruso voting no, and with Representative DeCoite being excused.

It is unfair to put more strain and financial responsibility on all of our charter schools when the State Public Charter School Commission testified that it has a list of only four to five charter schools that need this oversight. The State Public Charter School Commission is appointed by the Board of Directors at the DOE and are put in place to maintain the rules and standards of education across all charter schools in the state. Because the State Public Charter School Commission already identified which charter schools need this additional oversight, burdening all charter schools is both unnecessary and harmful to students."

"Mr. Speaker, no vote and short comments. Mr. Speaker, I was dismayed that this bill that deals with agricultural land was not referred to the Agriculture Committee. And I believe this sets very bad precedence in regards to utilizing A class land for anything but strictly agriculture. Thank you."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, tepid support, brief, brief comment. Given what the gentleman from the Big Island said, I would say, if we would take out A lands, that is the best of the best, this bill probably would make sense, because we need energy, we need it to come free from the sky, but when you got your prime agricultural lands to make solar, that just doesn't make sense. And we're losing so much now, some of the best ag land was in Ewa Beach, and Ewa Beach is being basically housing, as many other places. So, I would hope that those who are on either the next committee or the conference committee just strike out those ag lands letter A. Thank you."

Representative B. Kobayashi rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. Let me note that the vote in Finance Committee was nine in favor, two with reservations, and six opposed. Had the two with reservations voted in opposition, the bill would not be here. Secondly, I would reiterate what was said earlier by the Representative from the Big Island, that this bill was not referred to the Agriculture Committee and it deals with class A agricultural lands. Lastly, I would note that there was a very, very unusual array of supporters and opponents of this bill. This was the first time in history that two of Hawaii's most well-known farmers, Richard Ha and Dean Okimoto, voted against the Hawaii Farm Bureau, the Department of Agriculture, the Hawaii Crop Improvement Association. That is an unusual alignment that we have never seen before, and it said something about the controversial nature of this bill.

"So, for those reasons and plus the fact that class A agricultural lands represent only 3% of all agricultural lands. If you look up the definition of class A agricultural lands, it is very specific, and those are the most potentially productive agricultural lands in the State of Hawaii. If we are serious about growing our own crops, then I think we should look seriously about not supporting this bill. Thank you."

Representative Okimoto rose in opposition to the measure and asked that the remarks of Representative Onishi be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Thielen rose in opposition to the measure and asked that the remarks of Representative B. Kobayashi be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative San Buenaventura rose to speak in support of the measure with reservations, stating:

"With reservations. I'd like to point out a couple of things. One, I understand fully the need for ag lands to be used for ag purposes, yet we also should be mindful that our farmers need to use whatever resources are available to them to be able to make money in this climate. And I noticed that one of the supporters is a Big Island nursery, Green Point Nursery, who provided us with all of our greenery on Opening Day, and they would like to be able to use this ability to harness the solar energies in order to be able to finally be able to make money when times are tough. And for those reasons, again, I fully understand the need for it. This doesn't require the use of ag lands for solar purposes, this just permits and allows them to be able to do that. And for those reasons, I stand in support but with reservations."

Representative Quinlan rose to speak in opposition to the measure, stating:

"In opposition, Mr. Speaker. In my community, we basically do two different things with ag land, we build gentleman's farms on them and we build windmills. We cannot continue to expand permitted uses on agriculture land, because we're never going to meet our agricultural goals if we continue to do so. Thank you."

Representative Holt rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Wildberger rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered." [Note: Representative McKelvey later changed his vote to a no vote.]

Representative Creagan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Hashimoto rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Hashimoto's written remarks are as follows:

"Mr. Speaker, I rise in opposition to HB 593, HD1.

"Land in this state is a scarce resource. This is especially true for our prime agricultural land, or A-rated land.

"In testimony to Finance, proponents of this bill said that they wanted to open this land to utility-scale solar energy generation because of its proximity to transmission lines and power stations. But that's infrastructure we can build. We currently cannot build more prime agricultural land.

"One of the state's other goals is to increase our agricultural output. The smartest way to pursue both is by using our best agricultural land for agriculture and using other land, land that isn't as good for growing food, for renewable energy. There's no reason to create a situation that puts them into conflict with each other.

"For these reasons, I'm voting against HB 593, HD1. Thank you, Mr. Speaker."

Representative Lowen rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support, although I understand the reservations people have, and I just wanted to correct something that was said. This doesn't permit projects on ag land, it makes it an allowable use that they would have to apply to the Land Use Commission for a special use permit that's not guaranteed to be approved, and they would have to show that they were providing a net benefit to the farmer on that land. And I think we should be preserving, especially class A ag lands for agriculture, and it is a slippery slope to continue to expand the allowable uses, but at the same time, a lot of this land is not in production. And the reason it's not in production is because it's hard to be a farmer today. And so, this was just having a conversation about if it was possible to find some mutual benefit here where these solar development projects could actually create an incentive for that land to be put into production and actually used for farming. Thanks."

Representative Onishi rose to respond, stating:

"Second time and still in opposition. This Legislature has seen fit in the past to allow for class C, D and E agricultural lands to be used for solar production for projects that would help us reach our goals of 100% renewable energy. If you look again at the list of testifiers, and to see that most of our Hawaii ag organizations are against this policy, granted, this is a policy, but it sets a very poor precedent for us to encourage agriculture use when we're willing to give up our best land for potential use that will only

benefit that particular farmer and their land. Some of this land is actually lease land, and therefore would also be open to potential solar project development. Again, if you look at the people who testified against this, who are against this bill, these are the major agricultural organizations in the State of Hawaii. Thank you, Mr. Speaker."

Representative Yamane rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I just would like to add to what the Chair of EEP mentioned, this is an allowable permitted use. Entities that would go through this would still be required to go, in the proposed language, to the Land Use Commission with anything from zero to whatever property size permitted within the conditions of the use. As well as, Mr. Speaker, the nexus of the idea was to give the opportunity, looking at future farming. And Mr. Speaker, part of future farming is the use of potential greenhouses. Meaning not only just solar panels on the ground, but solar panels on top of greenhouses, which not only produces potential energy within the growing environment within the greenhouse, but also give the opportunity for farmers to potentially sell the excess energy to the grid to help supplement the ability for them to grow.

"So, Mr. Speaker, in light of what we've been talking, A land use, Mr. Speaker, currently right now we can put wind mills on A lands. That's in law. Mr. Speaker, in the past we've actually put homes on A lands, right. So if we're talking about the issue of requiring that within this kind of measure that the farmer not only has electricity and water, but also we push the discussion forward about elevating our ability to be self-sustaining food by increasing power as well as water conditions so that our future farmers have the best technology available. We just wanted the discussion to have this continue. Thank you, Mr. Speaker."

Representative Eli rose in opposition to the measure and asked that the remarks of Representative Onishi be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Perruso rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I stand in opposition. So, as a representative of a district where we have 17,000 acres in state ag land, this kind of future farming is being proposed. And I do think that it is important to think about the use of technology and the ways in which we can marry our energy needs and our food sustainability needs and address both of them at the same time. But I do think that we do have to make sure that A lands are reserved for growing food. And so if we keep that as a fundamental baseline and then we can do additional work around that, but I do think that criteria, that fundamental baseline, is really important. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 593, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LAND USE," passed Third Reading by a vote of 37 ayes to 13 noes, with Representatives Creagan, Gates, Holt, Nakamura, San Buenaventura and Wildberger voting aye with reservations, with Representatives Eli, Hashimoto, Kitagawa, B. Kobayashi, Matayoshi, Matsumoto, McKelvey, Okimoto, Onishi, Perruso, Quinlan, Tarnas and Thielen voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1130) recommending that H.B. No. 630, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 630, HD 1, entitled: "A BILL FOR AN ACT RELATING TO GLASS CONTAINER RECOVERY," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1131) recommending that H.B. No. 765, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 765, HD 1, entitled: "A BILL FOR AN ACT RELATING TO

COASTAL PLANNING," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1132) recommending that H.B. No. 1028, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1028, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE ENDANGERED SPECIES TRUST FUND," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1133) recommending that H.B. No. 1584, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1584, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CARBON EMISSIONS," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Ward voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1134) recommending that H.B. No. 210, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 210, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, we're on 1134, Relating to Elections? The elections that for three reason I'm opposed to. Mr. Speaker, these are the elections called 'ranked choice voting.' A step backwards, sir, and I have three reasons why I'm against this bill. First of all, it's too confusing. I'm sure everybody's debated among themselves no it means this, no it means, no it's like the jungle primary, no it's not like the jungle primaries. So we said, okay, call the experts, call the Office of Elections. So we called them, and they were confused, Mr. Speaker. The ones who are going to implement it don't even know what it is. So, first point of this thing being what it is, is it's too confusing.

"Number two is, it's unnecessary. There's already a method for nonpartisan contests and runoffs, contested primaries, and all the other things. We're doing fine as we are. Thirdly, it's costly, \$580,000 for a multipage ballot. We already have a shortage of funds for that particular group.

"But, the worst, or Shakespeare said, the unkindest cut of all, Mr. Speaker, is under this system, there would be no Charles Djou, no Ed Case. There would, if we are in the Senate bill going to entertain the jungle primary, there would only be two of us on this side of the aisle, Mr. Speaker. Is the intent to, I mean we're only five out of 51. Do we want to get rid of the loyal opposition? I don't think so. You're smiling though, I'm giving you an idea. Mr. Speaker, this is something which is a problem which we don't have, but it's the solution in search of a problem, and just because some guys on the mainland are trying to do it and have done it, it doesn't mean that we should do it. This is a bad bill, Mr. Speaker. Please make sure it doesn't live. Thank you."

Representative B. Kobayashi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations. I would note that ranked choice voting may have a good place in certain kinds of elections, such as in special elections where we have a current winner-take-all system, but it would not work well in other situations, particularly, shall we say, in Kauai, where all

of the councilmembers are essentially in one district, and probably also with Office of Hawaiian Affairs. So, perhaps ranked choice voting might be applied more selectively, and then I think it might be a better idea. Thank you."

Representative Todd rose to speak in support of the measure with reservations, stating:

"Thank you. Just to echo the previous speaker, I actually support the concept, but I believe it should be applied only to specific election types, including general elections. I think the benefit of ranked choice voting is primarily to allow for votes for third parties or independents without feeling like you're sacrificing your vote towards a candidate who you may share a lot of values with, but I don't believe it has a role in the primary system that we currently have. Thank you. Reservations."

Representative Thielen rose to disclose a potential conflict of interest, stating:

"Thank you, Mr. Speaker. Ruling on a potential conflict. Mr. Speaker, had ranked voting been in place, I would not be here," and the Chair ruled, "no conflict."

Representative Thielen continued and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative McKelvey rose to speak in support of the measure, stating:

"In support, for the reasons cited by the previous speaker."

Representative Eli rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of the measure, stating:

"With strong support. I understand the need for certain elections like Kauai where basically it's one district and multiple people, and it may not be workable there. But I'd like to cite the lieutenant governor's race, for instance, where we had a number of very good candidates. And a number of us, although we shared values with one candidate, felt that we were throwing our vote away if we voted for that candidate. Ranked choice voting basically allows our ability to choose the candidate we identify with, but not have our vote thrown away. Because if our candidate loses, then our second choice comes into play and is counted towards the remaining candidates who get in. And by doing that, we basically allow for a popular vote, which is what it is meant to be. And we actually reduce the number of special elections and having to keep doing this over and over again.

"So for those reasons, it's about time we do this, and I believe it's just a matter of education to let people know how ranked choice voting works, and when they actually do, and the number of counties that actually have ranked choice voting, they love it, because they know that their choice counts. Thank you."

Representative Hashimoto rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Holt rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matayoshi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to respond, stating:

"Mr. Speaker, brief rebuttal, if I may, from the good lady from the Big Island. The notion that your vote doesn't count, Mr. Speaker, let's look at the numbers. What's the turn out? What's the voter registration? More than half the people don't even sign up and the other half don't even, after they sign up, vote. Thirty-eight percent is an embarrassment. The reason people don't show up is not because they don't have all their choices that win, it's because

they have a one-party state here. They want to do, not diminish the minorities, but to increase them. This is just going to be the opposite of that.

"So, Mr. Speaker, we need to get our voter registration and voter participation up, not to have more fancy, six pages, half a million dollar and other kinds of things, which by the way, the Senate's floating with this jungle primary. Which is really, it's more dangerous than this one, if we think we have a convoluted system. And also, if we're going to do it, we should at least get the Office of Elections up to speed to know what this thing is. It's very convoluted and it's very expensive. So, Mr. Speaker, we have a lot to do politically here, but this is not one of the solutions. Thank you."

Representative San Buenaventura rose to respond, stating:

"Again, in strong support. I'd like to point out, there's nothing in the bill that gets rid of the party system, so it's basically within the primary, and as such, we're going to still be able have a two-party system so long as a Republican shows up. Thank you."

Representative Luke rose to speak in support of the measure, stating:

"Thank you, in support. I think there's some confusion with this bill compared to the that one I introduced, which died in Judiciary. So that bill actually gets rid of all the party affiliation and then select the top two, kind of similar to the council races where the top two or top three or whatever the number is moves on to the general.

"In this situation, you keep the entire party structure, but within the party structure you can rank from the choices. Actually, you know, another good example is the CD race. CD1 race had a bunch of people, you know you could go either way on all of them or you could go no way on any of them, but you know you kind of had a choice. So, if you kind of had a choice of the top whatever, you know top six, then you could have ranked it as opposed winner take all.

"So clearly there is some confusion, and we talked about this in Finance, and even the Office of Elections officials said, no, it doesn't impact the current party structure where you have the Democrat moving on to the general, the Republican winner move on to the general, Libertarian, so forth. That doesn't change. But within the party structure itself, when you vote in the primary races and you can vote one through dumpty dum, because as you saw in the CD1 race, the person who won, won by 38%, as opposed to, what we should expect is, by a majority of votes. So clearly, there's some confusion. Thank you."

Representative Okimoto rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. I just wanted to point out that it seems like there is a lot of confusion, and to me it would be irresponsible as a legislature to pass a bill that we're not sure about. And I also want to note that I probably wouldn't be standing here if this system was in place, and that would be a travesty. Thank you."

Representative Perruso rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'm in strong support. So, as a civic educator, I wanted to say while there may be some confusion amongst adults, there may some confusion about ranked choice voting, I think it's very common in other countries. And my experience with young people is that they generally tend to favor this kind of voting. They feel more engaged, they feel like their voice is more thoroughly articulated. So, I think that this would be a great move and it does preserve the two-party system, so I think there's no need to be anxious about that."

Representative Lee rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support and I just I think add to some of the discussion by saying, I think our democracy here in this country is the oldest modern democracy on the planet and it is set up in a way that we vote in a first-past-the-post system, meaning you need 50% plus one, as we are all well aware. The problem with that, in situations where you have multiple candidates on the ballot, as I think some of our colleagues described, is that

you end up electing someone with a minority, sometimes even a fraction of the electorate. Which means that person does not have a mandate from the population, from the voting public, in order to take office and to govern.

"What this system does is sets up an opportunity for everyone to be able to vote on that final two candidates that are going to be governing them. And so it ensures that there is a mandate from the public and gives everyone a voice, rather than disenfranchising a great majority of voters in each election. It's something which other states, other countries, have certainly figured out, which is far more advanced and far more appreciated I think in many cases than the democracy we have here, which is reflected in their voter turnout, which far exceeds ours.

"But I'll just say this, the reason that I think we entertain this bill is because it's time that we had a discussion. No bill is perfect, I think this goes on to the Senate for further discussion, but I think it's time we at least entertain that, on behalf of our constituents. Thank you, Mr. Speaker."

Representative Ward rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Ward's written remarks are as follows:

"Mr. Speaker, I oppose this bill because I believe in the simple election methods that have been used for decades in this country. The candidate who receives the most votes, wins. If the State of Hawaii were to adopt this voting method, anyone with the least number of votes will automatically be disqualified and their votes would go to each voter's second choice. Given the confusion amongst the public, including those in the Office of Elections, I respectfully vote 'no.' *Mahalo.*"

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 210, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONS," passed Third Reading by a vote of 41 ayes to 9 noes, with Representatives Eli, Hashimoto, Holt, B. Kobayashi, Matayoshi, Nakamura and Todd voting aye with reservations, with Representatives Gates, Har, Kong, Matsumoto, McDermott, Okimoto, Thielen, Tokioka and Ward voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1135) recommending that H.B. No. 287, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 287, HD 1, entitled: "A BILL FOR AN ACT RELATING TO VACANT AND ABANDONED RESIDENTIAL PROPERTY," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1136) recommending that H.B. No. 333, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 333, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 333, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE HIGHWAY ENFORCEMENT PROGRAM," passed Third Reading by a vote of 50 ayes, with Representative Okimoto voting aye with reservations, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1137) recommending that H.B. No. 839, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 839, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TRAFFIC SIGNALS ON THE PALI HIGHWAY," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1138) recommending that H.B. No. 1093, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1093, HD 2, entitled: "A BILL FOR AN ACT RELATING TO TRANSPORTATION NETWORK COMPANIES," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1139) recommending that H.B. No. 288, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 439, HD 2, entitled: "A BILL FOR AN ACT RELATING TO LAND USE," passed Third Reading by a vote of 50 ayes, with Representative Thielen voting aye with reservations, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1141) recommending that H.B. No. 453, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 453, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1142) recommending that H.B. No. 455, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 455, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE KAHOO LAWE ISLAND RESERVE COMMISSION," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 558, HD 1, entitled: "A BILL FOR AN ACT RELATING TO KEKAHA KAI STATE PARK," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1144) recommending that H.B. No. 1025, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1025, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Thielen rose to speak in opposition to the measure, stating:

"Mr. Speaker, I'm rising to speak against 1144, Relating to Lease Extensions on Public Lands. Thank you. Mr. Speaker, as I see this bill, it looks to me as if technically someone that would have had a 65-year lease would then be able to extend that lease, meaning that entity or person would have it for multiple generations. That really wipes out our young people, middle aged people that are there that maybe want to use public lands. And I think the original restriction of the 65 years is sound and should stand. Thank you."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Eli rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1025, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LEASE EXTENSIONS ON PUBLIC LAND," passed Third Reading by a vote of 48 ayes to 2 noes, with Representatives Gates, Matsumoto, Okimoto and Perruso voting aye with reservations, with Representatives Eli and Thielen voting no, and with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1145) recommending that H.B. No. 1033, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1033, HD 2, entitled: "A BILL FOR AN ACT RELATING TO MANDATORY VESSEL INSURANCE COVERAGE," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1146) recommending that H.B. No. 1035, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1035, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE INTERSTATE WILDLIFE VIOLATOR COMPACT," passed Third Reading by a vote of 50 ayes, with Representative DeCoite being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1147) recommending that H.B. No. 1121, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1121, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Nakamura rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I'd like to request a ruling on a potential conflict of interest. My husband's law firm is of counsel to the Kauai Island Utility Cooperative. Thank you."

The Chair addressed Representative Nakamura, stating:

"Your request for recusal is granted in this limited circumstance."
