Monday, April 1, 2019

The House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, convened at 12:04 o'clock p.m., with Vice Speaker Nakashima presiding.

The invocation was delivered by Senior Pastor Norman Nakanishi of Grace Bible Church Pearlside, after which the Roll was called showing all members present with the exception of Representatives McKelvey, Saiki and Todd, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Forty-First Day was deferred.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 693, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATEWIDE TRAFFIC CODE," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Saiki and Todd being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1923) recommending that S.B. No. 98, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 98, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, strong support, comments to the Journal, please."

Representative Ward's written remarks are as follows:

"Thank you, Mr. Speaker. Hawaii Kai experienced the first pedestrian death of 2019 because the City & County mistakenly removed a crosswalk that wasn't supposed to be removed. Our neighborhood board requested that it be reinstated but we were given the run around because an EIS was to be conducted first. After I saw the news of a pedestrian death, I wrote a letter

to Mayor Caldwell, and lo and behold, the mistakenly removed crosswalk is now reinstated. My point is, Mr. Speaker, with Hawaii having the most pedestrian deaths in the nation, it is essential that we do all we can to prevent pedestrian accidents. For these reasons, I stand in full support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 98, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CROSSWALK SAFETY," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Saiki and Todd being excused.

Representative Lee, for the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 1924) recommending that S.B. No. 1525, SD 1, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1525, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HOME CARE AGENCIES," passed Third Reading by a vote of 48 ayes, with Representatives McKelvey, Saiki and Todd being excused.

At 12:24 o'clock p.m., the Chair noted that the following bills passed Third Reading:

Representative Lee, for the Committee on Judiciary, presented two reports:

(Stand. Com. Rep. No. 1925) recommending that H.R. No. 86 be adopted; and

(Stand. Com. Rep. No. 1926) recommending that H.C.R. No. 89 be adopted.

Representative Belatti moved that the reports of the Committee be adopted, and that H.R. No. 86; and H.C.R. No. 89 be adopted, seconded by Representative Morikawa.

Representative Matsumoto rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Matayoshi rose to speak in opposition to both measures, stating:

"In opposition, brief comment. Mr. Speaker, I am not in opposition to the banking services or necessarily changing the schedule for cannabis within the Controlled Substances Act itself, though this resolution seeks to encourage the full removal of cannabis from the Controlled Substances Act, and that's why, I just believe that it really belongs there. It's one more step towards possible legalization, I believe. Thank you."

Representative Okimoto rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Eli rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Kitagawa rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Thielen rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. A strong yes vote, Mr. Speaker, and a few remarks. I met with the lead counsel of one of our major banks today. And the banks are, I believe in all of the states that have medical cannabis laws, are dealing with how do they work with financing or accepting deposits from the medical cannabis sector. We have a law, and it's a good law with a lot of protections in place, but without removing cannabis from the Controlled Substances Act, we're going to continue to have difficulties and problems with our cannabis program.

"I know when the medical cannabis started in Colorado, the shops were driving with bags full of money to pay their taxes, and of course the state government and their employees weren't prepared to deal with all of this cash coming across the counter. It was crazy.

"We have a law in place, I think it's about 32 other states maybe now that have medical cannabis laws in place, and this is just the commonsense step to take.

"I wish that we were within the Federal Government to make a bill to be signed into law back there because that would take it right out, but all we can do at this point, as a state legislature, is send a resolution saying, common sense says remove cannabis from the Controlled Substances Act. Thank you."

Representative Ward rose to speak in opposition to both measures, stating:

"Mr. Speaker, in opposition. And a brief comment, because common sense says, controlled substances is controlled because it's a substance endangering of the nation. I think what we have here is a federal law that we are challenging as a state. Federal law trumps state law. Probably a pun intended, because as long as there's a president and a Republican Senate, any of this is going to be just pushed aside and probably not paid much attention to. And that's probably why I appreciate the good Chair of Judiciary pulling back some of the other stuff that pokes the federal, or at least the administration, in the eye. And as long we have \$700 million pending, hopefully we will mind our comments.

"But to the bill itself, Mr. Speaker, we have used medical marijuana as the proverbial nose of the camel into the tent. Again, I quote our good colleague Marcus Oshiro, former Representative from Wahiaawa, who said, after medical cannabis, three to five years you're going to get decrim, and then decrim you're going to get recreational. So, a lot of this stuff that we're playing around on the fringes is really to make us a narcotic field state immunizing our young people with ambitions and freezing the brains of those young people who are going to be doing a lot of marijuana and the synopsis in their brains are not going to even connect. Oh, you sound like you're too conservative. Well, those are the medical realities, Mr. Speaker. You don't get a vibrant society of people who sit back and just float around. And I know I was cut back on this speech when I made it before, because everybody in this building probably has tried marijuana at some time, and it doesn't breed ambition. Now, if someone wants to strike this out of the thing, let it be done, but it's the reality, because you can get marijuana anywhere, anytime, at anyplace.

"The point is, Mr. Speaker, we're trying to go up against the feds with something that is impossible to do, is unconstitutional to do, and for the betterment of society, is not the best thing to do. For those reasons, Mr. Speaker, I'm a no. Thank you."

Representative Tokioka rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Wildberger rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. Strong support for both measures. I'd like the words from my colleague from Kailua entered into Journal as my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Kong rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Cachola rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative San Buenaventura rose to speak in support of both measures, stating:

"In strong support. I'd like to echo the Representative from Kailua's comments. As the speaker notes, I've been involved in helping out and shepherding our medical marijuana dispensary program and being involved in the interim of trying to get banking so that we don't have to have bags of money and cash, which then increases the potential for crime, in our dispensary systems. It is because we don't have the full spectrum banking that this kind of resolution is needed.

"And I just want to make our colleagues well aware that the states are able to ban the substances themselves. The fact that we're asking the Federal Government to take into account the legalization and decriminalization in other states and to allow for full spectrum banking is the reason for this resolution. And for those reasons, I stand in strong support. Thank you."

Representative Thielen rose to respond, stating:

"Thank you, Mr. Speaker, second time, I know. I don't like using the m-word because it's a racist term from out of the 1930s filled with hatred toward Mexicans, it's not scientific. This is cannabis. Mr. Speaker, this is a plant that helps those children with Dravet syndrome, the epileptic fits that are so devastating. It's such a beneficial plant that families actually moved to Colorado, to Colorado Springs. They have quite an enclave of families that went there because their children had the epileptic seizures, and that was the only place they could get cannabis legally at the time to cure them.

"In the military, those veterans now that are suffering from PTSD, we know that many of them are looking toward cannabis and getting help from that. We have a good medical program. What we don't have is what this resolution does. We don't have the banking industry in place too. So, it's kind of a fragile program without the basis that it needs to work within our community. Mr. Speaker, it's time that people stop being afraid of a plant that has done so much good for so many people. And it's certainly is time, Mr. Speaker, that we stop using racist language in this building. Thank you."

Representative Matayoshi rose to respond, stating:

"Thank you, Mr. Speaker, I wanted to clarify that my no vote is for HR 86 and HCR 89. And I also wanted to clarify that I do sympathize with the banking industry. It's a very difficult situation that people are put in because they can't deposit there, the money collected at banks. But again, my opposition is solely for removing cannabis completely from the federal Controlled Substances Act. There are many other prescription drugs on this act, such as codeine. If this resolution was moving or changing the schedule of cannabis, I think I would probably be in favor of it, but because it's removing it completely as a controlled substance, that's why I'm in opposition to this. Thank you."

Representative Belatti rose, stating:

"Mr. Speaker, rising on a point of personal privilege. Mr. Speaker, I'm not going to request that any members comments be stricken, I think the debate here is very good, but I would just like to remind the body that according to House Rule 27.3, a question concerning conduct of members should not be presented by way of debate on other matters. Allusions to, or critical reference to members and their conduct are not in good order. Such attacks are not conducive to the good order of the House. Thank you, Mr. Speaker."

At 12:35 o'clock p.m., Representative Thielen requested a recess and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 12:35 o'clock p.m.

Representative Say rose to speak in opposition to both measures, stating:

"Mr. Speaker, a strong no for both Stand. Com. Rep. 1925 and 1926. A no vote."

The motion was put to vote by the Chair and carried, and the reports of the Committees were adopted and H.R.
