Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because it repeals the law that prohibits the taking, killing, or possession of female spiny lobster (*ula*), Kona crab (*ranina ranina*), and Samoan crab (*Scylla serrata*). The DLNR prefers to regulate this by administrative rules. It contends that administrative rules will enable the department to adopt more comprehensive changes to manage these species. What are these comprehensive changes that the department has in mind? How will their enforcement actions change? *Mahalo*."

Representative McKelvey rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McKelvey's written remarks are as follows:

"House Bill 1017 undermines our entire foundation of administrative law and gives the department complete authority through its own rulemaking without statutory authority whatsoever. We need to continue protecting the resources of kona crab, *ula*, and Samoan crab instead of putting their protection in the hands of Honolulu-based decisions. It's important to know that without the statutory prohibitions, the default is that it is legal to take kona crab, *ula*, and Samoan crab without the department making rules first. It would also potentially criminalize aquaculture endeavors like those at NELHA. For these reasons I vote with reservations."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"Apparently, the night before, he was breaking and entering into a neighbor's home. The neighbor was named Richard Obrero. Richard Obrero shot Starsky as he fled his home in the streets of Kamehameha IV public housing complex. When Mr. Obrero was brought into court, he said that he was standing his ground. He said that he had every right to shoot this boy.

"I was there to see young men and boys cry over the death of their friend and their cousin.

"I'd like to thank the introducer for bringing forth this conversation about gun violence to this community. However, I feel that it is misapplied. I'd like to remind members, as well as myself, that hate begets hate, violence begets violence, toughness begets a greater toughness. Mr. Speaker, I rise in memory of Joseph Kahahawai, Trayvon Martin, and Starsky Willy Soichy. I vote no."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. No vote and brief comment, please. Studies have proven that stand your ground laws only increase gun violence and homicides. Florida and 25 other states have passed these bills and in no way do they deter crime. Thank you."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kapela rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Todd rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Branco rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Eli rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in strong support. I do want to thank my colleagues for sharing their *mana'o* on this bill and for articulating their position. However, I introduced this bill on behalf of my constituents, who for decades have been concerned about safety and protecting not just themselves but their *'ohana* and their homes. And this bill simply allows them to do that. *Mahalo*."

Representative Tam rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lowen rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose to speak in support of the measure, stating:

"In support, Mr. Speaker. This bill is like a familiar old friend to me. I have the same problems that the Representative from Nanakuli referenced in my district, we've suffered a number of home invasions. And to me this is really about, not standing your ground, but being safe at home.

"When I introduced this measure last year, it was really just to defend yourself on your own property. So, while I'm in support of this bill, there is one line that I think I do have some concerns about. In section 2, paragraph 2, part a, where it says, 'the actor is occupying the premises of a place that the actor has a legal right to be,' I think that could be very broadly interpreted. And I think what we don't want to come out of this bill is a law similar to Florida's which has led to a number of negative externalities and poor outcomes. Thank you, Mr. Speaker."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. As I'm on the next committee to hear this bill, I'll be going with reservations for now. Thank you."

Representative Tarnas rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Holt rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Sayama rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McDermott's written remarks are as follows:

"I want to thank the Representative from Hawaii Kai for his leadership and willingness to step aside and allow the next generation of Republican leadership to emerge; it takes a big man to give up power, and his willingness to embrace the situation for the betterment of all, including this body, was an example for us all. I admire him and his record of accomplishment over three decades as breathtaking in scope.

"A man elected to the House in 1990, served as minority leader until 1997 when he departed to run for Congress in 1998. Shortly after that election loss he worked for several years in the USAID, built on the foundation of his work as a Peace Corps volunteer and Vietnam veteran interpreter and East West Center graduate during the 1960s and early 1970s.

"Upon his return to Hawaii, in 2006 he once again ran for State House and won again! What folks may be unaware of is that the district he won in his second go around was not the district proper he once represented, it was the adjacent district. This accomplishment alone is remarkable. How many conservative Republicans win once in Hawaii, let alone twice? Few.

"He once again emerged as the leader of the Republicans and through various incarnations in the 2000s he held various positions. He often promoted the younger folks when he deemed it appropriate as he has done once again today.

"Perhaps the most important thing about the Representative from Hawaii Kai is his character. A devout man of faith, I can honestly tell you that in the 25-plus years I have known him, over the thousands of hours of conversation, he has never attacked another individual (Republican or Democrat) on a personal level. Yes, he would critique ideas in our body and

is in fact known for the catch phrase, 'the marketplace of ideas,' but never, ever, in private or in person, have I heard him attack an individual's character, only ideas.

"In closing, the Representative from Hawaii Kai is a veteran, a Peace Corps volunteer, East West Center and USAID alum, and a member of this body for approximately 2 decades on and off, he has devoted his entire adult life to public service. He has seen others come and go, but he has been the steady hand on the tiller always looking to help young people emerge as leaders. This is what he has done once again in stepping aside to allow the next generation, embodied by the Representative from Mililani Mauka, to now take the helm of leadership with him remaining as minority leader emeritus to provide mentorship and advice. Once again, the Representative from Hawaii Kai has shown us the example of how to lead."

The motion was put to vote by the Chair and carried, and H.R. No. 31 was adopted, with Representative Hashem being excused.
