Thursday, February 18, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at noon, with Speaker Saiki presiding.

The invocation was delivered by Representative Dale T. Kobayashi, after which the Roll was called showing all members present, with Representatives Har and LoPresti participating remotely via videoconference, and with the exception of Representatives Gates and Nakashima, who were excused.

Representative McDermott rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, reservations and some brief comments. With all due respect to the chairs or the introducers of this measure, as it moves on to Finance, I would like us to take a look at the issue of the unintended consequences. What I mean by that, Mr. Speaker, is this bill allows the Department of Transportation to charge fees or assessments on people who own private roads that the public uses.

"Now, I did look at the committee report and I looked at the bill. I may have missed it, but I didn't see where it says that they cannot shut that road down. In fact, we actually had this occur in my district. We have a road, 800 meters is owned by the golf course, one side the City, the other side the Navy. In that middle 800 meters there were potholes, in some cases 8-inches deep. It's not an exaggeration.

"We convened a meeting to address the issue with the golf course, city councilmen, state senator, myself, other colleagues. And the golf course said, well we're not going to repave it, we'll just close it, because there was another way to get in there, but this was much more convenient for the residents at Iroquois Point. This is North Road, what I'm speaking of. It's owned by three different people. So, they said they're not going to fix it and they were going to close it down.

"They offered to give it to the City, they offered to give it to the State, which we know will not accept it because they're unimproved roads. Which is the issue they're trying to fix here, or the safety issue. So, the City came in and paved the unsafe conditions, even though it's against their own rules to improve private property. But they did it for the overall safety, because the golf course wouldn't do it, they were going to close it. So, as we move forward, can we look at that issue of whether they can close it or not, because it's their road. Thank you."

Representative LoPresti rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I just would like to have the comments of my colleague from Ewa Beach entered into the record as if they were my own. He raises a really legitimate point in the Ewa Beach area that I hope is also considered. Thank you," and the Chair "so ordered." (By reference only.)

"In fact, Mr. Speaker, this has the potential to diversify our economy even more so than, as I've spoken on the floor, being the Hollywood of the Pacific, making movies as an economic diversification, and creating jobs that pay very, very strongly.

"Eliminating this is really eliminating probably the best place in the Pacific for not only small satellite launches but also for space tourism. As we know, there will be weightlessness flights that go up and will come down and they're having a huge premium that visitors are willing to pay.

"For those reasons, Mr. Speaker, I would hope as this moves on, we would think of the economy that has stalled and this is a way of diversifying it. I know we've given a lot weight, lip service, if you will, to diversifying the economy. This is one of those and this is office of the epicenter of diversifying the economy for space tourism, which the future holds a lot of potential. And I just regret that this is going to be a bill that is likely going to pass. For those reasons, Mr. Speaker, a no vote. A strong no vote, thank you."

Representative Wildberger rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

"In support, Mr. Speaker, just a few brief comments. The Office of Aerospace Development is, at this time, defunct and has been for a while. So, any outer space ventures, moon landings, weightless flights, that would be PISCES that they would be dealing with, not the Office of Aerospace Development. Thank you."

"Thank you, Mr. Speaker. In strong support and I would like to have the comments by the Representative from the North Shore written into the Journal as if it was my own," and the Chair "so ordered." (By reference only.)

"Thank you, Mr. Speaker. In support. It is unfortunate that the Governor's budget eliminated PISCES and all remnants of this office. This office, Office of Aerospace, has nothing left, even the person who was heading this office is now doing other jobs. So, it has been decimated already. The only thing that was left was travel, and I don't think it is the responsibility of the Legislature to leave just travel and slush fund for this office.

"So, in as much as I agree with some of the things that the prior Minority Leader has spoken, it's one thing for us to continue wishful thinking and hope that this office succeed, I think at some point in time it is about leadership and we need to just start over and look at how we can support the efforts of PISCES, it may not be fit in this office anymore. Thank you."
