"Point number two is that penalties, such as fines on the individual user level, have usually been much less effective than fines on the wholesale manufacturer or distribution level. So, you have requirements for warning labels on cigarettes, you have requirements for what ages you can purchase cigarettes, you have requirements for tobacco taxes, which have been extremely effective in lowering the usage of cigarettes especially amongst young people. So, that is generally the preferred way of tobacco control and enforcement. And while the fines here are not harmful, I think that they can also be added to with other, more effective means. Thank you."

This bill proposes to lower the Hawaii estate tax from \$5.49 million to an unspecified amount. My concern is that by lowering the estate tax, we will further motivate our aging population to join the ongoing exodus of our state's residents to the mainland. Furthermore, many of our residents live in multigenerational homes that have already appreciated just this year. If the family does not have the assets to pay the tax, they would be forced to sell their homes and further exacerbate our locals' problem of not owning a home. Thank you, Mr. Speaker."

Representative Har rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose to disclose a potential conflict of interest, stating:

I understand that right now, the amount is blank, but let's say hypothetically, if we're talking about estates under \$5 million, for the majority of folks, they made the majority of their money in their lifetime with their salary, not with investments necessarily or capital gains or stock options.

"So, if you made enough salary to have a \$5 million estate, your entire life you've been taxed at about a 50% effective tax rate when you factor in state and local taxes. And my fear is that if we set too low of a limit, what we're going to do is prevent middle class people from passing on their family homes to their children. Thank you."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

This measure would increase the fines for any individuals caught popping fireworks and for the permitted hours. The fines collected will be allocated for law enforcement."

"Mr. Speaker, I rise in opposition to HB 111, HD 2.

"The intent of this bill is to transition Hawaii away from fossil fuels so that the State of Hawaii is 100% reliant on renewable energy. While I certainly believe the intent of this bill is laudable, notwithstanding I am in opposition.

"The reason for my opposition is that this measure does not align with the state's 100% renewable portfolio standards mandate set forth in §269-92(d), which describes events and situations that are beyond the control of the electric utility companies that would allow them to use fossil fuels to generate electricity in emergency situations. Furthermore, there should be other amendments to the measure more clearly defining emergency electricity generation facilities, and describing events or circumstances that are beyond the reasonable control of electric utility companies.

"Mr. Speaker, I agree that Hawaii should move aggressively in the direction of renewable energy, but I also believe that we need to have more discussions on planning the 'what ifs' to make absolutely sure that after our state eliminates most of the fossil fuel energy production and reserves, there will be a contingency plan in place to provide continuous electricity for the people in the State of Hawaii. And for these reasons, I stand in opposition to HB 111, HD 2. Thank you."

Representative Ward rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representative Okimoto's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to HSCR 726, HB 433, HD 1. This bill imposes a 'climate change impact fee' of an unspecified amount per day or portion of a day to a rented rental motor vehicle. We already have legislation on the books that imposes a tax on the renting of motor vehicles, specifically HRS chapter 251. Furthermore, this surcharge is to be administered by the DLNR, which will put them at odds with DOTAX who is already administering a tax on rental motor vehicles. With all due respect to the author, our rental car industry already pays its fair share of fees. We should encourage industries to recover during our ongoing budget crisis, and this bill conflates already considerable revenue losses. For those reasons, Mr. Speaker, I am opposed to this bill."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 433, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CLIMATE CHANGE MITIGATION," passed Third Reading by a vote of 47 ayes to 3 noes, with Representative Ward voting aye with reservations, with Representatives Kong, McDermott, and Okimoto voting no, and with Representative Takumi being excused.

Representative Okimoto rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Okimoto's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition to HSCR 730, HB 1142, HD 2. I will keep this brief; this is, first and foremost, a tax increase on midlevel cars. Our state already has THE highest cost of living in the US. Legislation and taxes like this further contribute to this problem and force our population to outsource their needs to the mainland. For these reasons, Mr. Speaker, I am opposed to this bill." Representative Har rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Har's written remarks are as follows:

"Mr. Speaker, I rise in opposition to HB 1142, HD 2, Relating to Energy. This bill enacts a 1% surcharge on the gross proceeds and income on the sale of gas-powered vehicles with a value of \$60,000 or more. The monies collected from this surcharge would then be placed into the public utilities commission special fund subaccount established for the sole purpose of funding the rebate program for the construction of EV charging stations.

"Mr. Speaker, I am a staunch supporter of alternative energy and in fact, have owned a hybrid vehicle since 2007. While I support the intent of this measure, my concern is that passing this measure as is violates HRS §37-52.3, which states that there is criteria for the establishment and continuance of special funds as shown below:

§37-52.3. Criteria for the establishment and continuance of special funds. Special funds shall be established only pursuant to an act of the legislature. The legislature, in establishing or reviewing a special fund to determine whether it should be continued, shall ensure that the special fund:

(1) Serves a need, as demonstrated by:

- (A) The purpose of the program to be supported by the fund;
- (B) The scope of the program, including financial information on fees to be charged, sources of projected revenue, and costs; and
- (C) An explanation of why the program cannot be implemented successfully under the general fund appropriation process;

(2) Reflects a clear nexus between the benefits sought and charges made upon the program users or beneficiaries or a clear link between the program and the sources of revenue, as opposed to serving primarily as a means to provide the program or users with an automatic means of support that is removed from the normal budget and appropriation process;....

"Mr. Speaker, I submit that there is no nexus between the surcharge enacted against purchasers of gas-powered vehicles valued over \$60,000 and the EV charging stations rebate program. State law requires a 'clear link.' If, however, this measure included electric vehicles valued at \$60,000 and over, there would be a clear link because the purchasers of EV at this price point would be the potential users of the EV charging stations.

"As this bill violates HRS §37.52.3(2) in that there is no nexus between the surcharge on gas powered vehicles and the EV charging rebate system, I stand in opposition to HB 1142, HD 2. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. My reservations stem from the discussion we had in JHA relating to the confiscation of computers and if they are used basically in bullying and harassment, and it just seemed like an uneven penalty that could be applied to one family with a kid with only one computer in the household and everybody needs it to do the school work and say another family that might have multiple devices, so that's my reservations."

Representative Matayoshi rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I wanted to address some concerns that came up in the testimony. Members, this bill addresses a concern occurring every day in the courts of Hawaii. Domestic violence offenders almost always after arrest put pressure on victims not to appear in court, to recant, and to not cooperate with prosecutors. And it's working. Each year, hundreds of cases are dismissed for this reason. "The pressure by domestic violence defendants to have victims recant or not appear in court can often be heard in recordings from jail, where every day domestic violence defendants threaten, sweet talk, and coerce victims not to appear or to testify untruthfully.

"This bill is a narrow hearsay exemption for statements made to responding officers prior to the defendant's arrest. When the police respond to a call for domestic violence and the perpetrator is not on the scene, the primary purpose for both the questions to the victim and the responses to those questions to law enforcement are made in response to an ongoing emergency and are therefore nontestimonial in nature. Police officers ask questions to the victim in order to gather facts as to what happened, what medical attention might be needed, who did this, where they are, in order to arrest the person quickly and thereby keep the victim and their family safe.

"In domestic violence cases, the perpetrator who is not in custody is still a danger to the victim and their family. For example, the defendant might have keys to the home, might know what time the victim leaves their house and the route they take, might know the friends and family of the victim and where the victim might flee to if they don't feel safe at home, and a lot of other information that puts the victim in danger while the perpetrator is still on the loose.

"So that this questioning and the answers to these questions, again, passes the ongoing emergency test standard that the U.S. Supreme Court discussed in its most recent case on this issue, *Michigan v. Bryant*, in 2011, prior to the arrest of the defendant in a domestic violence case, it is clear that there is an ongoing emergency, such that the primary purpose of the police officers' questions, the victim's answers to what exactly happened and by whom, is to gather important, potentially lifesaving facts. As the court clearly stated in *Michigan v. Bryant*, the existence of an ongoing emergency at the time of the encounter is among the most important circumstances informing the interrogation's primary purpose.

"Nationwide, statistics show that 44.8% of women killed from 2007 to 2016 were killed by an intimate partner. And other news stories and studies are also alarming, discussing that the ongoing emergency right after a victim reports a case of intimate partner violence, women in abusive relationships are 500 times more at risk to violence when they leave.

"So, the primary purpose of this bill is to address the ongoing emergency of how the criminal justice system in Hawaii handles the prosecution of domestic violence cases. The proposed bill has constitutional safeguards in place that would entitle the defendant to a fair trial, only allowing statements that have a sufficient *indicia* of reliability after judicial review, which also be held constitutionally valid. So I ask my colleagues to join me in supporting this bill. Thank you."

Representative Nakamura rose to speak in opposition to the measure, stating:

"Thank you, in opposition. I respect the introducer of the bill's position and attempt to address this ongoing concern. I just wanted to note that there's a lot of negative testimony from the Judiciary, from the public defenders, and from the Hawaii Association of Criminal Defense Lawyers. So, I just wanted to state my concerns based on the testimony we received. Thank you."

Representative Ganaden rose to disclose a potential conflict of interest, stating:

"Noting a brief conflict. I'm a member of the Hawaii State Bar's committee on Hawaii defense attorneys," and the Chair ruled, "no conflict," and that the ruling would extend through *sine die*.

Representative Ganaden continued to speak in support of the measure, stating:

"I'm also standing in strong support. As a former staff attorney for the Domestic Violence Action Center, I represented numerous individuals who would go into court requesting a temporary restraining order to be turned into a full protective order under Chapter 586, which is in the family court.

"Oftentimes, the court would suspend numerous forms of evidence that wouldn't be admissible under criminal court in order to hear all the facts. Oftentimes, the individuals that we were representing were still in a relationship or were going to go back into a relationship with the respondent. So, the facts that were presented to the family court were oftentimes very different from the facts that were presented to the criminal court. For that reason, and because individuals would exercise their rights under due process, things would change in between the issuance of the protective order and the forthcoming criminal trial.

"If you work in this kind of line of work, you know that this is a unique kind of thing. That intimate family violence goes across lines of race, of class, of all sections of humanity. The way that hurt begets hurt is terrifying and predictable. For that reason, I stand in strong support."

"I appreciate the correction from the author of the bill, because the bill raises more questions than it gives answers. For example, why now? Why now and why not earlier? Many people on this floor work outside, why should we not be able to? Okay, we're part time.

"The point is, if we want to shackle the lieutenant governor, if we'd done this like two years ago, we'd be really in trouble. And because it's now, the timing of it just doesn't pass the smell test, Mr. Speaker.

"So, why now? Why are we doing this? And as the great opening remarks were, how does this make us closer and stronger, when in effect we put a mark on somebody's particular profession? Thank you, Mr. Speaker. For those reasons, no vote."

Representative McDermott rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose in opposition to the measure and asked that the remarks of Representatives Wildberger and Ward be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Lowen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative LoPresti rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

No. 1339, entitled: "A BILL FOR AN ACT RELATING TO IMPEACHMENT," passed Second Reading and was placed on the calendar for Third Reading, with Representatives DeCoite, Har, Tokioka, and Ward voting no, and with Representative Takumi being excused.

Representatives Tarnas and Nakashima, for the Committee on Water & Land and the Committee on Judiciary & Hawaiian Affairs, presented two reports:

(Stand. Com. Rep. No. 777) recommending that H.R. No. 33, as amended in HD 1, be adopted; and

(Stand. Com. Rep. No. 778) recommending that H.C.R. No. 41, as amended in HD 1, be adopted.

Representative Belatti moved that the reports of the Committees be adopted, and that H.R. No. 33, HD 1; and H.C.R. No. 41, HD 1 be adopted, seconded by Representative Morikawa.

Representative Tarnas rose to speak in support of both measures, stating:

"Thank you, Mr. Speaker. In support with some comments. These resolutions are in response to the House Speaker's comments at the very beginning of session, when he threw down the gauntlet saying that the University of Hawaii really should not be the one to manage the mountain going forward. The Speaker was giving voice to skepticism that is shared by residents in the state, not everybody, but there are a number that think the University should not be the one to manage the mountain.

"So, these two resolutions are to set up a working group that would allow the opportunity for the Native Hawaiian representatives to speak their perspective and share that perspective with the other members of the working group and then in turn to the Legislature and to the land board.

"The University is proceeding forward on their plans to extend the lease on the mountain so that they would be able to manage it as part of their responsibilities over these public trust lands. There is an independent evaluation of the management plan, and in that independent evaluation it states that, while the University has done a good job managing the natural resources on the mountain, they have struggled to really manage the cultural resources on the mountain. And that they have tried, but they have not really been able to engage with the Native Hawaiian community in seeking their input on a new management framework for the mountain. The University has identified five different governance structures, alternatives, and they are really only evaluating one of them, which is the one that has the University as the main manager.

"These resolutions set up a working group that would allow us to engage with the Native Hawaiian community and evaluate these other management structures for the mountain. And I think it's important for us, in our responsibility to manage public trust lands, that we engage with the Native Hawaiian community to get their perspective and share that perspective with other members of the working group, which would include the land board, the Board of Regents, the Office of Hawaiian Affairs, and also with the observatories.

"And I think this is really important for everyone to have that opportunity, have that discussion, so we can bring forward these perspectives to the University as they make their recommendation to the land board. And these recommendations would be shared with the land board and with the Legislature, so that we can make these important decisions going forward.

"I urge the members not to make this resolution about the Thirty Meter Telescope, it really is about the existing observatories on the mountain and how we manage the mountain going forward, so that we can actually do our job managing public trust resources and listen to the perspective of our Native Hawaiian community. So, I urge members here to support these resolutions and I appreciate their support. Thank you, Mr. Speaker."

Representative Ward rose to speak in opposition to both measures, stating:

"Mr. Speaker, opposition and a few comments. In all due respect to the Representative from the Big Island, in which the mountain does exist, if the mountain was in my district, I would certainly do the same thing that he's doing. However, he's wrong in a couple of places. First of all, all the testimony, we heard this in our committee, the Hawaiians are saying, we don't want this bill. So, if it's a way to embrace them, it looks like the wrong methodology by which to proceed.

"In particular, it's where they see it as, and we can't pretend it's not about TMT, because I think that's the big fatal flaw. There's an elephant in the room, there's an elephant on the mountain, and it's called the TMT. This does not get us farther to a resolution of that of which we know this is a festering sore in the Hawaiian community and in all of the governance model of this state. We've got to resolve that problem.

"I am not personally convinced that the way that this is restructured is another thing that shows we're doing something to do something, but in order to get to the ultimate of resolving this within the Hawaiian community, either culturally or scientifically, it's not going to get there.

"For those reasons, Mr. Speaker, there's expectations that are being put out today that are not going to be in that and we're going to end up in the same old, same old position. And we've got to get some leadership to really take control of this, and this particular reso is not going to be able to do it. For those reasons, I have a no vote. Thank you."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Kapela rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Perruso rose to speak in opposition to both measures, stating:

"No vote with comments. While I applaud the intention of the author of the bill and of this general approach, I do have concerns about the perception from the community that this is a vehicle to move forward further development on the *mauna*. And as I stand in opposition to that, I stand in opposition to both of these resolutions."

Representative Wildberger rose and asked that the Clerk record a no vote for her on both measures, and the Chair "so ordered."

Representative Ganaden rose to speak in support of both measures with reservations, stating:

"With reservations, Mr. Speaker. I was actually present on Mauna Kea on July 16, 2019 when numerous members of law enforcement came in to remove, with force, individuals who had come to protect the mountain with their lives. That noted, if this moves forward, I would like to note the concerns of the Office of Hawaiian Affairs that request that any working groups should consist of more than just a bare majority of Native Hawaiian voices and should specifically include Native Hawaiians who have demonstrated *kuleana* regarding Mauna Kea. Thank you."

Representative McKelvey rose to speak in support of both measures with reservations, stating:

"Thank you, Mr. Speaker. With reservations. I'd just like the comments of the previous speaker entered into Journal as if it were my own," and the Chair "so ordered." (By reference only.)

Representative McKelvey continued, stating:

"I share the concerns that were issued by OHA during the committee hearing, but I keep coming back to this one point. Right now, under the status quo, it's just the University, them and them alone, that controls the fate of the mountain. And a lot of the decisions of future endeavors will lie with them and them alone.

"So, this working group actually begins the process of hopefully trying to wrestle this unilateral control back towards the community and to the Native Hawaiian community. But I have my concerns, given the previous speaker, so, with reservations. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her on both measures, and the Chair "so ordered."

Representative Tarnas rose to respond, stating:

"Thank you, Mr. Speaker. Second time, just a brief correction. The Representative from Hawaii Kai was not quite accurate. We did receive supportive testimony from Native Hawaiian leaders and Native Hawaiian organizations, like the Hawaiian Civic Club in Hilo and Hawaiian Civic Club in Kohala.

"The Native Hawaiian leaders, the Native Hawaiian community are not of one opinion about this. And we did receive supportive testimony saying, yes, we do need to have a forum where we would be able to provide our perspective. So, this does offer that forum.

"And we did receive testimony saying, members of this working group really should be from Hawaii Island. And I certainly have made that recommendation to the Speaker, as he makes his decisions about who serves on this. And I am encouraging the Native Hawaiian organizations to nominate people who would be able to serve on this working group, so that we can have a positive conversation and share perspectives. That's essential for us as we carry out our responsibilities for these public trust lands. Thank you, Mr. Speaker."

Representative Ward rose to respond, stating:

"Mr. Speaker, I stand corrected with the good Representative from the Big Island. Only 80% of the people were against it, instead of 100%. Thank you."

Representative Todd rose to speak in support of both measures, stating:

"In support. Just to add on to what the Water & Land Chair said, I do think it's especially important to point out that one of the testimonies that came in support was from someone who was actually kind of the face of the *kia* 'i in a way and was arrested on the *mauna*. I think if they can come around to the idea to at least be open to the general idea of reconciliation and finding a path forward, then it isn't really our role to assign motive and intent to an entire group of people based on individual testimony, I don't think that's fair.

"Also, as I said in committee before the vote, I don't think it's fair to attach this to TMT. There is nothing in this process that will have any impact on whether TMT is allowed to proceed or not. They are already allowed to proceed, that's not what's at issue here. It's about finding a path forward for the future of Mauna Kea that kind of accounts for a broader collection of voices and is not driven by the University of Hawaii, which inherently has a conflict of interest in their management.

"So, I think whether we get to the right place or not, I do think that this is the right approach, and I'm hoping that we can take into consideration a lot of the testimony to improve this process and make sure it's as equitable as possible. Thank you."

Representative Nakamura rose to speak in support of both measures, stating:

"In support. I wanted to ask that the words of the Water & Land Committee Chair and the Representative from Hilo be accepted as my own. I also wanted to note that both of these representatives represent the Island of Hawaii. The Judiciary Chair, who heard this bill, is from the Island of Hawaii. And the two members who also serve on the Judiciary Committee with me represent the Island of Hawaii. So, I respect their recommendation and their efforts to try to find a path together forward by involving as many voices in the proposed process. Thank you, Chair," and the Chair "so ordered." (By reference only.)

Representative Branco rose to speak in support of both measures, stating:

"In support. For this measure, I believe this will start a conversation. This will be a hard conversation, but I believe in the hardest conversations, there can be resolution. And so that's why I support this.

"I also caution the body, as someone from the Native Hawaiian community, I think it's important that Native Hawaiians speak up for themselves. And so, it's very difficult for me to hear sometimes, Native Hawaiians think this, Native Hawaiians think this, when you are not from the community. So, I think we need to recognize the folk that Native Hawaiians should speak for themselves. *Mahalo*."

The motion was put to vote by the Chair and carried, and the reports of the Committees were adopted and H.R. No. 33, HD 1, entitled: "HOUSE RESOLUTION CONVENING A WORKING GROUP TO DEVELOP RECOMMENDATIONS FOR A GOVERNANCE AND MANAGEMENT STRUCTURE FOR MAUNA KEA," was adopted, with Representatives Ganaden, Matsumoto, and McKelvey voting aye with reservations, with Representatives Kapela, D. Kobayashi, Perruso, Ward, and Wildberger voting no, and with Representative Takumi being excused; and
