

## TWENTY-FIFTH DAY

Friday, March 5, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at noon, with Speaker Saiki presiding.

The invocation was delivered by Representative Lisa Marten, after which the Roll was called showing all members present, with Representatives Har and LoPresti participating remotely via videoconference, and with the exception of Representative McKelvey, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Third and Twenty-Fourth Days was deferred.

Representative DeCoite rose to speak in opposition to the measure, stating:

"In opposition, brief comment. Mr. Speaker, it is clear that the awarding of these contracts should demonstrate need. We continue to put these lands up for lease. Besides that, CTAHR already has its own fair share of problems in trying to advance itself in their own leases, as well as securing the fact of liability coverage. So, with that, I'm in opposition and permission to insert comments to the Journal. Thank you."

Representative DeCoite's written remarks are as follows:

"I am voting in opposition to this bill in its current form because functions are being given to CTAHR that are not part of their mission of education and research. As the Department of Agriculture has pointed out, this bill would disregard current DOA eligibility requirements in the leasing process. A contractor who wins multiple consecutive contracts could accumulate and monopolize the use of significant tracts of public land as each subsequent contract provides an additional opportunity to lease without demonstrating a need for additional acreage. The DOA's land leasing programs ordinarily have minimum lease terms of 15 years. The longer term allows a farmer to invest in and make improvement to the land and provides long-term stability. A contractor who is only awarded a single season contract could gain a windfall in the form of a valuable long-term lease after fulfilling a short-term contract. *Mahalo.*"

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Perruso rose to speak in opposition to the measure, stating:

"In opposition with brief comments. I want to say that I definitely applaud the intent and the direction of this measure, but I think that it needs more work. So, at this point, I'm in opposition."

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 531, HD 2, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURAL LANDS," passed Third Reading by a vote of 43 ayes to 7 noes, with Representatives LoPresti, Nakamura, and Okimoto voting aye with reservations, with Representatives DeCoite, Har, Kapela, D. Kobayashi, Onishi, Perruso, and Tokioka voting no, and with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 807) recommending that H.B. No. 930, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 930, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition please, brief comment. Right now, our Employees' Retirement System, that every single person here is invested in, is 18 months behind in its disclosure of earnings and performance. Any private investment vehicle would never be able to survive with that sort of performance. And so, this bill is asking to make investments that are not disclosed to the people that are contributing, and so, because of that, I am in strong opposition to this measure. *Mahalo*."

Representative LoPresti rose in opposition to the measure and asked that the remarks of Representative Wildberger be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 930, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EMPLOYEES' RETIREMENT SYSTEM INVESTMENTS," passed Third Reading by a vote of 44 ayes to 6 noes, with Representatives Ganaden, Kapela, LoPresti, Perruso, Tam, and Wildberger voting no, and with Representative McKelvey being excused.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1174, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, a no vote with a brief comment, please. Mr. Speaker, this lessens the motion picture tax credit and cap. And to my way of thinking, this is a lessening of our competitive edge or our competitive advantage, and we are kind of in a bullish movie and TV area right now. But like many of us here, including my wife, we will not pay retail. And this is almost a necessary incentive, if you will. If you're going to come to film anywhere, you've got to have tax credits. And by us lessening the amounts, I think we're lessening our competition. And, as I've said on this floor on numerous times and occasions, we have the ability to become the Hollywood of the Pacific. But we've got to play the structure of our incentives properly, and I think this is a disincentive. For those reasons, no. Thank you."

Representative Quinlan rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I would like to once again point out that this measure before us is one of fiscal accountability. It's one of transparency for our taxpayers. And quite frankly, I'm a little surprised that the party of fiscal responsibility, the party of fiscal conservatism, would vote against such a measure. Thank you."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1174, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Third Reading by a vote of 49 ayes to 1 no, with Representative Okimoto voting aye with reservations, with Representative Ward voting no, and with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 820) recommending that H.B. No. 775 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 775 pass Third Reading, seconded by Representative Morikawa.

Representative Yamashita rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Yamashita's written remarks are as follows:

"I stand in strong support of Stand. Com. Rep. No. 820, H.B. No. 775. This bill serves as a remembrance of the late Mayor Elmer Cravalho to commemorate his leadership and civil service not only to the people of Maui County, but also the people of the State of Hawaii. He was the first speaker of the State and Territorial House and continued his political career as the first mayor of Maui.

"Born in Paia, Maui on Feb. 19, 1926, Elmer Cravalho started his career as a Maui schoolteacher. In 1954, he entered the political realm and was elected to the Hawaii House of Representatives, serving until 1967. After statehood, he became the first Hawaii State House speaker in 1959 following his time as being the House chair of Finance.

"Leaving his position as speaker of the House, Elmer Cravalho ran for and won the special election to fill the position as Maui County's chairman. A few years later in 1969, due to a new charter provision that served as a foundation for the current political system that we know today, he was elected as Maui's first mayor.

"As mayor, he was responsible for many economic and infrastructure development projects. This included boosting Maui's tourism industry and creating affordable housing projects. One of his most notable projects was the development of the waterline from Wailuku and Wailea. The waterline project enabled the expansion of Kihei, developing it from once barren land to a residential locality and popular destination of Maui. His love for Maui was clear in the projects he chose to implement and the perseverance he showed throughout his life.

"On a personal note, I would like to thank him for all the guidance he shared with me during my tenure in office. I met with him on a regular basis, where he acted as an educator and mentor with a wealth of knowledge that is invaluable to me.

"Mayor Elmer Cravalho was a visionary leader whose actions changed Maui and the State of Hawaii to what we know today. Renaming a major roadway will serve as a thank you from his community for his commitment to Maui's growth and all that he did for the people he served."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 775, entitled: "A BILL FOR AN ACT RELATING TO RENAMING KAHULUI AIRPORT ACCESS ROAD," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 821) recommending that H.B. No. 663, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 663, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE GAME MANAGEMENT ADVISORY COMMISSION," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 822) recommending that H.B. No. 1029 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1029, entitled: "A BILL FOR AN ACT RELATING TO LIVING PARK PLANNING COUNCILS," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 823) recommending that H.B. No. 1105, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1086, HD 1, entitled: "A BILL FOR AN ACT RELATING TO VETERINARIANS," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 826) recommending that H.B. No. 282, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 282, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MINORS," passed Third Reading by a vote of 49 ayes to 1 no, with Representative McDermott voting no, and with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 827) recommending that H.B. No. 339, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 339, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE FAMILY COURT," passed Third Reading by a vote of 47 ayes to 3 noes, with Representatives Ganaden, Har, and Ward voting no, and with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 828) recommending that H.B. No. 1102, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1102, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition with a brief comment, please. Mr. Speaker, this is a well-intended bill. I think we want to lessen gasses and pollution as much as possible. But the issue is, it's the wrong timing. Mr. Speaker, this says that if a birthday party or a graduation has the release of a balloon that's inflated with gas that is lighter than air, you're going to be in trouble.

"Mr. Speaker, and again, with all due respect to the author, this trivializes the seriousness that we are now faced in the State of Hawaii. We've got the highest unemployment rate in the nation, we've got a huge budget deficit, and we're playing around with balloons and saying that we're going to make a difference by saying, if you're going to have a birthday party or graduation,

we're going to prohibit that. All this does is grow government and grow the authority of we in the state government has over the people. And I think this sends the wrong message, it's Nero in the burning of Rome while he is fiddling. And with all due respect, look, it makes sense, it's a good thing, but it's not the time to do it now, it sends the wrong message to the people of Hawaii. Thank you, Mr. Speaker."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1102, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LITTER CONTROL," passed Third Reading by a vote of 49 ayes to 1 no, with Representatives Okimoto and Tokioka voting aye with reservations, with Representative Ward voting no, and with Representative McKelvey being excused.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 829) recommending that H.B. No. 902, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 902, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition, brief comment, basically echoing what OHA said. If this involves crown lands and lands that the Hawaiians should have, we have a moral imperative to return the Hawaiians to the land. And if this alienates more land, we're going in the opposite direction. So, on behalf of what OHA has said, in between the lines, this is a step backwards, we don't need to give less land to the Hawaiians. More land, and obviously more housing. Thank you."

Representative Nakamura rose to speak in support of the measure, stating:

"In strong support. Mr. Speaker, since I first got elected to this body four years ago, I noticed that the Legislature has made an incredible commitment to affordable housing. And you've done that. I think we've all collectively worked on this to increase the amount of funds going into the dwelling unit revolving fund and the rental housing revolving fund, the two critical tools used to build and finance affordable housing in the State of Hawaii. As a result of this commitment by this Legislature, over the next five years, 8,000 affordable rentals and homes will be built.

"We met with OHA and HHFDC recently to talk about, how do we position Native Hawaiians into these rental units and homes? And we came up with some preliminary ideas about how to make this happen. And Mr. Speaker, the end result is that we're going to be working together with HHFDC and OHA to create waiting lists of renter-ready and mortgage-ready Native Hawaiians who can then have the opportunity to live in these units that have been financed by the State of Hawaii.

"And so, this is another tool that gives HHFDC the opportunity to do more, to not draw the line in the sand, but rather find ways to work together to make renter and homeownership a reality. And I just feel that we have the opportunity to address the critical issue of Native Hawaiians who are disproportionately homeless, disproportionately live in crowded conditions, and disproportionately are not homeowners in their native lands.

"So, I want to recognize and thank the Vice Chair of the Housing Committee and the Vice Chair of Water & Land for assisting in these ongoing discussions, and hopefully we will work toward really making a difference for Native Hawaiians. Thank you."

Representative Hashimoto rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Strong support and I would like to adopt the words of the Housing Chair as if they were my own," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 902, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PUBLIC LANDS," passed Third Reading by a vote of 43 ayes to 7 noes, with Representative LoPresti voting aye with reservations, with Representatives Eli, Ilagan, Kapela, D. Kobayashi, Okimoto, Perruso, and Ward voting no, and with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 830) recommending that H.B. No. 103, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 103, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EMERGENCY POWERS," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 831) recommending that H.B. No. 273, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 273, HD 1, entitled: "A BILL FOR AN ACT RELATING TO LICENSE RENEWALS," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 832) recommending that H.B. No. 572, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 572, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII EMERGENCY MANAGEMENT AGENCY," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 833) recommending that H.B. No. 573, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 573, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 573, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FEDERAL FUNDS," passed Third Reading by a vote of 50 ayes, with Representative Okimoto voting aye with reservations, and with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 834) recommending that H.B. No. 723, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 723, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PANDEMIC RESPONSE," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 835) recommending that H.B. No. 765, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 765, HD 1, entitled: "A BILL FOR AN ACT RELATING TO

MOBILE EMERGENCY MANAGEMENT SERVICES," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 836) recommending that H.B. No. 825, HD 2 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 825, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition with a brief comment. This bill gives basically martial law powers to the governor. I don't think we're under martial law, but he can take over buildings. In fact, he could take over this legislative session and building if he so desired. So, I think it's a bit of an overkill, an overreach. I know we want to be good to the governor, we want to make the emergency powers work, but to have a bill like this, this suggests to me that the departments are not cooperating when the government or the governor asks for something. And again, it looks too much like martial law to me. Thank you."

Representative Johanson rose to speak in support of the measure, stating:

"Thank you, in support. Just to correct the record, this bill has nothing to do with martial law. All it explicitly does in statute is clarify that for state agencies, in times of emergency proclamation, the governor is able to assume control of any state facility. Members may be wondering the genesis of this bill, which is why I'd like to explain it, because I've heard it mischaracterized in several floor sessions now. And I thought for the record, since this is third reading, I would elaborate.

"Mr. Speaker, under your leadership, the House has launched numerous initiatives, whether it was the standing up of the unemployment insurance massive operation at the Hawaii Convention Center, as well as the two public vaccination sites for the mass public vaccination campaign. And many of those members that you tasked with working on it know all too familiar how long, and painful, and arduous the discussions were with various state agencies, in a crisis, one of the greatest crises that members of the public have faced with us, know all too well how long and painful the negotiations were over whether or not a state agency would be recompensed and what rate of pay would be necessary to compensate a state agency that the state taxpayers already funding through their taxes.

"So, although the governor may already have this authority implied, the truth is, Mr. Speaker, so that to borrow the phrase of the previous speaker, while Rome is burning, rather than wasting precious time while a pandemic is raging, the governor shouldn't have to be so concerned with whether or not we're going to pay to use a school, whether or not we're going to pay to use a convention center. We should be acting on the best interest of our constituents, especially because they're already underfunding all of these state properties as it is. This bill merely clarifies that in statute so that if we're ever in a situation similar to this pandemic, we're not wasting precious weeks and days negotiating what the rate of recompense will be for a taxpayer-funded facility. Thank you."

Representative Ward rose to respond, stating:

"Mr. Speaker, brief retort. I totally agree with the logic of that. But, if we're in an emergency and I'm running the Convention Center, I shouldn't be concerned about charging the governor rent, I should just yield the right of way. And that's my whole sense, that this issue looks like a leadership issue, that the departments are not in sync with the governor, or there's something not in sync when we have an emergency. We shouldn't be talking about how many days and how much rent we should be paying, we should be getting on with the emergency and getting the job done for the people of Hawaii. That's my point."

Representative Tam rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I would like to have the comments from the Representative from West Honolulu inserted into the Journal as if my own. And I'd also like to add that, I've received a lot of comments from my constituents as to why we couldn't use the Convention Center for mass vaccination centers, and this bill would basically allow us to use that. And I

just don't think that the state should be charging the state rent for a state service. Thank you," and the Chair "so ordered." (By reference only.)

Representative D. Kobayashi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ilgan rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Same request as the Representative from Waikiki," and the Chair "so ordered." (By reference only.)

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. When the House helped to set up the unemployment processing center at the Convention Center, one of the things that we became very aware of was that, because the Hawaii Tourism Authority had a specific contract with the use of the Convention Center and because it was in violation of contract law, the governor could not just completely forgive the payment of bringing in outside food for volunteers or even the use of the facility.

"Right now, we're paying, still, about \$12 million to the Convention Center. The emergency powers are still limited in the governor being able to ignore contract laws. The governor can ignore certain state laws and suspend certain current state laws, but under contract laws and others, you cannot.

"It is unfortunate that we continue to have to pay \$12 million. Even if it's on the books, that is money out of pocket for DLIR. And because of that, DLIR doesn't have the budget to hire more staff to process unemployment claims right now. They have about 100 call center employees still at the Convention Center based on the current expenses and they have 75 adjudicators. I think they would like to have more, but because of the contract situation, they just cannot do it. It is kind of an unfortunate situation.

"And we're finding out all these kinds of things through the pandemic. But as to what the CPC Chair recognized, if we can fix this for the future, we need to do it now. As opposed to trying to rely on, or hoping that through leadership or somebody answered the call, if we can just fix some of the laws and make it easier for the future governors or the future legislature to do it, we just have to. Thank you."

Representative Onishi rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With strong reservations. I just want for people to understand that HTA and the Convention Center are funded through appropriations from the TAT. Now, their contracts that they make between private entities depend on that TAT funding. And when the issue of the use of the Convention Center was brought up, the governor had suspended all appropriations from the TAT. So, the HTA and the Convention Center were basically not getting any funding to make good on those contracts. So, they suspended those contracts.

"And when the use of the Convention Center was considered, the issue of who's going to clean the Convention Center and how are we going to pay for the utilities that are being used without compensation was apparent. Other government entities are already funded with general fund appropriations for their expenses, but the Convention Center and HTA are funded directly through TAT appropriations. And in this situation, the governor, instead of continuing the appropriations so that the Convention Center and HTA could provide the center for free, decided to suspend it, and they had no funding in order to make good on those contracts and provide the services that were necessary for the use of the Convention Center. So, I have strong reservations in regards to this bill. Thank you."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Cullen rose to speak in support of the measure, stating:

"Mr. Speaker, I stand in strong support. As a member who volunteered at the Convention Center and saw the UI claims that came in and the possibilities and all the individuals that we did help at that time, I saw that this measure was needed because, as we looked at the budget not just for last session and then seeing it in this session, as we read the budget and you

see some of the U fund transfers to cover costs for emergency-related items, this measure would just seem common sense. And in doing that, we can help the department streamline many things and be more efficient. With that, I stand in strong support, Mr. Speaker."

Representative Ichiyama rose to speak in support of the measure, stating:

"Mr. Speaker, in support and just a brief comment. This bill really just clarifies what is already in our existing emergency statute HRS 127A. And it just clarifies and gives the governor this extra flexibility and powers and authority. And I think in a state of emergency, that extra flexibility is warranted. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 825, HD 2, entitled: "A BILL FOR AN ACT RELATING TO EMERGENCY POWERS," passed Third Reading by a vote of 48 ayes to 2 noes, with Representatives D. Kobayashi, Onishi, and Tokioka voting aye with reservations, with Representatives Okimoto and Ward voting no, and with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 837) recommending that H.B. No. 954, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 954, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAII EMERGENCY MANAGEMENT AGENCY," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 838) recommending that H.B. No. 1286, HD 2 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1286, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Tokioka rose to speak in opposition to the measure, stating:

"No vote, Mr. Speaker, and just a brief comment. When you read this bill, it looks like it's applied to the neighbor islands. But specifically, it was focused, in my opinion and many people from my district and from the island of Kauai, it was focused on Kauai. That's how they feel. And a lot of times they feel separated from what happens over here, that's why they count on their delegation to stand up for them. With Mayor Kawakami's request to Governor Ige to open up Safe Travels on April 5th, it seems that this bill would not even be necessary. So, for those reasons, Mr. Speaker, in opposition."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In continued exasperated opposition, brief comment, please. Many of you all might remember receiving this lovely medallion from the governor after Opening Day with wishes of unity and best wishes for a great session, which I appreciate so much. But I was shocked to find the words that were on the front of it that read, one canoe, one island, one planet. And I can subscribe to the one canoe concept and I certainly can subscribe to the one planet concept, but I have a big problem with the one island concept. And I think that is really the heart of a large reason why I ran for office, to bring a voice to our neighbor islands. And I feel like this bill takes us steps back from achieving autonomy and having a voice. And so again, Mr. Speaker, in opposition and would like to see autonomy retained for leaders on the ground, particularly as it pertains to emergency preparedness and disaster management. Thank you very much."



Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, brief comment. Mr. Speaker, these are the times that try the mindset and the ability of legislators. On the one hand, I feel very strongly we've got to get tourism back and we've got to get the economy going. At the same time, I sense home rule and what Mayor Kawakami, a very competent former colleague in this body, he wanted to do it even better than we have for the State of Hawaii. He could be a model. And I understand that he has now backed off of that, he's willing to go for the state.

"So, we've got to get tourism open. We've got to get a consistency, and I said recently I came back from the mainland, it was just a jungle trying to get through all the 72 hours and the other stuff. So, that is still a problem, but at least we're going to have some consistency. But I think home rule needs to be more honored more often. And for those reasons, Mr. Speaker, I hope this goes well, but I have reservations as to how it's going to work out. Thank you."

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Morikawa rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. Mr. Speaker, HB 1286 has been a very contentious measure. However, as with many bills, this is the public's opportunity to voice their concerns. We know that consistency is a key to success, and the intentions of this bill is just that.

"I believe the message is clear, that we need a policy that will work for Hawaii that will help to spur our economy, stabilize our workforce, and of utmost importance, maintain the health of our state. It has spurred the conversation and brought the advocates to the table, which has helped to find solutions that many can agree on. Whether or not this measure is necessary, I am not sure. It could impede our end goal, or it could continue fostering good conversations. Only time will tell, Mr. Speaker. Thank you."

Representative B. Kobayashi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, in support with reservations. My concern is flexibility and speed of action. This bill would require that there be a concurrent resolution of the Legislature in order to change a state law. First of all, the Legislature convening during the interim is often difficult and not quick. The other point is that if there is a state law, a law would be more inflexible than a governor's proclamation. So, both in terms of law and in terms of changing law, it's slower if this bill comes into law. I would rather see a process that is flexible and fast reacting. Thank you."

Representative Ichiyama rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I rise in support. I think the just past speaker's comments about flexibility are well taken, and so that's why this bill was amended to create the concurrent resolution process, which members may not know is very simple, it's a one-day process, versus trying to pass a law which in special session can take five days.

"I would also say that I think our Legislature has proven itself to be remarkably flexible and agile in this past year in responding to whatever needs came up. And I think members recognize across their districts, when the need arises, they were there, they responded quickly. And I think that's an important point that we shouldn't miss here, that this bill has built in flexibility.

"But also, it provides a stability and certainty to an industry that has been in complete chaos and confusion. And that's really what we're trying to address here, is to provide consistency, predictability, stability, so that we can reopen our economy, people can get back to work and feed their families.

"I also wanted to talk about, I mentioned earlier in second reading, that I believe that public health and economic health are intertwined, and I still find that true. But the second reason I support this bill is because I believe that decisions that have a statewide impact need to be made at a statewide level.

"And let me give you two examples. Mr. Speaker, if we allow a particular county to close down their economy, that has a significant impact on our state finances, our state budget. So, our school system is one state school system that's funded in large part by general fund revenues. Those general fund revenues are collected from the general excise tax, income taxes, even the TAT. And when we have to make cuts, that doesn't just affect one county, Mr. Speaker, that affects schools from Hilo to Hanalei. And I'm proud of our statewide system, I think it makes it fair, makes it equitable. But the only way that we can do that is to spread our resources across the state and not just say whatever one county has should stay in that county.

"The second example I would offer is unemployment insurance. Mr. Speaker, when we close down a sector of our economy and hundreds of people are furloughed or lose their job, it's the State that has to maintain the unemployment insurance system. We have to administer it. We hire the call center workers, the adjudicators. We have taken on the fiscal responsibility of borrowing hundreds of millions of dollars to pay UI benefits.

"And so again, Mr. Speaker, I would just reemphasize my support for this bill, because decisions that have a statewide impact should be made at a statewide level. Thank you."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. May I have the words of the Chair of the Pandemic & Disaster Preparedness Committee entered as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. One of the things that I support this bill is, as you know, Mr. Speaker, even during the interim, many of us helped the administration during this whole process. And my staff has been involved in many of the day-to-day functions of what's going on.

"Part of the money that was used for CARES was to purchase a significant amount of test kits that the Department of Health is holding. And priorities have been set for those test kits, including essential workers, hospitals, including long-term care facilities and others.

"Because we have no statewide system, and it is really about what counties come in to ask for things before any other counties, recently we were able to learn that 250,000 test kits were diverted to one specific county for a Safe Travels type of second test program. And we were successful, thank you to your efforts, Speaker, we were able to block that. Because part of the 250,000 that went to a specific county got diverted by that contractor for the benefit of Oahu.

"If anything, Oahu, the City and County of Honolulu, has the means to purchase their own second test and it should not be state funds, it should not be CARES funds that take care of the second test. It really should be, the onus should be on the traveler. So, those types of things are happening, and it is unfortunate.

"The Legislature is struggling with so many things. The administration is also struggling with a lot of things. And these specific day-to-day things are not being caught, and it really puts a burden on me and my staff and you and your staff and other members of the Legislature to catch some of these mistakes. So, I think that's why we need a statewide policy, so we don't have to run to the governor and say, this is what's happening, can you put a stop to this? Because you cannot benefit one county over others. And just to let the members know, the members from the two counties who spoke up, it wasn't in their county.

"So, one of the things I really object to was that part of the test kits was diverted for the use for Oahu, Oahu travelers. And that's not right. And we should not be using CARES funding for the benefit of second test just for the benefit of a few counties. So, thank you very much."

Representative Onishi rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, and can I have the words of the Chair of Pandemic & Disaster Preparedness and the Chair of Finance entered into the Journal as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Perruso rose to speak in support of the measure with reservations, stating:

"Chair, I'd like the record to reflect that I'd like my vote changed from no to with reservations."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1286, HD 2, entitled: "A BILL FOR AN ACT RELATING TO TRAVEL," passed Third Reading by a vote of 46 ayes to 4 noes, with Representatives DeCoite, B. Kobayashi, Nakamura, Okimoto, Perruso, and Ward voting aye with reservations, with Representatives Kapela, Takumi, Tokioka, and Wildberger voting no, and with Representative McKelvey being excused.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 839) recommending that H.B. No. 1324, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1324, HD 2, entitled: "A BILL FOR AN ACT RELATING TO COMMERCIAL PROPERTY RENT RELIEF," passed Third Reading by a vote of 50 ayes, with Representative McKelvey being excused.

This bill is untimely and targets an individual unfairly, and for those reasons I will just say that it's probably the same thing I would say as I did yesterday. For the sake of what is in the process of being said, may the comments I made yesterday, I will finish now this speech with entering those into the Journal, with your permission."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. Mr. Speaker, just to address some of the public discourse that this may be applicable to any past or present office holders, if we look at the language of the bill, it says November 1st, 2022. So, that puts that to bed.

"Secondly, Mr. Speaker, this measure is not simply about employment. I would point members to the language of the bill that also refers to controlling interest in businesses. And what I would say is, noted attorney constitutional professor Zephyr Teachout teaches us and says, 'corruption, in the American tradition, does not just include blatant bribes and theft from the public till, but encompasses many situations where politicians and public institutions serve private interests at the public's expense.'

"It is that language in this bill that applies to the executives. And it is that language and concern about business interests that may intersect with the politician's own private interests.

"As a hypothetical, we could have a sitting executive who is a consultant to a group that maybe perhaps gains and garners large public contracts. It is that precise type of corruption that this bill aims to reach. And as we have seen, not just in our state, but in our nation, we have this concern about corruption, and it should apply to all of our executives who sit in these places of trust.

"And one last point, Mr. Speaker, as it was raised yesterday, the difference between legislators and executives is that we are designed to be a part time equal branch of government. In the instances of these executives, they are full time employees who wield great power and influence over the use of public funds. Again, that is the corruption, that is what we are getting at with this bill. We need to have a clear barrier to the intermingling of businesses and governmental interest. That is the importance of this bill, Mr. Speaker. Thank you."

Representative Tokioka rose to speak in opposition to the measure, stating:

"No vote and I'd like to ask the Clerk to insert the words into the Journal from my floor speech yesterday. Thank you," and the Chair "so ordered." (By reference only.)

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Lowen rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ilagan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Holt rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting in opposition to this bill because I believe it is unnecessary. The nature of the lieutenant governor's role is different from the governor. The lieutenant governor has few official duties to perform except to take over when the governor is not able to carry out the duties of the office. For example, this occurs each time the governor leaves the state.

"If we look at the Legislature, many of us would have a problem if we were prohibited from having outside employment. Although, the work of a legislator is part time and paid in this manner, the work continues throughout the year. After the legislative session ends, we do not stop serving our constituents, or attending legislative events, or maintaining an office year-round. *Mahalo.*"

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and H.B. No. 1075, entitled: "A BILL FOR AN ACT RELATING TO EMOLUMENTS," passed Third Reading by a vote of 43 ayes to 7 noes, with Representatives Gates, Holt, Ilagan, LoPresti, Lowen, Matsumoto, Quinlan, and Todd voting aye with reservations, with Representatives DeCoite, Har, Kong, McDermott, Okimoto, Tokioka, and Ward voting no, and with Representative McKelvey being excused.

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support on House Bill 1339 and my comments should be brief. This measure takes some explanation because I think, for me, this is an important measure for us to outline for future legislators the processes and roles and responsibilities that they may have to engage in in the event that impeachment becomes a necessity.

"What we learned during the pandemic and in recent times, even with the concern around Mauna Kea, is that our constitutional provision for impeachment may not be self-executing. Of the 50 states, we are the only state that has, in our constitution, the language that our impeachment statute be for causes that may be provided by law. With the absence of a measure like this leaves future legislators without a roadmap, and that's what this bill does. This bill provides grounds for impeachment that are found in the US Constitution and other state laws across the nation.

"I hope that this measure gets full consideration as it continues to move through the process because we should not be left floundering in the event that impeachment becomes a necessity that this body, this co-equal branch of government, must exercise. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and H.B. No. 1339, entitled: "A BILL FOR AN ACT RELATING TO IMPEACHMENT," passed Third Reading by a vote of 46 ayes to 4 noes, with Representatives DeCoite, Har, Tokioka, and Ward voting no, and with Representative McKelvey being excused.

Due to the pandemic, the bill was not able to be heard in the House. The bill is back again this year and will be crossing over from the Senate, and it is my hope that we can pass this bill as a tribute to Uncle Boogie and all of the residents past and present of Kalaupapa.

"Mr. Speaker, in 2012 Uncle Boogie was asked to write an introduction to a book about Kalaupapa, and at the end of the introduction he wrote, to all of our people, you will always be remembered. You are the pillars and icons of times past. This book is a tribute to you. Your stories are of solitude, passion, and grace, and may your legacy live on with *aloha*.

"Mr. Speaker, Uncle Boogie is one of the icons he wrote about, and the people of Kalaupapa, Molokai, District 13 and the State of Hawaii are better because of his legacy and his *aloha*. Mr. Speaker, at the appropriate time, I would like to ask for a moment of silence to honor Uncle Boogie of Kalaupapa. *Mahalo*."
