"In 2015, Corinthian Colleges, which included Heald College, declared bankruptcy after the federal Department of Education fined them \$30 million for 'overstating job placement rates.'

"Prior to its bankruptcy filings, Corinthian Colleges was under intense scrutiny for alleged predatory lending practices. According to one news story from KHON2 News, 'regulators claim the school preyed on low-income students, encouraged them to take out expensive loans and then used abusive tactics to collect repayment before the students graduated.'

"HB 389 does not 'discriminate' against for-profit institutions, but rather simply requires them to disclose that they are for profit to prospective students.

"HB 389 is intended to help protect prospective students at for-profit colleges from ever being in a position in which thousands of Heald Students found themselves: buried in debt with no degree or job prospects.

"Transparency is all this bill asks for. Any college not willing to take this simple declarative step likely isn't interested in full disclosure to their customers, their students. And that should worry all of us."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I've spoken a number of times regarding the stadium. This is again in opposition, because it's missing one thing, Mr. Speaker. And that is, as I've even had a floor amendment earlier, a floor amendment that says we should monetize the naming of the stadium. Mr. Speaker, we have a number of examples of that occurring. United Airlines Stadium, \$69 million for USC. University of Washington, \$41 million for a 10-year contract with Alaska Airlines. Colorado State, kind of like the size of our state and UH, \$38 million for a deal with a local credit union. Boise State, \$12.5 million.

"Mr. Speaker, we need to have taxpayers' money in mind. Even if we got \$5 million like they did at Stan Sheriff, UH got \$5 million from Bank of Hawaii. Mr. Speaker, I don't know why there's not more entrepreneurial thinking. It's time to, I think, think of taxpayers just other than some of the things that we have without thinking much other than bureaucracy.

"For those reasons, Mr. Speaker, we obviously need a new stadium. It's a money maker. And I know there's a great plan for it, but if we put up for naming rights, there would be at least 5, 10, 15, 20, sometimes multiple millions of dollars. We have to start thinking more entrepreneurial. We have a Department of Business and Economic Development that I understand has not put in one pro-business bill during the time when the businesses are suffering the most. So, Mr. Speaker, I'm surprised that I have to stand up and say, hey, let's get entrepreneurial, let's get some money to save taxpayers money.

"So with that, Mr. Speaker, it's a good bill except it's missing the most important thing and that is to bail out the taxpayers for at least \$5 to \$20 to \$30 million of which we could use by having naming rights at the new stadium. For those reasons, Mr. Speaker, I will keep continually pushing for entrepreneurship, innovative, creative thinking, not bureaucratic thinking, the way it is in this bill. Thank you, Mr. Speaker."

Representative LoPresti rose to speak in opposition to the measure, stating:

"Mr. Speaker, thank you. No vote for me and comments, please. I'd like the comments from second reading inserted into the Journal as if they were my own this time around. And I just would reiterate, I'm opposed to this on many levels. The most important thing, in my opinion, that it's missing is the emergency laydown area and the designation for that in the case of natural or manmade disaster. Thank you," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1348, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE STADIUM DEVELOPMENT DISTRICT," passed Third Reading by a vote of 49 ayes to 2 noes, with Representatives LoPresti and Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 865) recommending that H.B. No. 1294, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1294, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Perruso rose to speak in opposition to the measure, stating:

"I stand in opposition to this measure because I think that it's premature. We are in the first year of implementation of a brand-new special educations pupil allocation formula, and there are also administrative mechanisms designed to address the issue that was brought forward by DreamHouse. So, for those reasons, I stand in opposition."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1294, HD 2, entitled: "A BILL FOR AN ACT RELATING TO EDUCATION," passed Third Reading by a vote of 50 ayes to 1 no, with Representative Perruso voting no.

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1118, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CAMPAIGN SPENDING," passed Third Reading by a vote of 50 ayes to 1 no, with Representatives Kapela and Perruso voting aye with reservations, and with Representative Okimoto voting no.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 878) recommending that H.B. No. 686, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 686, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CRITICAL ELECTRICAL INFRASTRUCTURE," passed Third Reading by a vote of 46 ayes to 5 noes, with Representatives Eli, Ganaden, Kapela, D. Kobayashi, and Perruso voting no.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 882) recommending that H.B. No. 891, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 891, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Matsumoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in support with reservations.

"This bill seeks to regulate the sale and use of electric guns. I have reservations about this measure for the following reasons:

- 1. This measure imposes many regulations on a self-defense tool that is generally non-lethal. As Hawaii already has a multitude of restrictions for actual firearms, I struggle to find good reasons for Hawaii to impose just as aggressive regulations on generally non-lethal items meant for self defense of a scope far beneath that of regular firearms. With the regulations this bill currently proposes, including application, permit issuance, background check, and required training course, it would essentially prohibit the legal purchase of electric guns.
- 2. Moreover, the proposed procedure to regulate these electric guns (which include tasers) are set to overload the already-struggling police department, as the Honolulu Police Department has previously stated they are already inundated with requests for traditional firearms permits.
- 3. In addition, I fail to see why this level of restrictions are necessary, when one can purchase an electric gun through Amazon in most other states. Hawaii is one of two states in the country that ban ownership of such electric guns.

"While there are many other reasons and further explanations that I will not address here, overall I find this measure concerning in that the proposed regulations seem to go above and beyond what is necessary and reasonable for the population to safely acquire and use electric guns. Thank you, Mr. Speaker."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 891, HD 2, entitled: "A BILL FOR AN ACT RELATING TO ELECTRIC GUNS," passed Third Reading by a vote of 45 ayes to 6 noes, with Representatives Matsumoto and Ward voting aye with reservations, and with Representatives DeCoite, Har, Kong, McDermott, Okimoto, and Tokioka voting no.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 884) recommending that H.B. No. 1246, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1246, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Kapela rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1246, HD 2, entitled: "A BILL FOR AN ACT RELATING TO FIREWORKS," passed Third Reading by a vote of 45 ayes to 6 noes, with Representatives Kapela and Ward voting aye with reservations, and with Representatives DeCoite, D. Kobayashi, McDermott, McKelvey, Okimoto, and Tokioka voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 885) recommending that H.B. No. 446, HD 2, as amended in HD 3, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 446, HD 3 pass Third Reading, seconded by Representative Morikawa.

Representative Sayama rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker, brief comments. First, I'd like to thank the chairs as well as the members of the committees that have passed this really important bill. This measure would provide really critical regulatory safeguards to protect Hawaii's families from catalytic converter thefts that have been going throughout this pandemic. Families really depend on their vehicles to get to work, to drive their kids to school, and to conduct their daily business. And I'm really happy and grateful that members of this

House have passed this measure expediently, and I look forward to working with the Senate as well as HPD to ensure the proper administration and enforcement of this measure. Thank you, Mr. Speaker."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, strong support and congratulations to the new Representative from Palolo who has kind of sent out the warning to all of us who either buy or have already bought a Prius, Mr. Speaker, not mentioning yours, and others that are targeted for these catalytic converters. So, let us be on our alert for not only the ones that are electric but also the ones that are half electric and half gas. So again, accommodations to the young man from Palolo. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 446, HD 3, entitled: "A BILL FOR AN ACT RELATING TO MOTOR VEHICLES," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 889) recommending that H.B. No. 73, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 73, HD 2, entitled: "A BILL FOR AN ACT RELATING TO EMERGENCY WORKERS," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 890) recommending that H.B. No. 529, as amended in HD 1, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 529, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kapela rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative McKelvey rose to speak in support of the measure with reservations, stating:

"On SCR 890, please withdraw my green slip and enter aye with reservations and comments to the Journal."

Representative McKelvey's written remarks are as follows:

"Mr. Speaker, I stand with reservations to HB 529, HD 1. While this measure may work for Honolulu County, it may not work for other counties. For instance, in Maui County, similar functions are split between the planning and public works departments. Additionally, this could be used as a means to foreclose on people for numerous zoning infractions which would normally not rise to that level."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 529, HD 1, entitled: "A BILL FOR AN ACT RELATING TO RESIDENTIAL REAL PROPERTY," passed Third Reading by a vote of 49 ayes to 2 noes, with Representatives Kapela, Matsumoto, McKelvey, Perruso, and Ward voting aye with reservations, and with Representatives McDermott and Okimoto voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 892) recommending that H.B. No. 662, as amended in HD 1, pass Third Reading.

No. 884, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE OFFICE OF INFORMATION PRACTICES," passed Third Reading by a vote of 48 ayes to 3 noes, with Representatives Kapela, Perruso, and Tam voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 895) recommending that H.B. No. 1090, as amended in HD 1, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1090, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CHILD PASSENGER RESTRAINTS," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 896) recommending that H.B. No. 1096, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1096, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative McDermott rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McDermott's written remarks are as follows:

"I don't object to the contents or basic intent of this bill. I object to the tone and patronizing language contained in the introductory premise of the legislation, specifically where it cites 'to update existing parentage laws that reflect outdated, cisheteronormative concepts of families, parenthood, and parental rights.' I find it personally insulting. Setting aside the tortured terminology, I doubt that the Legislature wants to assert that the traditional views of Buddhists, Muslims, Hindus, Christians, Jews, or other people of faith, are no longer valid or relevant when it comes to parenting or family formation. Often our job as legislators is to amend laws or provide corrective measures reflecting changes in technology, the economy or society at-large. In this case, there are good arguments for the proposed task force to study revisions to the Hawaii statutes. Yet this legislation should not require that we insult our fellow citizens by diminishing their values."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1096, HD 2, entitled: "A BILL FOR AN ACT RELATING TO PARENTAGE," passed Third Reading by a vote of 50 ayes to 1 no, with Representatives Matsumoto and Okimoto voting aye with reservations, and with Representative McDermott voting no.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 900) recommending that H.B. No. 490, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 490, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CRIMES AGAINST SENIORS," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 903) recommending that H.B. No. 476, HD 2, as amended in HD 3, pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 927) recommending that H.B. No. 80, HD 1 pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 928) recommending that H.B. No. 131, HD 1 pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 940) recommending that H.B. No. 1184, HD 1 pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 902) recommending that H.B. No. 474, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 474, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE HOSPITAL SUSTAINABILITY PROGRAM," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Nakashima, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 910) recommending that H.B. No. 576, HD 2, as amended in HD 3, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 576, HD 3 pass Third Reading, seconded by Representative Morikawa.

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Kitagawa rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative McDermott rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition, just a few brief comments. Mr. Speaker, I came here in '96, my first time here. And I've seen things that we do usually is to ensure more regulation, ensure a greater education, ensure a greater degree of safety for the licensed professionals who come before us and who the public is exposed to.

"This is the first time I've seen us take a step backwards, in my view, lowering the requirements for an invasive surgical procedure. As you can see, this thing on my hand here, I had surgery two weeks ago. I had two doctors, an anesthesiologist and an orthopedic surgeon, just to fix my finger. So I look at this and say, wait a minute, I wouldn't feel safe allowing my daughter to have an abortion under these circumstances. I mean, I'm pro-life to begin with, obviously, I'm not going to change anybody's mind here. But why would we lower the safety threshold, why would we lower the education that's required? Well, I know there's arguments why they do that, but I just don't think it's the right thing to do. And comments in the Journal too, please."

Representative McDermott's written remarks are as follows:

"I find this legislation deeply flawed. It is nothing more than a political gesture on behalf of those who want abortions at any and all times. It actually lowers the medical expertise and requirements for those who would perform this invasive surgical procedure. These abortions referenced in the bill are not the equivalent of the 'morning after pill type,' rather they are, depending on the level of potential complications, done in a clinic and constitute a serious, invasive medical operation. Bill Clinton once declared that abortion should be safe, legal, and rare. Simply put, by lowering professional standards this bill would make it less safe and more common."

Representative Okimoto rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in strong opposition. I am unapologetically pro-life. To me and many others, there is no compromise to the life of a child. This is not a stance I take lightly. This is a conviction to protect life, and one that is under constant attack. The pro-life, pro-choice debate has been around longer than I've been alive and has been debated *ad nauseam*. At the end of the day, this body is making a value judgement as a society, both as Americans and as citizens of Hawaii.

"For the women legislators, we make value judgements based on our own experiences and what is important to us as women. Women are not monolithic and shouldn't be chastised for speaking their truth and voting on their convictions.

"For me, I'm a woman who was born and raised on the island of Kauai. My biological grandmother was faced with a similar decision that many women face in their lives. Do I keep this child inside of me or do I terminate it? This is one of the most difficult decisions we may make as women, no matter our background. In my case, my biological grandmother chose to keep her future daughter and put her up for adoption. Had she made a different decision, Mr. Speaker, I would not have the privilege of addressing you and this body today.

"Mr. Speaker, we may hear heartfelt speeches on each side, heart breaking stories of women who have struggled through the difficult choice of terminating their pregnancy and those who made the difficult choice of keeping their child in less than ideal circumstances. We may debate the technicalities of whether APRNs should have the authority to perform aspiration abortions, but for me the choice is as simple as life and death. I am a mother of two beautiful daughters, and I work diligently to instill the

same values to them that made me who I am today. These values are the reason for my opposition.

"From the beginning, the pro-life movement has been about assisting women in crisis pregnancies. The movement that launched crisis pregnancy centers, the Sisters of Life and so many other organizations, to help house, feed, clothe, and care for expecting mothers, has always viewed motherhood as vastly superior to abortion. While I completely understand the arguments from my colleagues about the access to care in our rural areas and on our neighbor islands, I urge us to consider expanding access to contraceptives instead of expanding access to the brutal nature of procedures such as aspirational abortions.

"Mr. Speaker, as you might know, we celebrated, just yesterday, International Women's Day. Women such as Harriet Tubman, Amelia Earhart, Mother Teresa, Susan B. Anthony, and countless others who have paved the way for myself and my fellow 13 fellow female Legislators to sit on this floor today. These pioneers have come from all walks of life and have had deeply held convictions all across the political spectrum. At the end of the day, we as a body are making a value judgement on behalf of our residents. Today, I am choosing to stand with women who stand for life. Thank you, Mr. Speaker."

Representative Tokioka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ichiyama rose to speak in support of the measure, stating:

"Mr. Speaker, in support. I want to clarify some of the statements that were made by prior speakers. First and foremost, this bill does not authorize APRNs to perform surgery. APRNs are not trained to perform surgery and none of them want to do surgery. I think that point should be made very clear here.

"What this bill allows is to allow APRNs to practice to the top of their training and their scope, as this body has done numerous times over the past years. This bill would allow APRNs to prescribe a medication that can terminate pregnancy up to nine weeks, and APRNs already have prescriptive authority for a wide range of other drugs.

"It would also allow APRNs to perform aspiration abortions, which is not surgery. It is a procedure that's performed in an office. Under this bill, that requirement remains, it must be performed in an office. And it is a simple procedure that takes five to ten minutes, it uses vacuum suction. It is very similar to a procedure that APRNs already do called an endometrial biopsy, where they use vacuum suction to remove the lining of the uterus so that a sample can be taken and tested.

"We heard numerous testimonies from doctors, from OBGYNs. In fact, the Hawaii Chapter of the American College of Obstetricians and Gynecologists came out in strong support of this measure, and they are the women's health professionals who are trained in this area, who specialize in this area, who perform these procedures. And they resoundingly, unanimously said that it is safe for APRNs to perform this procedure, that they can be trained and practice to the top of their scope.

"I also want to note, in the larger discussion about the scope of practice for APRNs and other medical professionals that this body has considered in the past, and sometimes what gets lost is the discussion about the cost of health care, Mr. Speaker. We are facing skyrocketing costs in health care, and by allowing well-trained professionals to practice to the top of their scope helps reduce those overall costs for us.

"But I don't want to miss the larger point of this legislation and why I'm in support. It's about access, Mr. Speaker. Prior to the pandemic, access on the neighbor islands to abortion care was severely restricted. And during the pandemic, Mr. Speaker, that situation only got worse. For example, Planned Parenthood currently flies over doctors to Maui County to provide care two days a month. They had to suspend that during the very darkest days of our lockdown, because it wasn't safe for the doctors to travel. And that meant that women in Maui County had no access, Mr. Speaker, because of the unique situation caused by the lockdown.

"In essence, when we legalized abortion in this state, which has been the law of this state for the past 50 years, but by limiting it to physicians only, we've created a Dutch door. And Mr. Speaker, this bill addresses that

situation and ensures that no matter where somebody lives in this state, that they can have access to this critical health care. Permission to insert further comments to the Journal. Thank you, Mr. Speaker."

Representative Ichiyama's written remarks are as follows:

"Thank you, Mr. Speaker, for the opportunity to submit additional written remarks in support of HB 576, HD 3. I wanted to add in the record my appreciation to House leadership, especially to the Speaker and Majority Leader, for their support of this bill. I would also like to acknowledge the hard work of the respective Chairs of the Committee on Health, Human Services and Homelessness, Committee on Consumer Protection and Commerce and Committee on Judiciary and Hawaiian Affairs. Each of these chairs helped to improve this bill as it moved through the legislative process. I sincerely believe that it takes a lot of teamwork to move a bill forward, and this one was no exception. Thank you all very much."

Representative Onishi rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support and I'd like to have the words from the Chair for PDP entered as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Onishi continued, stating:

"Mr. Speaker, I'm unapologetically pro-choice. As a father of three daughters and the grandfather of two granddaughters, I am fully supportive of their choice to decide what happens to their bodies. I also represent a very rural district, as the previous speaker has indicated, has had challenges with medical services during this pandemic.

"This bill allows for certain procedures to be done by advanced practice registered nurses who have been trained and fully licensed to do these procedures. I don't believe that there is a health risk under these circumstances and, again, it's very important that my daughters and my granddaughters are able to make the choices that they want to make and not the government. Thank you."

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. Requesting that the words of the Chair of PDP be entered as my own. Further, Mr. Speaker, this is of great importance to my community. Health care and women's right to choose constantly comes up for members of my community that go to church often and consider this as a part of their faith in discussion. I rise in strong support as a member of this body with a Y chromosome. Thank you," and the Chair "so ordered." (By reference only.)

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I rise in opposition. There are some of us who believe that life begins at conception. And it's all about life, liberty, the pursuit of happiness. And, Mr. Speaker, life doesn't belong in a vacuum cleaner. Thank you."

Representative Marten rose to speak in support of the measure, stating:

"I rise in strong support and would like to have the words of the Representative from Salt Lake entered as my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative DeCoite rose to speak in support of the measure, stating:

"In strong support. I'd like the words of the Chair of PDP be inserted into the Journal as if it was my own. Talk about rural, I think I represent the most rural district separated by water of three different islands. As we saw many people that tried to come down and get services that were not provided on Molokai, Hana, and Lanai, we know that it became a huge challenge, so I appreciate the fact that this bill allows us to have those choices and allows us to have resources available for young women that need guidance and support along with those services. And then I wish to insert comments into the Journal. Thank you," and the Chair "so ordered." (By reference only.)

Representative DeCoite's written remarks are as follows:

"I am voting in support of this bill because it will have a positive impact on women in rural and medically underserved communities in our state. My rural district is one of those whose communities will benefit from this bill. Many of my constituents need to travel or fly to Maui or Oahu to get the health care they need. This bill will help provide the access to the health care we need in our communities. *Mahalo*."

Representative Kapela rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support and I would also like to have the words from the Representative from Salt Lake inserted into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Kapela continued, stating:

"Another brief comment on top of that, today we've heard from a number of different representatives about being pro-life or pro-choice. And one thing that I want people to also realize is that we have to take into consideration the life of the mother. I have a very dear friend that would not be alive if she did not have access to an abortion. We have to think about those people as well. We have to think about young women who have been raped. We have to think about young women who have had so many different pains thrown at them and something like this being just one more obstacle. And whether or not we choose to keep a child or to terminate for our own choices, we have to be able to have that choice. And we have to be able to have access to that choice. And I think it's our job as legislators to provide possibility, to provide support, to provide options, and not to provide barriers or hate towards those women or towards those individuals.

"And I also want to say, I think that we also need to think about the many women, as it was International Women's Day yesterday, the many women whose names are not highlighted, whose names may never be known, because they didn't have access to a choice, to choose what to do with their own body. So, thank you."

Representative Nakamura rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, may I ask that the words of the Chair of PDP be entered into the Journal as my very own," and the Chair "so ordered." (By reference only.)

Representative Nakamura continued, stating:

"Representing the island of Kauai, access to this type of care is not available. Women will have to pay for travel, sometimes overnight expenses, lodging, and so forth. This is something that's needed for many neighbor island rural communities.

"I also feel that APRNs have been given, via state policy, the authority to act in many ways as a primary care provider. They're permitted to evaluate patients, order and interpret diagnostic tests, they're able to prescribe treatments and medications. Mr. Speaker, they already provide a wide range of services. APRNs administer anesthesia during surgeries and manage chronic conditions like hypertension and diabetes, to provide gynecological care and family planning services. So, for these reasons, in strong support. Thank you."

Representative Wildberger rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, brief comment. I'd also like the words from the Chair of the PDP Committee inserted into the Journal as if they were my own and additional brief comment. I'd also like to show my appreciation for the Representative from Mililani highlighting that contraception is also very important in access. During the Trump administration, Hawaii lost \$2 million in funding for family planning, and access to contraception and disease treatment was eliminated for many low-income people, especially on the neighbor islands. And when you don't have access to contraception, unintended pregnancies are a result, so thank you," and the Chair "so ordered." (By reference only.)

Representative Takumi rose to speak in support of the measure, stating:

"In support, Mr. Speaker. I'd just like to address the comments made by my good friend, the Representative from Ewa Beach, regarding the seems to be watering down our standards and widening the scope of practice for professionals that heretofore did not have that. I don't recall if he was here in 2015 when we enabled physician's assistants to have full prescriptive authority, joining 40 other states that allow that. We've also widened the

scope of practice for optometrists, relative to ophthalmologists. And we've obviously had very robust discussions, still didn't happen, but robust discussions as to whether or not psychologists should have prescriptive authority. So, this is nothing new. Thank you."

Representative Okimoto rose to respond, stating:

"Thank you, Mr. Speaker. Still in opposition. I just would like to clarify that being pro-life has and will never propagate hatred towards anyone. Thank you, Mr. Speaker."

Representative Tam rose in support of the measure and asked that the remarks of Representative Ichiyama be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative LoPresti rose in support of the measure and asked that the remarks of Representative Ichiyama be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Perruso rose in support of the measure and asked that the remarks of Representative Ichiyama be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Matsumoto rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. I rise in opposition. If I could also have permission to insert written comments into Journal. I wasn't going to speak, but I thought I'd just say a few words. I often look at this issue from a bit of a different lens. And as we move forward looking at different pieces of legislation, and I know we're working on some of these issues, but I'd like to make the point that I feel women's need for equality is not necessarily increased access to abortion, but to be given what they need to survive financially and socially as mothers.

"And to me, that means inexpensive and readily available child care. It's a workplace that provides for the needs of the mother, whether that's flexible scheduling, maternity leave, paid family leave, telework, and state support to really help reintegrate women back into the workplace. And I felt like that was a lens that needed to be shared, and something like I said I know we working on, but we need to be working on it much more in order to provide women, not telling them that they only have one option but that there are so many options for them to succeed both in their careers or in school as well as being a mother. Thank you, Mr. Speaker."

Representative Matsumoto's written remarks are as follows:

"Thank you, Mr. Speaker. I rise in opposition.

"This measure seeks to allow registered nurses to perform aspiration abortions. There has been a longstanding debate between those who view abortion as an issue of a woman's right to her own body, and those who view it as an issue of life for the unborn. Some in this legislative body have framed this issue, and the bill in which this issue is packaged, in terms of 'health care' and advocating for access to this 'health care' across every island in the state. While I understand this perspective, I personally take a different view of the issue of abortion, this framing of abortion as 'health care,' and the greater overall issue of how the state can support women holistically.

"Oftentimes we hear of the abortion issue as a binary choice: either be a mother and leave the workforce or path of education, or have an abortion and continue either working or studying. I believe this is the critical aspect that must be addressed: women are not confined to this 'either/or' situation. We can be both mothers and professionals in the workplace. I know many working mothers who not only are competent and highly achieving professionals in their respective industries, but are also caring, nurturing mothers who maintain healthy familial relationships. If the state is going to be pro-women and claim to support women, then the state should reflect on what it actually means to support women.

"Supporting women is implementing flexible work schedules and telework opportunities so that women can choose a routine that best suits her work and her child-raising approach. Supporting women is having affordable and flexible childcare options that allow for mothers seeking further education to arrange their optimal daily schedule. Supporting women is allowing for maternity and paternity leave, allowing a family to assess all

their options and decide what arrangement is best suited for their particular familial habits and preferences. It can be argued that providing greater access to abortion does not liberate women, but instead makes it acceptable for society to not support women in all areas of their life. Thank you, Mr. Speaker."

Representative Lowen rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. I'd like to adopt the words of the Representative from Moanalua. I'm also unapologetically pro-choice. But I will point out, this bill is about equity for rural areas and access to health care and access to a procedure that is legal in the State of Hawaii. And that's not what we're here debating today, this is about providing access particularly for rural areas that are underserved," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 576, HD 3, entitled: "A BILL FOR AN ACT RELATING TO HEALTH CARE," passed Third Reading by a vote of 42 ayes to 9 noes, with Representatives Kitagawa, Quinlan, and Tokioka voting aye with reservations, and with Representatives Aquino, Cullen, Eli, Har, Kong, Matsumoto, McDermott, Okimoto, and Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 913) recommending that H.B. No. 290, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 290, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Tokioka rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition, I'll make this as short as I can. I understand and I respect the introducer and the author of the bill, but to look at the many difficult choices that we have to make because of the budget restraints that is in front of us, this, in my opinion, shouldn't be one of them.

"On this very same floor, under the guidance of former Representatives Ito and Takai, we did the ceremony for the fallen soldiers. And I think everyone who was here at that time was extremely proud of being an American, being a part of this body, and being able to support the men and women who lost their lives fighting for this country. And it was right here, on our own floor.

"So, to do this, the emails that I got from my veterans and people on Kauai were very, very disappointed to see what was happening. And I again say that I understand the budget constraints, but it just takes away a lot of what we have already done to honor our veterans and our soldiers. We hear stories from General Hara of the things that he dealt with in Afghanistan, and many others who come back, too, that have fought wars and supported their country.

"So, for those reasons and many others, Mr. Speaker, I'm in opposition and I, again, hope that everyone who introduced this or had a part of this understands why I'm saying what I say. Because those days when we did have those ceremonies, I'm sure everyone who was here had tears, especially the first time that it happened. So, thank you for this opportunity."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. Believe it or not, Mr. Speaker, there used to be a veterans caucus in the House of Representatives. Some of us were active, some were inactive, so it's inactive. But on the basis of that, we've spoken of the veterans in the State of Hawaii. So, on that basis, I would say this misplaced savings, if there is savings, in effect, I think it puts the Legislature in a bad light vis-à-vis the fact that we are the highest per capita veteran state in the nation. And for those reasons, Mr. Speaker, I also ask that the gentleman from Kauai's comments be inserted into the Journal as my own. And if we want to be fiscally responsible, I think we should take it out on a different tact and a different way of doing it than this one. Thank you, Mr. Speaker," and the Chair "so ordered." (By reference only.)

Representative Tam rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I believe that I speak for everyone when I say that we have the deepest appreciation for our men and women in uniform, and this bill is not an attack on them, nor is it to undermine their work. The purpose of this bill is to ensure that the Hawaii Department of Transportation is properly funded so that the people of Hawaii, including the military, can drive on the best roads we can offer.

"According to the testimony offered by the Hawaii Appleseed Center for Law and Economic Justice, the total amount of transportation funding gained by this bill could result in \$2 million to \$9 million each year. The Department of Transportation has seen a large reduction of funds since the result of COVID-19. Less people are driving, so less fuel tax money is coming in. Less planes are landing, meaning less landing fees. Less harbor fees because no cruise ships are coming in. All this, while our infrastructure continues to crumble because of the heavy rains that we are seeing right now. By passing this bill, we will provide some much needed funding to our roads so the Legislature can avoid raising fuel taxes on everyone else.

"The Tax Foundation also mentioned in their testimony that exemptions on an individual's age or status is technically poor tax policy. It results in a large reduction of funds, and often times those funds are picked up by everyone else. So, while a military member will have some relief because of the exemption, a single mother making minimum wage would have their taxes raised in order to make up for the lost revenue.

"I would also like to point out that this bill is about Section 249-6.5 of the Hawaii Revised Statutes and it does not include our veterans. Our veterans currently right now are not exempt, meaning they pay the vehicle weight tax. So, for these reasons, I'm in support of the bill."

Representative McDermott rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. Mr. Speaker, have you ever spent Christmas halfway around the world in sand up to your butt and you're by yourself? Well, that's what these kids do. And while they're here, while they're deployed, we're going to tell them, you know what, instead of paying the reduced rate, you're going to pay the full freight, because that's the least we can do for you.

"Mr. Speaker, I don't believe this thing is going to become law, to be quite frank with you. If it passes the House and goes to the Senate, I'm pretty sure the governor will get a call to at least to veto it from the PACOM Indo-Pacific Command up there, because this is a real slap in the face to the one industry that we have going right now that supports us. So, I just think it's bad. Thank you, Mr. Speaker."

Representative Perruso rose to speak in support of the measure, stating:

"I rise in strong support. I support this measure on the basis of equity. I'm sure that most members of the House are aware that active service members do not generally, by and large, pay income taxes in the State of Hawaii because, if they declare residency in another state in which they do not have to pay income tax, they are able to not pay income tax at all. So, most military members do that. And I want to say that this is one small way we're giving them an opportunity, one small way in which they can contribute to the common good and support our community, support our public schools, support our public tax base. *Mahalo*."

Representative Ward rose to respond, stating:

"Mr. Speaker, second time in opposition. Two factors, Mr. Speaker. We have two golden goose economic drivers. One is tourism and one is federal spending. This gets to the heart of federal spending and it kind of nibbles a bit away from that, Mr. Speaker. Also, people who are pleading for the potholes to be filled, please understand that in the history of this body, some 10 years ago, we raided the pothole fund. We took the money, we used it in the general fund, and we have never recovered since then. So, this body is directly responsible for why we have these kind of grabs for money for even our veterans and our military people, who are heretofore exempt. So please know historically, we are part of the culpability of why we have a problem with our roads. Thank you, Mr. Speaker."

Representative Aquino rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose to speak in opposition to the measure, stating:

"Opposition, Mr. Speaker, and I would like to adopt the words of the Representative from Kauai as if they were my own, and just a brief comment. If this is a little of what our veterans have to sacrifice, they are front line, when we sacrifice our families and go to war and defend our country. I would think that if this is such a little contribution to be made back to the State of Hawaii in funds, I would think that it should be a give at this point. And that's why I'm in strong opposition, Mr. Speaker, thank you," and the Chair "so ordered." (By reference only.)

Representative Tam rose to respond, stating:

"Mr. Speaker, in support and I just want to reiterate that this is not about veterans. Veterans pay the vehicle weight tax, so I would advise members to not reference veterans at all, as it does a disservice to them. I'd also like to remind the Minority Leader Emeritus that in 2017 to 2018, the Department of Transportation repaved Kalanianaole Highway, and that benefits a lot of Hawaii Kai residents living in Hawaii Kai and working in town."

Representative Tokioka rose to respond, stating:

"Second time in opposition. I realize that this bill doesn't affect veterans, and I was referring to the people that were contacting me who were veterans. And whenever a bill like this comes up, its mainly the veterans that call my office or call me. Thank you."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative McDermott rose in opposition to the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative McDermott's written remarks are as follows:

"This bill to repeal the vehicle weight tax exemption is both shortsighted and petty, as well as an insult to both our active duty military and members of our Hawaii National Guard. We should remember that it was our late Congressman and former House colleague, Mark Takai, who was the original champion of providing this exemption. It is not only a practical gesture of recognition for our servicemen and servicewomen but, as Major General Hara, director of the Hawaii Emergency Management Agency and homeland security advisor points out, an important tool in recruiting and retaining Hawaii Air and Army National Guard members. We can honor those who continue to serve by rejecting this ill-conceived legislation."

Representative Har rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition, brief comment. First, may I please adopt the words of the Representative from Lihue into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Har continued, stating:

"Secondly, Mr. Speaker, I do very much appreciate the comments made by the introducer of this bill and his passion. I think I'd take a different perspective, because in 2008 I was the vice chair of the then committee that was called Public Safety & Military Affairs. And it was then the chair, Representative Cindy Evans, and myself who introduced this bill on behalf of our former colleague Representative Mark Takai.

"And this bill actually started off as an exemption for any active national guardsman or woman would be able to get one vehicle registration fee waived. And it became, when we looked at the amount of money that it would affect the state highway fund, we then decided to somewhat morph it throughout the process and it became one vehicle for an active national guardsman or woman for one vehicle in their family.

"And you have to understand at that time, that was when we were at active war in Iraq and in Afghanistan, and many of our local men and women who are active national guardsmen and women were deployed. And so Representative Takai had come to Representative Evans and myself and said, this is the right thing to do.

"And so, while all of you may have a different perspective, for which I very much appreciate, this is a very personal bill for me because our former Congressman Mark Takai, who was many of our friends, this is a personal bill he asked for us to pass because of what we were going through at that time. For those reasons, Mr. Speaker, I remain in strong opposition to this measure. Thank you."

Representative Ohno rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. While I've also had the honor of sitting through the very emotional and honorable floor presentations honoring our service members, I've also had the honor of serving with one of our former colleagues, former Congressman and former House member Takai, it is a painful measure that I do put forward in support.

"The reason why, very quickly, is just I think the circumstances of this year and the circumstances that face our state departments and many of our public employee friends are very dire. As a result, I don't believe this bill would have much of a shot a year ago and I don't think this bill will have much of a shot in a couple of years. But I just want to remind you and the members, the circumstances in which we're under are very unique and I think this bill deserves consideration. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 290, HD 2, entitled: "A BILL FOR AN ACT RELATING TO VEHICLE WEIGHT TAXES," passed Third Reading by a vote of 39 ayes to 12 noes, with Representatives Aquino and Matsumoto voting aye with reservations, and with Representatives Branco, DeCoite, Eli, Har, Ilagan, Kong, McDermott, Okimoto, Tokioka, Ward, Woodson, and Yamane voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 914) recommending that H.B. No. 1352, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1352, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SURPLUS MILITARY LAND," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 916) recommending that H.B. No. 11, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 11, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 11, HD 1, entitled: "A BILL FOR AN ACT RELATING TO EDUCATION," passed Third Reading by a vote of 50 ayes to 1 no, with Representatives Matsumoto and Okimoto voting aye with reservations, and with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 917) recommending that H.B. No. 225, HD 2 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 225, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose to speak in support of the measure with reservations, stating:

"Reservations please, brief comment. I'd just like to say, I appreciate the intent of this bill, Mr. Speaker, as all of our *keiki* should feel safe at school. However, as stated in the testimony from the Department of Education, these rules already exist, thus making this measure duplicative. If codified into law, my concern is that it also runs the risk of hamstringing the DOE

from making changes to the definitions of the terms bullying, cyberbullying, and harassment when deemed necessary. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 225, HD 2, entitled: "A BILL FOR AN ACT RELATING TO BULLYING," passed Third Reading by a vote of 51 ayes, with Representative Okimoto voting aye with reservations.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 920) recommending that H.B. No. 558, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 558, HD 2, entitled: "A BILL FOR AN ACT RELATING TO CLEAN ENERGY FINANCING," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 922) recommending that H.B. No. 327, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 327, HD 2, entitled: "A BILL FOR AN ACT RELATING TO GREENHOUSE GAS EMISSIONS," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 923) recommending that H.B. No. 803, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 803, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTRIC VEHICLES," passed Third Reading by a vote of 48 ayes to 3 noes, with Representatives Kong, McDermott, and Okimoto voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 924) recommending that H.B. No. 1092, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1092, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CARBON OFFSETS," passed Third Reading by a vote of 49 ayes to 2 noes, with Representatives McDermott and Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 925) recommending that H.B. No. 331, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 331, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE PLAN," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 926) recommending that H.B. No. 882, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 882, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PROCUREMENT," passed Third Reading by a vote of 51 ayes.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 931) recommending that H.B. No. 160, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 160, HD 1, entitled: "A BILL FOR AN ACT RELATING TO REGISTRATION OF VEHICLES," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 932) recommending that H.B. No. 161, HD 2 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 161, HD 2, entitled: "A BILL FOR AN ACT RELATING TO REGISTRATION OF VEHICLES," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 936) recommending that H.B. No. 683, HD 1, as amended in HD 2, pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 683, HD 2, entitled: "A BILL FOR AN ACT RELATING TO SUSTAINABLE AVIATION FUEL," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 937) recommending that H.B. No. 862, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 862, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose to speak in support of the measure with reservations, stating:

"With reservations, Mr. Speaker, and a brief comment. There is a similar Senate version of this bill that establishes the Office of Aerospace Development in the Hawaii Technology Development Corporation instead of abolishing the OAD completely, which allows us to continue discussions and methods of diversifying our economy through the aerospace sector. Thank you, Mr. Speaker."

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, in strong opposition. Notwithstanding what the Senate may be doing, I think we're taking a step backward by doing this, Mr. Speaker. I earlier spoke on the need for the State of Hawaii to get more creative, innovative, more entrepreneurial. Well, this takes a giant leap backwards because it takes away basically what's on the forefront of technology and aerospace.

"All of you do Amazon. Well, your delivery is going to be by a UAV, which we now are opting out of in this particular bill. We are basically canceling all the legislation we did to create keeping up with the rest of America for aerospace and for high technology.

"I think it's rather shameful to know that we have the most strategic position for aerospace tourism, we have the most strategic position for shooting of a breadbasket or how would you say, satellites that are as small as a loaf of bread. We have undermined this by saying, well we don't want anything to do with it.

"Now, I know, and I'm also grateful to the Chair of Finance who said, we are not really getting rid of all of it, we are putting it into the University of Hawaii Hilo. Which is good. We have PISCES. PISCES is the Pacific islands space center *et cetera*, but it's still not the same as the Office of Aerospace Development to mainstream us into the 22nd century, 23rd and beyond.

"Mr. Speaker, as co-chair of the Small Business Caucus, I'm very disappointed that we are so anti, not antibusiness, we are so apathetic to entrepreneurial, creative, innovative things. And as I've said earlier, I'm really disappointed that our DBEDT, our engine of our economy, hasn't put in one pro-business bill in this session when the businesses are hurting the most.

"For those reasons, Mr. Speaker, I'm really sad by a bill like this. Hopefully something will happen with UH Hilo. But the fact is, they used to fly over Hawaii, and now with these other things that are going on, we are going to be a forgotten area in the Pacific because we haven't adjusted. We think that we're so smart, we live off of our good looks, but we're not

using our brains. We've got to get more entrepreneurial, we've got to get more creative, we've got to do it more innovative, and we've got to stop throwing things onto the wayside. Thank you, Mr. Speaker."

Representative Quinlan rose to speak in support of the measure, stating:

"In support, Mr. Speaker. There is just so much to unpack, so many inaccuracies in one long run-on sentence. How do we take a step back from nothing? The Office of Aerospace Development is defunct and has been defunct for quite some time. There is nobody working in there. And after 15 years of having OAD and having PISCES, funding these positions, funding their research, we have nothing to show for it. We have no projects, we have no space port, we're not testing any drones here. And that's not OAD's fault, necessarily, or the fault of PISCES, it's the result of a number of different factors. But I think to suggest that the mere existence of a few positions in a division of DBEDT would make or break the aerospace industry in Hawaii is disingenuous. Anyways, I don't want to get myself in trouble, that's it. Thanks, Mr. Speaker."

Representative Ward rose to respond, stating:

"Mr. Speaker, in opposition. For the good Representative from the North Shore, he also accusing me of what he himself, the reason why it never went anywhere, Mr. Speaker, is because we never funded it. We never funded the positions. That's number one. Literally, for the last 10 years. I mentioned Mr. Crisafulli who is very aggressively, very, very strongly mentioning that, if we're going to compete with the rest of the nation, we've got to put some skin in the game, is his term. So, we've never funded this, so it's kind of died from neglect.

"And number two, we never responded to the private sector gestures of Elon Musk and the other Virgin Galactic who wanted to come here, but we kind of played, as I said earlier, we live on our good looks, we don't use our brains. So, Mr. Speaker, this is a death of neglect, this is the death of bureaucratic nonsense, and from this body not picking it up and running with it and being creative and innovative, I put the onus of our unfortunately killing off of this, this is a job creator, now it's a job killer the way that this bill is fit. So, for those reasons, Mr. Speaker, I will remain in opposition."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. As the one who created PISCES, I feel I need to step up and say something. I stand in support of this measure. The OAD, Jim did a great job, he tried to use it as a way to bring minds from around the world to Hawaii to discuss things, to have conferences on aerospace. But there was a frustration, Mr. Speaker, of the private sector, that these meetings, while well intended, were just that, meetings, think groups, work tanks. No real projects were being engaged in. The opportunity of our location, of having an analogue center here in Hawaii, wasn't being realized, which is why we created PISCES.

"And the Chair of Finance, I thank her, cause all those years contrary, let the record reflect, she funded those positions and funded the programs, some of which include the basalt concrete project which was undergone in Hilo, as well as other projects which have brought the University of Hawaii and other universities to the Big Island to take advantage of these partnerships.

"You have to evolve, Mr. Speaker, to the 21st century, and PISCES was trying to do that. Jim did a great job, but even then, there was concern and issues from the private sector of the efficacy of OAD. To refocus this back into PISCES and back into the University is a good thing in moving forward to try to really engage that private sector partnership for our strategic location.

"So, I want to thank both the Chair of Finance for her previous support, I also want to thank the Chair of Economic Development for continuing to demand results of these projects and programs. And so for that, I stand in support of the measure. Thank you."

Representative Quinlan rose to respond, stating:

"Thank you, Mr. Speaker. Still in support and may I have the words of the Chair of Government Reform entered into the record as if they were my own. And I'd just like to briefly point out that my colleague from Hawaii Kai often rails against bureaucracy in this chamber and at the same time speaks glowingly of the private sector, so it confuses me when in this case

his answer to our lack of an aerospace industry seems to be keeping more bureaucrats employed permanently. Thank you," and the Chair "so ordered." (By reference only.)

Representative Luke rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. One of the things I wanted to point out was that there was some incorrect statement about not funding Office of Aerospace. Even the position of the executive director has been funded and continues to be funded, which will be removed in this bill, only because the position has now been filled by the former Department of Labor director. And as soon as the former labor director became the head of Office of Aerospace, DBEDT quickly reassigned that individual to do workforce development.

"I think this is an example of legislative intent in trying to work with the administration and the executive to get progress in some of these economic efforts. But at some point in time after 10, 15 years, if the executive still continues to struggle, it is really the opportunity for the Legislature to reexamine, as opposed to continuing to fund a program that has really struggled and only has succeeded only on those parts like PISCES and unmanned aerial where the Legislature got involved. Other than that, other than going through NASA trade shows and other type of similar trade outfits, Office of Aerospace has not developed to the full potential that it could have.

"And this is an example of perhaps sometimes government should stay out of the way as opposed to trying to control every step of the way. What do we have as far as innovation and technology in this state? It really is in the University of Hawaii, and that's why we feel that maybe it is time, after giving DBEDT 15 years to succeed in this program, if they have not been able to do so, it is time for us to restructure and reexamine and have it be placed in an area where they can succeed as opposed to continuing to wish that this program will succeed under the executive where they have not really completely supported or envisioned the full potential. So, thank you very much."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 862, HD 2, entitled: "A BILL FOR AN ACT RELATING TO STATE GOVERNMENT," passed Third Reading by a vote of 50 ayes to 1 no, with Representative Okimoto voting aye with reservations, and with Representative Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 941) recommending that H.B. No. 1388, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1388, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support. Mr. Speaker, the original home mortgage interest deduction in the United States was created to incentivize home ownership. It has been twisted in years to allow for the rich to get richer and for the poor to become poorer. As it is currently structured, it increases inequality and contributes to housing unaffordability.

"I'd like to note for the members that the housing price of the average home here on Oahu is up 3% this year during the pandemic to \$814,000. In its testimony before the first committee, the Department of Transportation noted that an increase to the general fund, if we were to enact this bill, would be \$9.2 million. Noting the increase in housing here on the island of Oahu, I think that might be a bit conservative."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1388, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAXATION," passed Third Reading by a vote of 48 ayes to 3 noes, with Representatives McDermott, Okimoto, and Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 942) recommending that H.B. No. 1027, HD 1, as amended in HD 2, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1027, HD 2 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in opposition to the measure, stating:

"Mr. Speaker, I am in opposition. As the City & County administered Hanauma Bay, which all of us have been a visitor or a participant in, and the fee that they collect is what this bill is about, the MLCD.

"The bill is aimed specifically and only at Hanauma Bay, and its aim is to get the money from the city's Hanauma Bay fund to spend throughout the state instead of only at Hanauma Bay, and in violation of two federal court orders governing the use of the Hanauma Bay fund.

"Mr. Speaker, the bottom line is, this is a cash cow. The state has discovered it, the state works on the ocean side of it, the city runs it in the administrative land side. And because it has been so prosperous, and I know there is a grab for money wherever and however it can be found, but this is not the place. This is my district. This is a place that needs the money to keep it pristine, to keep it operational, to keep it as it is one of the gems of all of the world, if you will, to not only visitors, but to local people alike.

"And some people say, well the Friends of Hanauma Bay gave written testimony in the Finance Committee and they were all for it. Well, I just spoke to the president this morning, and she said the verbal testimony, she said, was to pull back that positive note on this bill, 1027, and to know negatively that now her eyes, the Hanauma Bay friends, have their eyes open and they know that this is bad because it's another grab for what otherwise is for the maintenance and the wellbeing of Hanauma Bay operationally.

"For those reasons, Mr. Speaker, please note that this is not a good bill, it's a step backwards, and it's a grab of money from my district. Thank you."

Representative Tarnas rose to speak in support of the measure, stating:

"Thank you, in support, brief comments. I just want to note for members that, in the Water & Land Committee we specifically amended the bill to address the concerns of the City & County of Honolulu to ensure that this would not be in conflict with the two court cases that the previous speaker referred to. And so, the measure, as amended, should be able to be adopted without any concern. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1027, HD 2, entitled: "A BILL FOR AN ACT RELATING TO MARINE LIFE CONSERVATION DISTRICTS," passed Third Reading by a vote of 49 ayes to 2 noes, with Representatives McDermott and Ward voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 943) recommending that H.B. No. 497, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. The House of Representatives reconvened at 10:43 a.m.

At this time, the Chair stated:

"The following measures will be deferred one legislative day. SCR 954, House Bill 1144, HD 2, it's on page 31. And on page 32, SCR 960, House Bill 1314, HD 2."

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 954) recommending that H.B. No. 1144, HD 2 pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 960) recommending that H.B. No. 1314, HD 1, as amended in HD 2, pass Third Reading.

By unanimous consent, action was deferred one legislative day.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 945) recommending that H.B. No. 753, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 753, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Matayoshi rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matayoshi's written remarks are as follows:

"I am very supportive of the intent of HB 753, HD 1, which is to ease a financial burden on DHHL to allow for the development of more affordable housing for Native Hawaiians. My concern, however, is that we are paying for this development on the backs of our public schools; namely, the public schools that will serve the population this measure is meant to help. We cannot increase the student population in an area while at the same time depriving that area's schools of funding needed for those students. For this reason, I will be voting with reservations.'

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 753, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SCHOOL IMPACT FEES," passed Third Reading by a vote of 51 ayes, with Representatives LoPresti and Matayoshi voting aye with reservations.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 948) recommending that H.B. No. 1012, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1012, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Onishi rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. Mr. Speaker, this is another veiled attempt for DLNR to try to cover up the mismanagement of Banyan Drive. For many years, Banyan Drive has been mismanaged. The properties on Banyan Drive have been left to disrepair. And it now requires the removal of some of the structures, some of the hotels that formerly existed in Banyan Drive, and the DLNR has been trying to come to the State to have the State pay for that removal in order for them to do the development of Banyan Drive.

"Obviously, the removal of these buildings, condemned buildings, should be part of the full development plan, and it shouldn't be costing the people of Hawaii in order to take those buildings down and benefit the developer.

"In this particular case, the restructuring of the lease, or the forgiveness of lease rent to the developer, is in essence the State and the people of Hawaii paying for what the developer should be able to do for the permission of developing that property. So, I stand in strong opposition."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Todd rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. I just have brief comments and I'd also like the words from the Representative from South Hilo adopted as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Todd continued, stating:

"Just to kind of echo some of those sentiments, if this area, even though this has statewide applicability, it's really designed specifically for an area in my district that everyone is very tired of hearing about, so I'll be brief.

"The dollar figure in question is about \$6 million. And I think it's worth noting that the actual value of this property, in terms of potential lease revenue, would be probably only in the order of \$100,000 a year, give or take. So, you'd really be paying a developer to take this off of your hands, in a sense. And they may, in effect, have 30, maybe even 50 years of free lease of this land for tearing down a building that should never have gotten into this condition in the first place, had this area been managed better. So, I just want to add that. Thank you."

Representative Sayama rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Holt rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Marten rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

passed Third Reading by a vote of 48 ayes to 3 noes, with Representatives Gates, Hashimoto, Holt, Ilagan, Marten, McKelvey, Nakamura, Perruso, Quinlan, and Sayama voting aye with reservations, and with Representatives Kapela, Onishi, and Todd voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 951) recommending that H.B. No. 1023, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1023, HD 1, entitled: "A BILL FOR AN ACT RELATING TO A NONRESIDENT RECREATIONAL MARINE FISHING LICENSE," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 952) recommending that H.B. No. 1122, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1122, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Holt rose to speak in support of the measure with reservations, stating:

"Thank you. Mr. Speaker. With reservations, brief comment. I'm unapologetically pro-Hawaiian. I appreciate the Sovereign Council of Hawaiian Homestead Associations putting forth these measures, but as highlighted in the testimony by the department, as I read before, the amendments proposed are unnecessary and propose to elevate the interests of lessees and homestead associations over the interests of applicants on the waitlist. And we have over 28,000 members on the waitlist. So, for those reasons, I'm with reservations."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Branco rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative DeCoite rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting with reservations on this bill because it imposes additional requirements on the DHHL which in every case, the DHHL has testified that they are unnecessary. When we see bills that impose substantive changes to the administration of DHHL, we hear from a broad cross section of Hawaiian organizations and the Hawaiian community who weigh in on such changes. In the case of this bill, I have not seen widespread support, opposition, or comment. *Mahalo*."

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Gates rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ilagan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Sayama rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Har rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1122, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAIIAN HOMES COMMISSION ACT," passed Third Reading by a vote of 51 ayes, with Representatives

Branco, DeCoite, Gates, Har, Holt, Ilagan, Okimoto, Quinlan, Sayama, and Todd voting aye with reservations.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 953) recommending that H.B. No. 1124, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1124, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, but I'm still in support of it, with degrees of it. First, I want to thank the west side author of this bill. This is essentially a step forward for the Hawaiian Homes Commission to modernize their lease. But, Mr. Speaker, it doesn't, probably, go far enough, because the number of Hawaiians who have lived and died in a state of transgenerational trauma, waiting for a place to call home in their homeland, and I'm going to say, it borders on criminal.

"Whatever excuses might spring from the State after 100 years of failed management of this trust responsibility, it is disturbingly clear and there is no end in the sight. The governance model of DHHL from the get-go has been one of perpetuating government dependency, and that continues till now, year after year after year.

"The State of Hawaii signed off on the trust responsibility of the Homestead Act of 1920 as a condition of statehood in 1959. So, let's be clear, the ultimate responsibility lies in the lap of the governor and the Hawaii State Legislature. If after 100 years of profoundly egregious mismanagement of a fundamental trust, you would think that the leaders of the State would stop looking at DHHL to come up with solutions, which they seem incapable of doing.

"The point is, the model is broken. Broken. The model has to change. House Bill 1124, HD 1, offers a legitimate path to resolving the breach of trust. What is lacking, Mr. Speaker, clearly, is the political will and the courage and determination to right this wrong. House Bill 1124 will take us to the well, but it won't force us to drink.

"It's a good beginning. It's piecemeal. It's something that we need to do. Looking at the lease, the way that Bishop Estate has written leases and put them forth, there is actually value to it when you have a 99-year lease. Heretofore, if you have a Hawaiian Homes lease, all you get is what is in the construction or the reconstruction rebuilding price. So, Mr. Speaker, this is a definite step forward.

"And I'd note that the effective date is 2050. And one of my Hawaiian colleagues said, yes, and all the 28,000 on the waitlist will be dead by then because there are more people on the waitlist that are dying than are getting homes. After 100 years, only 9,800, maybe 10,000 leases at the most. Which means, Mr. Speaker, for 100 years, we built 100 houses per year. I know a developer who could do that in a number of months, Mr. Speaker. We are really negligent. And as I said in the beginning, this borders on criminality. For those reasons, Mr. Speaker, it's okay, but not so okay."

Representative Holt rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. With reservations. I appreciate the passion that the previous speaker has for DHHL and the Hawaiians. Like I said, thank you for the SCHHA for putting this bill forth. I wish it was as simple as this.

"Over the interim, our former colleague and the current chair of the Senate Health Committee looked into these issues to require appraisals, improvements, to identify the replacement costs of the leasehold market value. The problem is that DHHL homestead leases are not like any other properties in Hawaii.

"And, as stated in the testimony from the department, 'the term leasehold is and refers to a lessee's right to exclusive use and possession of a tract of DHHL land for a term of years. DHHL leaseholds can only be owned by qualified beneficiaries. Consequently, the market for DHHL leaseholds is limited by statute.'

"There is also another section in this bill which would again put homesteads and current homesteaders ahead of those on the waitlist. Again, in the testimony from the department it says, 'authorizing second position loans could require additional sources of loan financing to existing lessees while nearly three times that number are awaiting a lease and financing for their homestead award.' For those reasons, I'm with reservations, Mr. Speaker.

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Branco rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ward rose to respond, stating:

"Second time, with reservations but mild support, Mr. Speaker. One of the caveats obviously is that if one of the leases is to pass to another person, it has to be Hawaiian, it has to be 50%, or 25% if it's the children. That limits the number of potential buyers. But for those who follow the numbers locally, as well as on the mainland, as well as in the world, there's probably a half a million Hawaiians. So, that is something that administratively can be taken care of, the governor could probably do it.

"The Department of the Interior asked for innovative, creative things of which this body, with this bill, can introduce creative, innovative ways. And this is a creative, innovative way of getting out of the doldrums of 100 houses every year for 100 years and never fulfilling what otherwise is, to me, a moral imperative to put the Hawaiians back on the land. I repeat, a moral imperative to put the Hawaiians back on the land which was promised 100 years ago. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1124, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE HAWAIIAN HOMES COMMISSION ACT," passed Third Reading by a vote of 50 ayes to 1 no, with Representatives Branco, DeCoite, Gates, Har, Hashimoto, Holt, Ilagan, Matayoshi, Matsumoto, Nakamura, Okimoto, Quinlan, Todd, Tokioka, and Ward voting aye with reservations, and with Representative Ganaden voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 955) recommending that H.B. No. 1276, HD 1 pass Third Reading.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1276, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATE PARKS," passed Third Reading by a vote of 50 ayes to 1 no, with Representative McDermott voting no.

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 957) recommending that H.B. No. 321, HD 1 pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 321, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative DeCoite rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Luke, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 958) recommending that H.B. No. 1296, as amended in HD 1, pass Third Reading.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1296, HD l pass Third Reading, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative B. Kobayashi rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, support with reservations and a few comments. After our majority caucus, I was given some dollar numbers and I'd like to share them with you. The master settlement agreement is one of the most lucrative law cases that have come to the support of state finances. Over the past 20 years, over approximately \$1 billion has gone into the tobacco trust fund, not to count the billions in addition that have gone to the general fund, the Department of Health, health prevention fund, the UH School of Medicine.

"In the past 20 years, approximately \$45 million have been earned in interest income through the Hawaii Community Foundation for the tobacco trust fund. This is, depending on your perspective, a little bit of money or a lot. I would suggest that given that there would have been zero interest income had the money gone into the general fund, that this is a lot of money.

"Second dollar item has to do with the rumor that \$1 million from the tobacco trust fund went to support the Biki bike car rental program of the City and County. In fact, while there was \$1 million given to Biki bikes by the State, it came not from the tobacco trust fund, but from the pot of money that went to the Department of Health, health prevention.

"The third item is that I am told that while this program, the tobacco control program, will be supported by general funds, the general fund support is \$1 million less than what is currently available. So, for these

reasons and others, I would like to suggest that we look at this program more closely as this bill proceeds. Thank you."

Representative Perruso rose to speak in support of the measure with reservations, stating:

"While I appreciate the intent of this measure to move special funds into the general funds, and I definitely support that approach, I still do have reservations about this particular bill."

Representative Tam rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Nakamura rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Ganaden rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, I'd like to change my no vote to a with reservations. I'd like the words of the speaker who spoke four times previously to be entered as my own. Also noting, hoping that we can clarify in future iterations of this bill, the decoupling of the financing of the cost of construction for the University Health and Wellness Center from the need to support tobacco cessation in communities like the one I represent. Thank you," and the Chair "so ordered." (By reference only.)

Representative Kapela rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1296, HD 1, entitled: "A BILL FOR AN ACT RELATING TO STATE FUNDS," passed Third Reading by a vote of 45 ayes to 6 noes, with Representatives Ganaden, Kapela, B. Representative Takumi rose to speak in opposition to the measure, stating:

"Thank you very much, Mr. Speaker. In opposition. Mr. Speaker, as your CPC chair emeritus, I've got a little familiarity with condominium issues. On this one, it's well intended but there is one big unintended consequence.

By putting in language that says that no condominium association employee can solicit proxies, it will result in most if not all condominiums not being able to achieve quorum.

"As you know, many condominiums have a very difficult time achieving quorum, particularly those condominiums where the majority of the owners are not even living in the state. So, usually the board directs the community association employee to get votes. And how do they do that? Usually they do a mailing. Because, as you know, boards are all volunteers, and to do a mailing of 200, 300, 400, 500 unit owners is very time consuming, and so that's what they pay condo associations to do.

"Secondly, I've known instances where in order to get proxy votes, the employees would literally go door to door in that condo, knocking on the doors, asking if they can fill out the proxy form. Under this bill, that would not be allowed.

"So, if the intent is to paralyze boards and not get proxies and not achieve quorum, this bill would achieve that purpose. I am hopeful with a nine word change, nine words added to this bill, we can take care of this unintended consequence and also ensure that association employees are not engaging in something nefarious in trying to get proxies for their own ends. Thank you, Mr. Speaker."

Representative LoPresti rose to speak in support of the measure with reservations, stating:

"Thank you, Mr. Speaker. I have reservations with comments. I'd like the words of the previous speaker entered into the record as if they were my own, although I was not CPC chair emeritus," and the Chair "so ordered." (By reference only.)

Representative LoPresti continued, stating:

"I have reservations for similar reasons, but also slightly different. I'd like to see, and the reason I'm a reservation and not a no, is I'd like to see the language that was removed put back in.

"As the president of my association, it is difficult to achieve quorum sometimes. But I think one of the rationales behind the idea to not allow people to give a proxy to the board as a whole, is because sometimes there is disagreement in the community as to what the board is doing. And it's hard to replace the board when you give a proxy and that proxy is almost always given to the board as a whole. And if you want to change something, you can't do that and give a proxy. So, the part that was removed is the part that should be kept, in my opinion.

"The universal language that says that the association managers cannot solicit a proxy seems a bit overbroad. If the intent is to limit something nefarious, I think that's fixable in the bill. But we can't hamstring boards from having the people that they pay to help manage their associations to help do the job. And so, that's why I'm reservations, because I think we can still fix it. Thank you."

Representative Johanson rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In support. I want to start off by saying, I appreciate the comments, actually, from the Representative from Pearl City, and I agree. I think his comments are helpful as it moves over to the Senate in providing some clarification because I, too, agree that the intent here is to try to ensure that nothing nefarious is happening from the various employees who have a vested interest and sometimes might actually have a conflict of interest in the manner in which they pursue the solicitation of proxies.

"For most members, including myself, who are getting an education in this, the proxies are important because this is a governance structure that governs the condominium associations. And this is how common area improvements are done, policies are made. So, I think those are very good comments that I take to heart.

"I will say, the restoration of the portion of the bill that I deleted would have achieved exactly what the Representative from Pearl City and myself are concerned about, which is the inability to actually govern a condo association. These proxies are important, and the ability to delegate them to the board is a necessary part of condo association government. Thank you very much."

Representative LoPresti rose to respond, stating:

"Mr. Speaker, second time, still in reservation. By reinserting that language, you'd still very much have the ability to have the governance structure function. There are many options of what to do with a proxy. You can give it to your neighbor, you can give it to an individual member. There's lots of options. The default tends to be only giving it to the board to use, and that is where, in my experience, a lot of the problems come.

"When people think that something nefarious is being done on a board or they don't like the way the board is making decisions, by having the option to have the proxies given to somebody else, you still have governance structure. But by removing the option to, that sometimes these boards put out calls for proxies and the only real option that's given to them is that they can give the proxy to us, the board, if I'm speaking as a board member. And that's not the only possibility, there are many possibilities. And so, I just wanted to correct that. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 221, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CONDOMINIUMS," passed Third Reading by a vote of 49 ayes to 2 noes, with Representative LoPresti voting aye with reservations, and with Representatives McDermott and Takumi voting no.

H.B. No. 458, HD 1:

Representative Belatti moved that H.B. No. 458, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Matayoshi rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and H.B. No. 458, HD 1, entitled: "A BILL FOR AN ACT RELATING TO DRIVER'S LICENSES," passed Third Reading by a vote of 51 ayes, with Representative Matayoshi voting aye with reservations.

Representatives DeCoite, D. Kobayashi, Kong, Matsumoto, Okimoto, Perruso, and Tokioka voting no.

H.B. No. 248, HD 1:

Representative Belatti moved that H.B. No. 248, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Ward rose to speak in support of the measure with reservations, stating:

"With reservations, Mr. Speaker. Interestingly, marriage is now just, as the bill indicates, a personal relationship. I think this lessens the meaning of marriage, it kind of cheapens it, if you will, and anybody and everybody can now marry anyone.

"Interestingly, the first part of the bill says, you've got to pay a license fee. So, is this a way of getting money by actually diluting actually what vows are, which we hopefully take seriously nowadays, and this thing kind of cheapens it. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and H.B. No. 248, HD 1, entitled: "A BILL FOR AN ACT RELATING TO PERSONAL RELATIONSHIPS," passed Third Reading by a vote of 50 ayes to 1 no, with Representative Ward voting aye with reservations, and with Representative McDermott voting no.
