

## THIRTY-SEVENTH DAY

Thursday, March 25, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at 12:01 p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Richard H.K. Onishi, after which the Roll was called showing all members present, with Representative Har participating remotely via videoconference.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Sixth Day was deferred.

## ORDER OF THE DAY

## REPORTS OF STANDING COMMITTEES

Representative Woodson, for the Committee on Education, presented a report (Stand. Com. Rep. No. 1365) recommending that S.B. No. 807, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 807, SD 2, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Well the problem is, Mr. Speaker, we're putting the mentally ill, the homeless, into the prisons instead of those who are in effect the real felons.

"The difficulty is, even if you are mentally defective or poor, you still have no skin in the game if there's no reason for going there. And what some creative states have done is to have them sign an affidavit that says, if you don't show up, you're gonna owe this money. So, there's a better way around

it rather than this no bail. I think if it isn't broke, it shouldn't have to be changed. And right now, it's giving the message that, hey guys, you, particularly those who are in the revolving door, you get in, you get out, you get in, you get out, revolving door. This is a message that says, hey we're going to be really soft on crime, and this opens that flood gate. Thank you, Mr. Speaker."

Representative Ganaden rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. And in response, the pretrial criminal defense system is broken, as articulated by the Native Hawaiian Justice Task Force Report, created by this Legislature in 2012. It is broken for those who don't have resources in our community. It is broken according to an ACLU report last year that notes that approximately half of the individuals at the Oahu Community Correctional Center are there simply because they can't afford to get out.

"This bill represents a prudent process-oriented approach to pretrial reform, it reduces Hawaii's overreliance on cash bail, and ensures that bail and detention determinations are instead tailored to individual risks of flight and danger to the community. Mr. Speaker, the era of Dog the Bounty Hunter is over, and we need to support criminal justice reform so that we can eventually bring people back home from the mainland and Arizona. Thank you."

Representative LoPresti rose to speak in support of the measure, stating:

"Strong support. I would just like the comments from the Representative from Joint Base Pearl Harbor-Hickam entered into the record as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Trespassing tourists could also face the same thing. Also concerned about the fact that many gentleman's estates throughout rural Hawaii are still considered agricultural land. This would be essentially creating a private police force in several of these communities. Thank you so much."

Representative Wildberger rose to speak in opposition to the measure, stating:

"Same request."

Representative D. Kobayashi rose to speak in opposition to the measure, stating:

"Same request."

Representative McKelvey rose to disclose a potential conflict of interest, stating:

"Mr. Speaker, I have a potential conflict. I live on land that is zoned agriculture," and the Chair ruled, "no conflict," and that the ruling would extend through *sine die*.

Representative McKelvey continued to speak in support of the measure with reservations, stating:

"Thank you so much. In which case, with reservations. I believe that you shouldn't be separating crimes based upon zoning of land. Thank you very much."

Representative Nakamura rose to speak in support of the measure with reservations, stating:

"Same request."

Representative LoPresti rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

And this one pushes us farther away from that, with a good excuse for saying we're going to build affordable housing. And I know a lot of Hawaiians do get affordable housing, but this is about land, it's not about rental housing. Thank you, Mr. Speaker."

Representative Okimoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative DeCoite rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative DeCoite's written remarks are as follows:

"I am voting in opposition to this bill because my concern and priority is making sure that ceded lands are used to benefit Native Hawaiians as intended. Under this bill, ceded lands could be leased or disposed of by using HHFDC's broad leasing authority by granting long term, including 99-year leases, or by disposing of these lands at below market value. This bill goes too far and will undermine the state's commitment to Native Hawaiians. *Mahalo.*"

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 947, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO A BROADBAND AND DIGITAL EQUITY OFFICE," was referred to the Committee on Finance.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1509) recommending that S.B. No. 263, SD 2, as amended in HD 1, be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 263, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ECONOMIC DEVELOPMENT," was referred to the Committee on Finance.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1510) recommending that S.B. No. 973, SD 1, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 973, SD 1, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 973, SD 1, HD 2, entitled: "A BILL FOR AN ACT RELATING TO HAWAII MONEY TRANSMITTER ACT," was referred to the Committee on Finance, with Representative Okimoto voting aye with reservations, and with Representative D. Kobayashi voting no.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1511) recommending that S.B. No. 1340, SD 2, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1340, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO EMERGENCY MEDICAL SERVICES," was referred to the Committee on Finance.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1512) recommending that S.B. No. 1313, SD 2, HD 1, as amended in HD 2, be referred to the Committee on Finance.

Representative Belatti moved that the report of the Committee be adopted, and that S.B. No. 1313, SD 2, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Wildberger rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Perruso rose to speak in opposition to the measure, stating:

"In strong opposition with brief comments. So, I have spoken about this before and I rise again because in the interim I've had an opportunity to speak to both DLNR and DAR and they didn't have enough information on the impact that the previous introduction of bass had, not just on Lake Wilson but also on the waters downstream.

"So, I reached out to uncles in the community who fish and got information from them and indeed there are bass downstream. And so, the problem with these largemouth bass is that they are apex predators, so they wipeout the native species. And in the pandemic, this was especially problematic, because people in my community wanted to fish, but if you fish in Lake Wilson you have to catch and release any bass or any of these sport fish fishes. And so, because they have wiped out all the other fishes, there's no point fishing in Lake Wilson. And I just don't want that to become the case for all the waters downstream from my community. *Mahalo*."

Representative Kapela rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1313, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO SPORT FISH," was referred to the Committee on Finance, with Representatives Kapela, Perruso, and Wildberger voting no.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1513) recommending that S.B. No. 834, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 834, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CHILDLIKE SEX DOLLS," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Johanson, for the Committee on Consumer Protection & Commerce, presented a report (Stand. Com. Rep. No. 1514) recommending that S.B. No. 974, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 974, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CONSUMER PROTECTION," passed Second Reading and was referred to the Committee on Finance.

## ANNOUNCEMENTS

Representative Ward: "Mr. Speaker, I have an announcement and it's because tomorrow we have a holiday. It's a state holiday in honor of Prince Kuhio. I think to celebrate it properly we need a little bit more background and I'm going to name a couple of things and a few of his accomplishments, if I may, Mr. Speaker.

"He was born in 1871 on March 26th, tomorrow's March 26th, that was 150 years ago, and he was born on Kauai. Some of our good colleagues who are from Kauai, kudos to them. And he was basically the father of the Hawaiian Republican Party, so it's dear to a few of us in the minority here.

"He was the first elected member of Congress of royal decent, to this day he still is the same, and the first Republican actually who was elected to the US Congress. His tenure lasted for 19 full years until his death. He actually died in office in 1922.

"During his tenure, here is some of the accomplishments that he did. He was the first to introduce statehood for Hawaii, that was in 1919. And most importantly and most remembered for is his founding of the Hawaiian Homes Commission, his introduction of that Hawaiian Homes Commission Act in 1920 which, as you know, granted 203,000 acres to the Hawaiian community, of which we're still, 100 years later, trying to fix.

"But, Mr. Speaker, I should put a footnote here that he wanted no blood quantum. The 50% requirement of blood quantum actually was a political compromise, but he never wanted to have it to where you had to have a certain lineage, if you will. If you were Hawaiian, you were Hawaiian, and from that you should be back on the land.

"Some other accomplishments and primarily CIP accomplishments, Pearl Harbor, got the appropriation and the dredging and the construction of that, Makapuu Lighthouse, the Territorial Building, the Hilo Wharf, Hawaii's Volcano National Park, the hospital at Kalaupapa, and a number of things that now in the governance model, the county system and the home rule that many of us hold very, very dear in this body.

"Lastly, he restored the Royal Order of Kamehameha and established the first Hawaiian Civic Club. For those reasons, Mr. Speaker, Prince Kuhio was a great Hawaiian and a great American and is why we celebrate tomorrow as a state holiday. Thank you, Mr. Speaker, and happy three-day weekend to members. Thank you."
