### Thursday, April 8, 2021

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2021, convened at 12:13 p.m., with Speaker Saiki presiding.

Those concerns haven't been addressed, but I am confident that they will be addressed in conference, that's why I'm not voting no. Thank you, with reservations," and the Chair "so ordered." Representative Okimoto's written remarks are as follows:

"Mr. Speaker, I rise in opposition to HSCR 1700, SB 294. Mr. Speaker, civil asset forfeiture can significantly assist our law enforcement's ability to combat crime by targeting specific property that has been deemed to be capable of furthering criminal activity. Some of these assets include vehicles that have been used in kidnappings, drug trafficking, and sex trafficking. I have serious concerns that restricting asset forfeiture to cases involving felony offenses will significantly increase high-profile criminals' ability to continue terrorizing our communities. Mr. Speaker, this is, to my knowledge, the second measure of this session that not only compromises our law enforcement officers' abilities to do their jobs but would also recklessly endanger their lives and the lives of the people in our communities. Mr. Speaker, as I have mentioned in the past, we should be doing everything we can to assist our law enforcement officers. Instead, measures like this seem to be trying to find ways to hamstring our officers every step of the way in solving crimes, particularly crimes of violence and trafficking."

"Mr. Speaker, a no vote with a few comments. This bill is where, if you are charged with something, you don't have to pay bail. I call it the get out jail free card because it's shown in other jurisdictions that it's questionable or it doesn't work. And some of those can say, well okay, we don't have to take their money, but let's at least get an affidavit from them which says if they don't show up, then they got to pay.

"This bill doesn't do either of those, it just says, hey if you are of a certain guideline, and most of these people are going to be homeless anyway, I can't see why we're doing this and how we're going to help people, because many of these people really need treatment and it is only when they get into places like prison, which are the new mental health treatment centers, that they do actually get attention, get the physical, psychological, and in often cases drug treatment that they need.

"So, for those reasons, Mr. Speaker, I don't think this is good policy. It's been tried in various states, but it doesn't seem to work that well, if at all. Thank you."

Representative Okimoto rose to speak in opposition to the measure, stating:

"In opposition please, Mr. Speaker, brief comment. I do not think this bill helps to protect the people of Hawaii due to the addition of Class C felony offences. While it does say nonviolent in the bill, this category is still at risk for public safety as it includes burglary in the second degree and felony

possession, just to name two. This does not solve the issue of overcrowding of facilities either and I think we can think of a better solution. Thank you, Mr. Speaker."

This measure would prohibit defendants originally charged with the offenses of violation of privacy in the first degree and certain sections of violation of privacy in the second degree from qualifying for a deferred acceptance of guilty or *nolo contendere* plea.

"The courts should be allowed to maintain their discretion on a case-by-case basis to grant deferrals in these types of situations. According to the state public defender: 'A criminal conviction follows an individual for the rest of his/her life. It will impact his/her ability to seek and maintain employment and to receive government benefits. A defendant who is youthful, immature, remorseful and is not likely to re-offend should be allowed, in limited circumstances, to be given the opportunity for a second chance — a chance to avoid a criminal conviction. Police officers, soldiers, government and private sector employees may lose their jobs if they receive a criminal conviction.'

"The prohibition of deferrals of guilt could also lead to the increase of jury nullifications which would obscure the truth and would not establish the defendant's history accurately if he or she were to be tried for a repeat offence. Deferrals of guilt allow the courts more room to judge each case on

its own circumstances and determine what verdict will result in the best outcome for maintaining justice and societal welfare.

"For these reasons, I respectfully oppose this bill."
