Tuesday, February 8, 2022

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 12:01 p.m., with Vice Speaker Mizuno presiding.

"In strong support. This bill would create a *ho'okaulike*, a collaboration between the University of Hawaii Richardson School of Law as well as the School of Hawaiian Knowledge to discuss best practices regarding the overincarceration of native peoples in criminal justice. These are statistics that the state has known about for many years.

"This bill is the result of many people from the academic, private, and state sector talking about how to implement these practices, how to talk about them in a way that's civil, and how to work with an emerging body of knowledge from an international diaspora of intellectuals talking about how to reduce the over incarceration of native peoples, people of color, and juveniles in our community. It's a cost saving measure. And for those of you who might be hearing it in the next few committees, I implore you to just listen to the testimony and check out what the School of Law has supplied to us. Thank you so much."

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2015, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Okimoto voting aye with reservations, and with Representative McDermott being excused.

"So, what I'd like to do is just study the problem and let us learn to see if sand burritos are an appropriate tool for our toolbox. I'm certainly not suggesting that we would just start using them everywhere, but there may be certain instances at certain homes or certain properties where they could be appropriate. So, I'd just like to find out. Thanks very much, Mr. Speaker."

Representative Tokioka rose to speak in support of the measure, stating:

"Mr. Speaker, in strong support and I'd like to ask that the words from the Representative from the North Shore be inserted into the Journal as if they were my own, and I'd also like to insert written comments as well," and the Chair "so ordered." (By reference only.)

"The Representative from North Shore mentions that this is an increasing problem statewide, not just on the North Shore. There is also no clear evidence that sandbags cause or worsen erosion in other areas... So, let's

Other regions, other states, other countries don't allow what we allow here, which is for their geographic origin name for a specialty product like this to be used on products that aren't that product and that don't reflect the quality that people expect.

"In Hawaii, we allow coffee blends that contain only 10% of Kona coffee or whatever origin coffee, one coffee bean in 10, an amount that in blind taste tests cannot be detected, to be sold under the name Kona. Some people will say the important thing is truth in labeling, but the reality is we know that these labels mislead people. If they didn't, they wouldn't be used. That is the point, to put the name Kona or Kau or Hawaii on coffee that is 90% not that and sell it for more. The deception is the point.

"By allowing this deceptive practice, we're damaging the reputation of our specialty products and we're decreasing the value of the products that are grown here and are 100% that product and we decrease the revenue to the farmers that grow them. Every farmer that testified on this bill testified in support. And I would argue that the Legislature has a greater obligation to support our local farmers than to undercut them with a state law that allows people to make a little more profit on imported coffee they are selling based on deceptive labeling.

"People have also made the argument this year that there's inflation and we have some obligation to provide affordable coffee. I think it's a completely fallacious argument. This is a specialty product. We're not here to provide affordable luxury sports cars or designer brand clothing or specialty coffee. There are other choices on the shelves if people want affordable coffee, and we shouldn't undercut our farmers and then make the argument that this is somehow for the good of low-income families. I guess those are the comments I wanted to make, and I think it's long past time that we pass this legislation. I hope this is the year that we can do it."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, strong support. We must protect our local coffee market. And may the comments of the previous speaker be entered into the Journal as my own. A historical moment for both of us."

Representative Kapela rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. And I ask that the words of the Representative from Kailua-Kona be inserted into the Journal as if they were my own.

"One of the most important and special things about Kona coffee is that it's one of the only coffees in the world that is picked and produced by hand. And that's something that's special about Kona and Kona coffee. It contributes to the flavor, but it's also something that we need to think about when we're thinking about the farmers who do this every single day and spend their livelihoods doing something like this. So, thank you very much to the chair for passing this out, and I hope that it will continue forward, and we can get it passed this year. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1517, HD 1, entitled: "A BILL FOR AN ACT RELATING TO COFFEE," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Okimoto voting aye with reservations, and with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 97-22) recommending that H.B. No. 1768, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1768, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DISPOSITION OF WATER RIGHTS," passed Second Reading and was referred to the Committee on Water & Land, with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 98-22) recommending that H.B. No. 1844 pass Second Reading and be referred to the Committee on Higher Education & Technology.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1844, entitled: "A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII," passed Second Reading and was referred to the Committee on Higher Education & Technology, with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 99-22) recommending that H.B. No. 1864, as amended in HD 1, pass Second Reading and be referred to the Committee on Education.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1864, HD 1 pass Second Reading and be referred to the Committee on Education, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1864, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SCHOOL FOOD PROGRAMS," passed Second Reading and was referred to the Committee on Education, with Representative Okimoto voting aye with reservations, and with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 100-22) recommending that H.B. No. 1993, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 1993, HD 1 pass Second Reading and be referred to the Committee on Water & Land, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Marten rose to speak in support of the measure, stating:

"I rise in support with comments. So, basically, this bill is seeking to use our state agricultural land as best we can to achieve our sustainability and local food production goals. Currently, our state agricultural land is not always used optimally. Our leases are long and there is not a lot of opportunities to bring new competition in and to provide the opportunity to new farmers. So, this is just trying to address some of that. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1993, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURAL LEASES," passed Second Reading and was referred to the Committee on Water & Land, with Representative Okimoto voting aye with reservations, and with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 101-22) recommending that H.B. No. 2084, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

Representative Belatti moved that the report of the Committee be adopted, and that H.B. No. 2084, HD 1 pass Second Reading and be referred to the Committee on Water & Land, seconded by Representative Morikawa.

Representative Okimoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kapela rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Perruso rose to speak in support of the measure with reservations, stating:

"Mr. Speaker, with reservations, only because the language of this measure has been extended to include lessees. So, with that in mind, I'm voting with reservations."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 2084, HD 1, entitled: "A BILL FOR AN ACT RELATING TO IMPORTANT AGRICULTURAL LANDS," passed Second Reading and was referred to the Committee on Water & Land, with Representatives Kapela, Okimoto, and Perruso voting aye with reservations, and with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 102-22) recommending that H.B. No. 2305 pass Second Reading and be referred to the Committee on Higher Education & Technology.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2305, entitled: "A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII," passed Second Reading and was referred to the Committee on Higher Education & Technology, with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 103-22) recommending that H.B. No. 2319, as amended in HD 1, pass Second Reading and be referred to the Committee on Consumer Protection & Commerce.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 2319, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SERVICE ANIMALS," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative McDermott being excused.

Representative Hashem, for the Committee on Agriculture, presented a report (Stand. Com. Rep. No. 104-22) recommending that H.B. No. 1726, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

On motion by Representative Belatti, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 1726, HD 1, entitled: "A BILL FOR AN ACT RELATING TO AGRICULTURAL BUILDINGS," passed Second Reading and was

referred to the Committee on Water & Land, with Representative McDermott being excused.
