The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at noon, with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Sam Satoru Kong, after which the Roll was called showing all members present, with Representatives Har, Holt, D. Kobayashi, Matayoshi, McKelvey, Perruso, Quinlan, Tokioka, and Wildberger participating remotely via videoconference, and with the exception of Representative Kapela, who was excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Nineteenth and Twentieth Days was deferred.

Representative Ward rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Strong support commending, not only this is a new industry, but to commend the introducer from the North Shore, because this is the way entrepreneurial thinking happens. Getting an industry that's got really a good trajectory and then boosting it even higher, so it's a great bill. Thank you."

Representative Wildberger rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Perruso rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Ward rose to respond, stating:

"Just in response, Mr. Speaker. Again, strong support. But people should realize this is a billion-dollar industry and could be multi-billion dollars because of our beautiful environment and the way that people find this very attractive. So, contrary to the fact that it's expensive, even with the tax credit, even though I know that's not on this particular bill, we have a ratio for every dollar that the state spends, we get \$4 to \$5 back because of the labor and all the expenses that we are having been paid by the industry. So, this is a moneymaker.

"And Mr. Speaker, even if you're just, I forget what they call him, a grabber, you carry the camera around, you're making \$75,000 to \$85,000.

These are the kind of jobs that we need to get out of that ALICE study where 48% of the people in Hawaii are one paycheck away. This is a great bill, and I look forward to everybody voting for it. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1983, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM," passed Second Reading and was referred to the Committee on Finance, with Representative Perruso voting aye with reservations, with Representative Wildberger voting no, and with Representatives Eli and Kapela being excused.

"Thank you, in opposition. I have yet to see a justification from a cost benefit standpoint of the existing film credit that we have. Now we're throwing this infrastructure film credit in addition to what we already have. I'd like to see a little bit more considered approach taken to be able to determine whether all of this is even justifiable, or whether we could have other ways to encourage growth in this besides just throwing a tax credit set, I think and in a lot of cases get gamed in different ways. Thank you."

Representative Quinlan rose to speak in support of the measure, stating:

"In strong support and may I have the words of the Representative from Manoa entered into the Journal as if they were my own."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representative McKelvey's written remarks are as follows:

"Mr. Speaker, I rise and strong support of the measure. Mr. Speaker, this measure seeks to waive one's right to judicial contest if they didn't contest an allegation of the commission and did not have a contested case hearing beforehand. Mr. Speaker, while there are concerns about this bill insofar as inadvertently cutting off due process should timely notification not be given, it overall strikes a steadfast blow for much needed campaign and ethics reform. This measure, like many others, is the product of the commission, good government advocates, and the Legislature working together, and that underscores the fact that this action is needed and not that of any ad hoc committees."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1426, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ORDERS OF THE CAMPAIGN SPENDING COMMISSION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Eli and Kapela being excused.

Representative McKelvey, for the Committee on Government Reform, presented a report (Stand. Com. Rep. No. 565-22) recommending that H.B. No. 1880, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative McKelvey's written remarks are as follows:

"Mr. Speaker, this measure looks to strengthen our electioneering communication laws by requiring a person or political action committee to file a statement of information with the campaign spending commission for every expenditure of an electioneering communication they make. Mr. Speaker, as you know, dark money has also eroded the public's trust and confidence in their elected government and has made campaigns toxic, like that of the mainland. This measure is yet another product of cooperation between government advocates, the commission, and the Legislature, and illustrates that immediate action is already occurring."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1880, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ELECTIONEERING COMMUNICATIONS," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Eli and Kapela being excused.

Representative McKelvey, for the Committee on Government Reform, presented a report (Stand. Com. Rep. No. 566-22) recommending that H.B. No. 1897, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

"Mr. Speaker, I stand in support of this measure. Mr. Speaker, this measure seeks to modernize our government hearing process by requiring

recordings for public meetings that would be preserved in perpetuity for the record. Mr. Speaker, these kinds of resources are critical not only for any litigation which may arise because of the issues at hand, but also to provide a well of legislative and policy information for different branches of government in Hawaii and other interested parties. The complaints of the agencies fall on deaf ears as they continue the old grid there is not enough processing power nor space to create digital archives of all these recordings. However, Mr. Speaker, due to advances such as IaaS, there is a depth of cloud resources for both storage and enumeration of these meetings as to create meaningful compendium of all of the various government and public hearings that have occurred which have been recorded."

"Mr. Speaker, this is yet another measure that seeks to stem the influence of dark money, particularly through that of shadow nonprofits, that are created solely to engineer money towards the defeat or advocacy of certain candidates all while enjoying the fiscal umbrella given to nonprofits for their work. There is obviously great concern about the fact that not all nonprofits who engage in candidate advocacy or recommendations may be incorporated as a 501(c). However, I believe the change we made to ensure that it only applies to nonprofits that have filed a report with the campaign spending commission will limit its scope to political PACs as opposed to that of other types of nonprofits. This measure also showcases the things that are being done by this legislature to bolster transparency and accountability thereby bolstering public support."

Representative Gates rose in support of the measure with reservations and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Gates's written remarks are as follows:

"I stand with reservations on HB 1570, HD1. As we have seen with previous bans throughout history, blanket bans do not necessarily stop our constituents from finding ways to purchase things like flavored vapes. With minors not allowed to purchase flavored tobacco products, they unfortunately resort to the black market which are substantially more dangerous to the end user. Black markets will continue to sell prohibited products, which is why I am in support of placing taxes on these items for the funding of cessation programs to help those with smoking addictions."

Representative D. Kobayashi rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Kong rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Todd rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Quinlan rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative McKelvey rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1570, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE YOUTH VAPING EPIDEMIC," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representatives Gates, McKelvey, Quinlan, and Todd voting aye with reservations, with Representatives D. My point, Mr. Speaker, is that when we have our current account, i.e. our checking account, which has millions and millions of dollars in it, which either is now either Bank of Hawaii or First Hawaiian Bank and it rotates with CPB, *et cetera*, the pCard should be in those accounts. We shouldn't have to do it separately, and we shouldn't have to have a bill like this. Because of that, I have reservations, because the local banks are making a lot of money on this and they should be able to put this pCard in there without any inconvenience whatsoever. Thank you, Mr. Speaker."

Representative D. Kobayashi rose to speak in opposition to the measure, stating:

"Mr. Speaker, in opposition. So, I think it's framed as really a buy local issue. Really what it is, is what we've been talking about, it's a giveaway to some local moneyed interests here that's really not in the interests of the taxpayers of Hawaii. As a result, I'm a no vote on this measure. Thank you."

Representative Wildberger rose to speak in support of the measure, stating:

"Mr. Speaker, in support with a brief comment. The agency that awarded this contract to the Bank of America testified that they did not know that the Bank of America owes the State of Hawaii and the people of Hawaii hundreds of millions of dollars due to bad mortgage practices. And while I like to see state agencies saving money and that not necessarily a local bank should be given priority over another bank that can provide electronic services that could save the state money, at what point do we declare an entity unqualified for such benefit if they have been a bad actor? Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1909, HD 2, entitled: "A BILL FOR AN ACT RELATING TO PROCUREMENT," passed Second Reading and was referred to the Committee on Consumer Protection & Commerce, with Representative Ward voting aye with reservations, with Representative D. Kobayashi voting no, and with Representatives Eli and Kapela being excused.
