

## THIRTY-SIXTH DAY

**Wednesday, March 23, 2022**

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 12:02 p.m., with Vice Speaker Mizuno presiding.

The invocation was delivered by Representative Val Okimoto, after which the Roll was called showing all members present, with Representative Har participating remotely via videoconference, and with the exception of Representatives Kitagawa and Kong, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Fifth Day was deferred.

regarding these energy investments, I'm going to be voting with reservations."

Well, I think we have a responsibility to do our numbers before we pass it on to them. For those reasons, Mr. Speaker, with reservations, hoping enlightenment from my colleagues. Thank you."

Representative LoPresti rose in support of the measure with reservations and asked that the remarks of Representative Kapela be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 777, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE CRIMINAL DESTRUCTION OF TREES," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Har, Kapela, LoPresti, and Tam voting aye with reservations, with Representative Ganaden voting no, and with Representatives Kitagawa and Kong being excused.

Representative Lowen, for the Committee on Energy & Environmental Protection, presented a report (Stand. Com. Rep. No. 1297-22) recommending that S.B. No. 2297, SD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.
