

## FORTY-FIFTH DAY

**Wednesday, April 6, 2022**

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 12:05 p.m., with Vice Speaker Mizuno presiding.
