No. 1472, HD 1, SD 1, entitled: "A BILL FOR AN ACT RELATING TO THE WITHDRAWAL OF PETITION SIGNATURES," passed Final Reading by a vote of 47 ayes, with Representatives Holt, Marten, Ohno, and Tokioka being excused.

H.B. No. 1743, HD 1, SD 1:

Representative Belatti moved that H.B. No. 1743, HD 1, SD 1 pass Final Reading, seconded by Representative Morikawa.

Representative Yamane rose to speak in support of the measure, stating:

"Mr. Speaker, standing in support, real brief comments, Mr. Speaker. This measure was actually worked with Department of Health over the last year. We're glad that we made this at this juncture of moving this measure forward. Mr. Speaker, HB 1743 affects public swimming pools, but not in the way that we typically look at oversight of nationally accredited pools. Mr. Speaker, these are pools specifically like the Waikiki Natatorium, Enchanted Lakes, Koko Marina, Lake Wilson, Wai Kai Lagoon, and other

bodies of waters in which there is no defined borders and which impact counties and in our state throughout the islands.

"Mr. Speaker, this was a labor in which everybody came together with a common goal to address these issues throughout our state. And we're glad that this bill is here today in support of what Department of Health is trying to do, protecting all of us. Thank you."

Representative LoPresti rose to disclose a potential conflict of interest, stating:

"Ruling on a potential conflict. This bill directly impacts Hoakalei Resort, where I reside," and the Chair ruled, "no conflict."

Representative LoPresti continued to speak in support of the measure, stating:

"Thank you. In support, then. I support this because the people in my district and my community, my neighborhood, have been waiting for over 10 years to be able to use what is now called the Wai Kai Lagoon, used to be a marina. And they deserve to have access to amenities that they were promised. So, I'd like to see this bill passed so that the people in my community can enjoy some version of amenities that they've been promised. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 1743, HD 1, SD 1, entitled: "A BILL FOR AN ACT RELATING TO POOLS," passed Final Reading by a vote of 47 ayes, with Representatives Holt, Marten, Ohno, and Tokioka being excused.

H.B. No. 1789, HD 2, SD 1:

On motion by Representative Belatti, seconded by Representative Morikawa and carried, H.B. No. 1789, HD 2, SD 1, entitled: "A BILL FOR AN ACT RELATING TO COLLECTIVE BARGAINING," passed Final Reading by a vote of 47 ayes, with Representatives Holt, Marten, Ohno, and Tokioka being excused.

H.B. No. 1848, HD 2, SD 1:

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support, brief comments. As we see democracy being eroded throughout the world, it is so important that we pass this bill and acknowledge the advocates of student journalists across the state who have helped us to come to this point where we can pass the Hawaii Student Journalism Protection Act. Mr. Speaker, again, this is so important as it codifies freedom of speech and freedom of press protections for student journalists across our state. Thank you, Mr. Speaker."

Representative Woodson rose to speak in support of the measure, stating:

"Strong support, Mr. Speaker, and may I have the speaker from the area of Makiki's words adopted into the Journal as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Ward rose to speak in support of the measure, stating:

"Strong support, Mr. Speaker, brief comment. This issue of student journalism is so important because of the state of journalism now in our state and in our nation and probably in the world, given what's coming out of Moscow of what's not true of what's going on in Ukraine. But the point is that this is a, I talked to the students earlier, there's a censorship and intimidation that these young minds are going through. And I think this is a turning point, if you will, like 13 or 16 other states have it codified in statute that this will be freedom of speech, freedom of writing, and it's a good bill. Thank you."

The motion was put to vote by the Chair and carried, and H.B. No. 1848, HD 2, SD 1, entitled: "A BILL FOR AN ACT RELATING TO STUDENT JOURNALISM," passed Final Reading by a vote of 47 ayes, with Representatives Holt, Marten, Ohno, and Tokioka being excused.

H.B. No. 1883, HD 1, SD 1:

Representative Belatti moved that H.B. No. 1883, HD 1, SD 1 pass Final Reading, seconded by Representative Morikawa.

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Again, in strong support. And I feel so strongly in standing up for this because of the work of the Chair and Vice Chair of the Judiciary. Again, Mr. Speaker, as we see other states and jurisdictions restricting the right to voting, we can be very proud as members of this state where we're ensuring access to voting for all those limited English speakers in our community. Thank you, Mr. Speaker."
