

## FIFTY-SEVENTH DAY

Thursday, April 28, 2022

The House of Representatives of the Thirty-First Legislature of the State of Hawaii, Regular Session of 2022, convened at 6:32 p.m., with Speaker Saiki presiding.

The invocation was delivered by Representative David A. Tarnas, after which the Roll was called showing all members present with the exception of Representatives McDermott and McKelvey, who were excused.
