

## TWENTY-EIGHTH DAY

Friday, March 10, 2023

The House of Representatives of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 12:05 p.m., with Vice Speaker Ilagan presiding.

The invocation was delivered by Representative Scot Z. Matayoshi, after which the Roll was called showing all members present with the exception of Representatives Kitagawa and Mizuno, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Twenty-Sixth and Twenty-Seventh Days was deferred.

INTRODUCTION OF RESOLUTIONS
