Thursday, February 6, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:04 p.m., with Speaker Nakamura presiding.

The Roll was called showing all members present with the exception of Representative Ward, who was excused.

And I know that it's unusual to stand up and speak on second reading, but this bill is really important. This bill seeks to impose greater taxes on people who are selling properties that are between \$6 million and \$10 million. Who can afford \$6 million to \$10 million properties? Only the uber wealthy amongst us.

"But that's not the only reason to support this bill with full heart and support behind it. It's also because of what we create with the special fund through a supportive housing special fund where we will dedicate 8% or \$10 million. Why is this important to me as the chair of the Committee on Public Safety? What did we hear over the last few days? We need more supportive housing. This is the bill that could do that.

"Madam Speaker, last week we experienced chaos caused by an administration far from these shores, threatening to take away funds from nonprofit organizations that provide rent to supportive housing projects. That threat is still there. We need bills like this to move for the working class, local families of this state who cannot afford \$6 million residential properties, who cannot afford the \$10 million residential properties. This measure is what sets us apart and makes us and helps us to ensure that we protect our social safety net. So, in strong support, Speaker. Thank you."

Representative Perruso rose to speak in support of the measure, stating:

"Madam Speaker, in strong support. And I'd like to enter the words of my colleague from Makiki into the record as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Hussey rose to speak in support of the measure, stating:

"Madame Speaker, same request. Thank you," and the Chair "so ordered." (By reference only.)

Representative Alcos rose to speak in support of the measure with reservations, stating:

"Speaker, with reservations. I like to see that we tax higher outside investors or foreign investors. But making it higher taxes on local families that invested their life savings to better themselves and even tax them higher, I feel that the local people should, we be protecting instead of increasing taxes for them. Thank you, so much."

Representative Matsumoto rose in support of the measure with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"Although I support the measure's intent to increase funding to housing programs, I hold reservations regarding restructuring the conveyance tax system in a manner that increases the conveyance tax rates to achieve this. For this reason, I vote with reservations."

Representative Souza rose in support of the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Souza's written remarks are as follows:

"I diverge from most of my Republican colleagues in relation to HB 1410, HD 1 in that I believe that we should restructure the conveyance tax system to promote even-handedness and to relieve any disproportionate burden on the middle class. Moreover, I believe we should, as the bill states: increase the tax rate on non-owner-occupied homes valued at \$2,000,000; slightly increase the tax rate on owner-occupied homes valued at over \$6,000,000; and ensure revenue neutrality for owner-occupied homes valued at \$6,000,000 and under and non-owner-occupied homes valued at \$2,000,000 and under through the adjusted marginal rate structure. This revenue will help our local people with supportive housing. It is not a paradigm shift for

fiscal conservatives to support measures such as this bill. Instead, we must examine each measure for the totality of its merits and not just for the very nature that it increases taxes. Ultimately, it is imperative that we first and foremost rate its merits on what this bill strives to achieve, instead of the burden it might impose on the very wealthy."

"Thank you, Madam Speaker. I rise in opposition. That this bill will pass along wildfire negligence costs from HECO to consumers. A tariff rider is a supplemental charge on a utility bill that is not included in the base rate. Section B-3 of this bill says the PUC may create a nonbypassable wildfire discrete tariff rider recovery charge and other financing costs where the recovery charge, meaning this cost can be passed on to consumers, and also via securitization, would allow HECO to sell unpaid utility debt collections from broken or in debt Maui families to finance this.

"There's a fundamental disconnect with having a public utility that is privately owned and operated for profit. The fiduciary responsibility for profit generation is at odds with good, safe service at low cost. Which explains why we have antiquated distribution on Maui, yet the highest rates in the entire country.

"Considering that in Hawai'i we have the highest electric costs in the nation, I think it's time we reconsider for-profit public utilities when taxpayers have to bail them out. And at a minimum, as a body, we ought not to let a for-profit entity pass along its debt via supplemental charges to those it serves. Given the current administration, I urge us to be working for the people who put us in office, not for the corporations. It is time we stand up for the rights of the middle class. Please join me in voting no on this utility securitization bill. *Mahalo*."

At 12:57 p.m., Representative Belatti requested a recess, and the Chair declared a recess subject to the call of the Chair.

Representative Kong's written remarks are as follows:

"Madam Speaker, I rise in in strong opposition to HB 755. While this bill is only at its second reading, I feel compelled to articulate my concerns. As a legislative body, we have collectively committed to addressing the high cost of living in Hawai'i. However, HB 755 runs counter to that goal by imposing additional financial burdens that will inevitably raise the cost of living for our residents.

"Labor unions, representing thousands of hardworking individuals, have expressed their opposition to this measure, unless the full cost is borne by employers because their members simply cannot afford it. If the very workers this bill aims to support are saying they cannot shoulder the financial impact, we must listen.

"I made a promise to my constituents that we would work to ease their financial struggles, not exacerbate them. For that reason, I cannot, in good faith, support this bill."

Representative Alcos rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

"Thank you, Madam Speaker. I rise in support and I want to thank the Water & Land chair for his work in support of this bill. My bill, right to play, costs very little money and proposes that all state parks and playgrounds and public-school playgrounds have a minimum set of special needs playground equipment for disabled *keiki*. As a rough example, a \$2,000 swing for those who can't walk. Given the backward and often illegal apparently imminent changes at the federal level, excluding our disabled community members and veterans and threatening ADA law, we have a duty to uphold proper standards for our disabled *keiki* so all children may enjoy their right to play.

"Thomas Jefferson said it well when he said, none of us, not one, is imperfect, and were we to love none with imperfections this world would be a desert for our love.

"It is my hope that this body will move this bill forward, clearly demonstrating the compassion and ideals in society and real *aloha* that we all care about. *Mahalo*."

Thank you."

And what a Category 5 hurricane, for example, as a house, if your studs are built 16 inches on center to 24 inches on center, you would have to build it almost like two inches on center, increasing the strength of

the building so much more. And it will cost really high for the state, for us guys to continue building and construction for a Category 5 building and make it almost like bullet proof. And it's probably going to cost construction maybe about two to four times the cost that is standard cost now. So, for that, no vote."

Representative Muraoka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Shimizu rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

"Thank you, Madam Speaker. No vote for the same reasons as the representative from District 41."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. Representatives Tarnas and Kahaloa, for the Committee on Judiciary & Hawaiian Affairs and the Committee on Agriculture & Food Systems, presented a report (Stand. Com. Rep. No. 247) recommending that H.B. No. 1246, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs and the Committee on Agriculture & Food Systems.

Representative Todd moved that the report of the Committees be adopted, and that H.B. No. 1246, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs and the Committee on Agriculture & Food Systems, seconded by Representative Morikawa.

Representative Todd moved that H.B. No. 1246, HD 1 be recommitted to the Committee on Judiciary & Hawaiian Affairs and the Committee on Agriculture & Food Systems, seconded by Representative Morikawa.

At this time, the Chair stated:

"Members, there will be limited debate on the merits of the motion to recommit. Any discussion?"

Representative Iwamoto rose to speak in opposition to the motion to recommit, stating:

"Thank you, Madam Speaker. I speak against the motion to recommit. I'm opposed to the timing. I would like to allow us to vote for second reading and delay the recommittal until the next, potentially before third reading. I never got to sit on a committee to hear this bill debated in front of me. I was looking forward to hearing and asking questions. I also want to, because this is about timing, my understanding is this recommittal then kind of defers the whole bill until next session. So, I'm going to speak to that, the timing of passing a bill or considering a bill like this.

"The media, back in November of 2024, reported in Reuters, New York Times, many credible news sources, that the current administration was in support of descheduling cannabis-"

Representative Quinlan rose to a point of order, stating:

"Madam Speaker, point of order. Please confine discussion to the motion at hand."

Representative Iwamoto continued, stating:

"This is. This is about timing, Speaker."

The Chair addressed Representative Iwamoto, stating:

"Please keep it to the motion to recommit this bill."

Representative Iwamoto continued, stating:

"Correct. If we recommit this bill, it will delay the application of this bill, and I'm afraid that it will open up, potentially, mayhem if the current administration deschedules and we are stuck in a situation where we have no regulation. Again, this is the timing."

Representative Quinlan rose to a point of order, stating:

"Madam Speaker, point of order. We are here to speak about a motion to recommit."

The Chair addressed Representative Iwamoto, stating:

"Please confine your remarks to the motion to recommit, not the future of this bill."

Representative Iwamoto continued, stating:

"The motion to recommit delays the process, which I am speaking to because if the current federal administration deschedules-"

Representative Quinlan rose to a point of order, stating:

"Madam Speaker, point of order."

At 1:12 p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:14 p.m.

Representative Iwamoto continued, stating:

"Thank you very much. Normally what would have happened is there would have been a second reading on the floor and votes would have been taken. I've been quiet on second reading because even though I may not agree on the bill substance, I agree to the further discussion. So, my passivity or quietness in allowing a yes vote, for me, doesn't impugn my position on the substance of a bill. And that's all I'm asking for, is that we have a second reading so that we can just have it recorded that we supported further discussion on this matter. Thank you very much, Madam Speaker."

Representative Belatti rose to speak in opposition to the motion to recommit, stating:

"Thank you, Madam Speaker. I also rise in opposition the recommittal. One, because I would like to get my vote on the record if there is not going to be a roll call vote. Secondly, I think it's very important to note that it has

been rare custom and practice on this floor to actually recommit a bill on second reading in my 18 years here so far. So, for those reasons, I stand in opposition to this recommittal at this time. Thank you."

Representative Perruso rose to speak in opposition to the motion to recommit, stating:

"Madam Speaker, no vote, for many of the reasons stated by my colleagues earlier. And also, I would like to share that I really appreciate the conversations and the debate and the discussion we have in this process. And for me, that's really important. And to have it cut short so early in the process is disheartening. So, for that reason primarily, I'm a no vote."

Representative Amato rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Souza rose to speak in opposition to the motion to recommit, stating:

"Also in opposition to the recommittal, Madam Speaker. And I would also like to raise a point of parliamentary inquiry. I would like to know the reasons why we are recommitting the bill. And so, I'm not sure if you'd like to pose the question to the necessary parties. If that is not granted, I just want it on the record that I am asking as to why we are recommitting. Thank you."

At 1:16 p.m., Representative Todd requested a recess, and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:20 p.m.

Representative Souza rose, stating:

"Madam Speaker, thank you. I just want a response to my request or my point of parliamentary inquiry. Thank you."

The Chair addressed Representative Souza, stating:

"So, there will be no response."

Representative Souza

"So, would that be considered a no to my point?"

Speaker Nakamura: "Yes."

Representative Cochran rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Quinlan rose to speak in support of the motion to recommit, stating:

"Thank you, Madam Speaker. In support. Madam Speaker, just like last session, similar to last session, we were unable to build consensus. And I think it is now time for us to focus on areas where we can build consensus. To focus on the bills that we are able to pass over to the Senate this year and the good that we hope to accomplish for the people of Hawai'i. Thank you."

The motion that H.B. No. 1246, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CANNABIS," be recommitted to the Committee on Judiciary & Hawaiian Affairs and the Committee on Agriculture & Food Systems, was put to vote by the Chair and carried, with Representatives Amato, Belatti, Cochran, Iwamoto, Perruso, and Souza voting no, and with Representative Ward being excused.

At this time, the Chair stated:

"The motion to recommit is carried. Let's go back to, we're going to take the voice vote, then, on all of the items we discussed earlier. All those in favor say aye. All those opposed say no. The motion is carried."

Representative Iwamoto rose, stating:

"Point of order, Madam Speaker. What did we just vote on?"

The Chair addressed Representative Iwamoto, stating:

"All of the 18 pages of bills that we previously reviewed. We're going back to the main agenda."

At 1:23 p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:24 p.m.

Representative Kapela, for the Committee on Culture & Arts, presented a report (Stand. Com. Rep. No. 248) recommending that H.B. No. 925, as amended in HD 1, be recommitted to the Committee on Culture & Arts.
