Tuesday, February 11, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 1:07 p.m., with Speaker Nakamura presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Iwamoto, Ward, and Woodson, who were excused.

There's other situations that 17 year olds want to get married. So, I think this bill is a little bit too restrictive. I think currently the state law is 15 years old you can get married with parental consent, I recommend we just bring that up to 17 years old and not up to 18."

Representative Matsumoto's written remarks are as follows:

"Madam Speaker, I stand in strong support of my bill, HB 572. Hawai'i faces one of the highest costs of living in the nation, putting a heavy financial burden on local families. The economic impacts from recent supply-chain disruptions as well as the COVID-19 pandemic affect nearly 30% of households in 2023, according to Hawai'i Foodbank.

"With these challenges, the state continues to impose this unethical tax on our residents. The 4.5% General Excise Tax (GET) adds approximately \$773 annually to the cost of groceries for a family of four following the USDA's Thrifty Food Plan. Grocery taxes hit low- and middle-income families the hardest, deepening economic hardship and food insecurity. For many of our financially struggling residents, this impedes their quality of life and survival in our state significantly.

"Grocery taxes are particularly a regressive form of taxation, negatively impacting our *kūpuna* and low-income families. Research consistently shows that grocery taxes are linked to higher food insecurity rates. A 2021 study by Cornell University revealed that even modest increases in grocery taxes significantly heighten the likelihood of food insecurity among low-income households. The Food Research & Action Center (FRAC) found that states with grocery taxes of 4% or higher see a 3% rise in food insecurity. Additionally, states that impose grocery taxes tend to rank among the most food-insecure in the nation, as noted in a 2021 study published in Food Policy.

"Several states have taken steps to eliminate grocery taxes, demonstrating the benefits of such measures. Kansas, for example, began phasing out its 6.5% food tax in 2023, planning to eliminate it entirely by 2025. Similarly, Alabama and Virginia have reduced or completely removed grocery taxes, providing relief to residents while balancing budget needs. Georgia's phased elimination of grocery taxes in the 1990s resulted in significant savings for households, alongside job creation and increased economic activity.

"These actions show that removing grocery taxes is possible without straining state budgets and can help reduce food insecurity while boosting the economy.

"Taxing groceries also worsens health outcomes, particularly for vulnerable populations like children and the elderly. It leads to higher rates of obesity, diabetes, and cardiovascular disease due to the problems associated with food insecurity. This also increases long-term healthcare costs and has negative effects on childhood development and mental health. A study published in Health Economics Review found that grocery taxes contribute to food insecurity, which in turn leads to worse health outcomes and higher healthcare costs. Along with this, medical services needed to address these health issues are subject to the GET as well, leading to an even bigger financial burden.

"Hawai'i is already grappling with a severe food insecurity crisis and continuing to tax groceries as well as necessary medical services will only make the financial and health problems worse. Evidence shows that grocery taxes disproportionately harm low-income families, increase food insecurity, and create further health complications. Removing the GET on groceries and medical services would provide immediate financial relief to families, encourage residents to stimulate the local economy through increased consumer spending, reduce food insecurity, and improve overall health outcomes. I urge this body to pass HB 572 and eliminate the GET on essential groceries and medical services, ensuring that residents can have the freedom to make quality of life improving decisions without having to worry about the financial repercussions. For these reasons, I vote aye in strong support."

Representative Souza's written remarks are as follows:

"I oppose this measure, HB 565, HD 1. This bill seeks to amend Hawai'i Revised Statutes Section 441-22.5 so that purchasers providing funeral services that encompass cremation shall include in the contract (1) a provision that requires written notice to the purchaser if precious metals are recovered at the conclusion of the cremation process, and (2) a disclosure that after the receipt of the written notice, the purchaser has thirty days to claim the precious metals recovered, after which the precious metals may be sold or recycled by the mortuary or pre-need funeral authority.

"The issue with this bill is that it regulates the industry by expanding contract language instead of doing what we needed to have done years ago, which is to create oversight of the death-care industry in Hawai'i like how most states regulate the industry: by having a death-care industry regulatory board. The death-care industry globally is slated to reach over \$189 billion globally by 2032 and over \$40 billion in the U.S. by that same time. This is why this matter is important, as the industry is extremely lucrative and a keen eye on consumer protection is paramount.

"Regulation of the death-care industry here in Hawai'i is fragmented between different entities: federal oversight occurs with the Federal Trade Commission (FTC), and locally, it is the Regulated Industries Compliance Office (RICO), the Department of Commerce and Consumer Affairs (DCCA)—its Professional Licensing Division, and the Board of Health—the Sanitation Branch and the Clean Air Branch.

"If this bill becomes law, how do we administratively enforce the contract related to the provisions this bill requires, and what are the consequences to the mortuaries, cemeteries, or pre-need funeral authorities if they do not notify the purchaser about the precious metals? This presents a situation where it is an honor system whether a mortuary, cemetery, or pre-need funeral authority decides to notify the purchaser based on the contract. There is essentially limited recourse in the State of Hawai'i if circumstances go awry and a family has a bad experience when a loved one passes away. We have no licensing requirements for even funeral directors or salespersons in Hawai'i.

"This is such a passionate issue of mine that I wrote my second-year seminar paper about the lack of oversight of Hawai'i's death-care industry in Hawai'i while at the University of Hawai'i William S. Richardson School of Law in 2013. I even wrote about oversight of the death-care industry in Hawai'i again in a Civil Beat opinion piece in 2019 where as a part of my discussion, I noted how in 1963, author Jessica Mitford wrote a bestseller called 'The American Way of Death,' which was the first investigation of its time to expose unethical practices in the death-care industry. It led the United States Senate Committee on the Judiciary's Subcommittee on Antitrust and Monopoly—of which the late Hawai'i Senator Hiram Fong was a member—to probe antitrust aspects of the industry.

"The aforementioned investigation led to increased federal oversight, but Hawai'i as a state has lagged in its oversight of the industry, as we have some of the laxest requirements regulating the death-care industry in the country. We need to regulate the death-care industry in an effective way. The companion bill to this measure was deferred in the Senate (SB 525), and I hope in lieu of this bill we figure out a more robust way of regulating the industry as a whole instead of piecemealing regulations by amending HRS 441 in this manner."
