NINETEENTH DAY

Thursday, February 13, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:09 p.m., with Vice Speaker Ichiyama presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Kitagawa, and Ward, who were excused.

On motion by Representative Morikawa, seconded by Representative Garcia and carried, reading of the Journal was dispensed with and the Journals of the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth, and Tenth Days were approved. Representative Pierick rose to speak in opposition to the measure, stating:

"In opposition. So, this bill basically has tax dollars towards a child development center or a child watching center, where the government can watch your kids. There's lots of daycares. This is just a state ran daycare. So, I think that parents should pay the private sector if they want the private sector to have a part in raising their kids, but not the government."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 241, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CHILD CARE," was referred to the Committee on Finance, with Representative Pierick voting no, and with Representatives Cochran, Kitagawa, and Ward being excused.

Representative Woodson, for the Committee on Education, presented a report (Stand. Com. Rep. No. 564) recommending that H.B. No. 424, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Todd moved that the report of the Committee be adopted, and that H.B. No. 424, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Garcia rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Pierick rose to speak in opposition to the measure, stating:

"No vote with comments. Similar to the last bill, this is basically all the residents of Hawai'i, part of their state income tax goes to the state budget, the state budget goes towards feeding kids in school. That's a very, it's a great talking point, it sounds wonderful. But, we should let parents, if they choose to have sex, if they choose to have kids, if they choose to raise their kids, let them pay to feed their kids, not everybody else."

Representative La Chica rose to speak in support of the measure, stating:

"Madam Speaker, in strong support. Our Committee on Education had the opportunity to hear from amazing students who testified in front of us and just shared very heartbreaking stories of coming to school with this being their only meal of the day. Having heard from teachers who've had to share the news that their own students can't even stand in line and go to the lunch line because their own accounts can't be replenished by their parents. To be eligible for free and reduced lunch, a family of four needs to be making \$47,000 for free lunch. So, if you make \$47,001, you can't get a free lunch. If you're a mom and you have a child, you're not—"

The Chair addressed Representative La Chica, stating:

"Representative La Chica, please address the rostrum."

Representative La Chica continued, stating:

"Sorry, yes, Madame Speaker. So, we're in strong support of this because it's not just nutrition that a child deserves, we all know that a child can't learn when they're hungry. But we all know that this is something that all students shouldn't even have to worry and shouldn't even have to think about. And we're just, on behalf of the Committee on Education, we're just very, very, just encouraged to see and we would like to see the body support this bill and see it through this session. So, in strong support, Madam Speaker."

Representative Kapela rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In strong support. I'd like to adopt the words of the previous speaker as if they were my own. And I would just like to add that this bill boils down to either we care about kids, or we don't. No child should be hungry, and no child can learn if they are hungry. Thank you."

Representative Reyes Oda rose to speak in support of the measure, stating:

"Speaking in support. As the representative from Kona has just said, when we talk about feeding kids, I want everybody to understand what the dollars and cents are for how much it costs to feed a reduced-price lunch, which is what this would be. And for an individual student, that's 30 cents for breakfast and 40 cents for lunch. So, if this passes, what the Legislature is asking for is to pay 70 cents if a kid so chooses to eat both per day for each kid that qualifies for reduced lunch. Representative Perruso's written remarks are as follows:

"With reservations. HB 661 would fundamentally weaken Hawai'i's environmental review process. By allowing previously permitted activities to continue during environmental review, the bill undermines HEPA's purpose, which is to prevent harm before it occurs. The testimony underscores that stopping activities during review is essential to ensuring informed decision-making.

"OHA specifically notes that HEPA has been a critical tool for Native Hawaiian beneficiaries to protect traditional and customary practices. The example of the commercial aquarium trade case illustrates how allowing activities to proceed unchecked would disproportionately harm Native Hawaiian fishers and cultural practitioners. The testimony raises concerns that HB 661 would prioritize permitted activities over indigenous rights.

"Testimony provided on this issue provides concrete examples of how agencies have failed to follow environmental review laws, leading to devastating long-term impacts. The case of East Maui's stream diversions, where streams were drained for 20 years despite a court order, illustrates how HB 661 could further entrench these failures by legitimizing continued harm while legal challenges are pending.

"Environmental review is a mechanism for public participation and accountability. By allowing projects to continue before reviews are completed, HB 661 would sideline public input and place decision-making power in the hands of agencies and special interests without proper oversight.

"The Sierra Club warns that passing HB 661 would pressure decisionmakers to approve projects without fully assessing their long-term consequences, leading to irreversible damage. Environmental degradation, loss of cultural and subsistence practices, and weakened food security are among the anticipated negative impacts. I vote with reservations because it seems to me that this bill would transform environmental review from a preventive measure into an afterthought. Instead of weakening HEPA, lawmakers should strengthen enforcement to ensure compliance and protect Hawai'i's environment for future generations."

No. 1457, HD 1, entitled: "A BILL FOR AN ACT RELATING TO TAX INCREMENT FINANCING," passed Second Reading and was referred to the Committee on Finance, with Representatives Garcia, Muraoka, and Pierick voting no, and with Representatives Cochran, Kitagawa, and Ward being excused.

Representative Tamas, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 629) recommending that H.B. No. 1483, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Todd moved that the report of the Committee be adopted, and that H.B. No. 1483, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Shimizu rose to speak in support of the measure with reservations, stating:

"Thank you, Madam Speaker. I rise in support with reservations and brief comments, please. I'd like to thank the fine representative from Kāne'ohe for this great bill. The reservation I have is based on opposition testimony from HiPyro, which is supposedly the only legal entity that does the Hilton Hawaiian Village shows and 95% of the legal fireworks shows in the state. And according to their testimony, the language of this bill would prohibit them from proceeding with their business. So, my reservation is if the bill can address that situation. Thank you."

Representative Matsumoto rose in support of the measure with reservations and asked that the remarks of the previous speaker be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Garcia rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1483, HD 1, entitled: "A BILL FOR AN ACT RELATING TO FIREWORKS," passed Second Reading and was referred to the Committee on Finance, with Representatives Matsumoto and Shimizu voting aye with reservations, with Representative Garcia voting no, and with Representatives Cochran, Kitagawa, and Ward being excused.

Representative Tamas, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 630) recommending that H.B. No. 129, HD 2, be referred to the Committee on Finance.

Representative Todd moved that the report of the Committee be adopted, and that H.B. No. 129, HD 2 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Pierick rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Garcia rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Muraoka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Shimizu rose to speak in support of the measure with reservations, stating:

"Thank you, Madam Speaker. I rise in support with reservations. I understand the intent of this bill, but the reservation is the message we send

to maybe our youth that there are consequences that are insignificant based on their crime that's committed. So, that's the concern. Thank you."

Representative Reyes Oda rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Kila rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Matsumoto rose, stating:

"I'm going to change my vote to a no vote. Thank you."

Representative Lamosao rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 129, HD 2, entitled: "A BILL FOR AN ACT RELATING TO YOUTH FEES AND FINES," was referred to the Committee on Finance, with Representatives Kila, Lamosao, Reyes Oda, and Shimizu voting aye with reservations, with Representatives Alcos, Garcia, Matsumoto, Muraoka, and Pierick voting no, and with Representatives Cochran, Kitagawa, and Ward being excused.

Representative Hashem, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 631) recommending that H.B. No. 735, HD 1, as amended in HD 2, be referred to the Committee on Finance.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B. No. 735, HD 2, entitled: "A BILL FOR AN ACT RELATING TO WASTEWATER," was referred to the Committee on Finance, with Representatives Cochran, Kitagawa, and Ward being excused.
