#### TWENTY-SECOND DAY

#### Wednesday, February 19, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:05 p.m., with Vice Speaker Ichiyama presiding.
