Representative Reyes Oda rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Shimizu rose to speak in opposition to the measure, stating:

"Thank you, Madam Chair. I rise in opposition with brief comments, please. In respect to the good representative from Hawai'i Island, there was overwhelming testimony in opposition, as well as opposition from HPD and the prosecuting attorney. HPD stated that the requirements of this bill, although well-meaning, would make their job more difficult, requiring more paperwork, and they are already short staffed. I believe our first responders already have a very difficult job, and I would like to listen to their voice, which is telling me, don't make it more difficult for them. So, thank you, Madam Chair, I yield."

Representative Muraoka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Souza rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 128, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CRIMINAL JUSTICE REFORM," passed Second Reading and was placed on the calendar for Third Reading, with Representatives Alcos, Amato, and Souza voting aye with reservations, with Representatives Garcia, Matsumoto, Muraoka, Reyes Oda, and Shimizu voting no, and with Representatives Cochran, Pierick, Templo, and Ward being excused.

Representative Tarnas, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 821) recommending that H.B. No. 141, as amended in HD 1, pass Second Reading and be placed on the calendar for Third Reading.

"In opposition. Thank you, Madam Speaker. I oppose this bill for a few reasons. This bill basically says that the appointees to the Elections Commission, which are appointed by both the majority and minority, will now have to go through the advice and consent of the State Senate. This defeats the purpose of having a truly bipartisan elections commission. A truly bipartisan election commission means both parties get to appoint who they want to serve on this commission. If this bill passes, you all are telling us, the minority, that our appointments have to be approved by the majority party in power. This defeats the purpose. I think this is going to move us in a wrong direction to where the Elections Commission will no longer truly be equally bipartisan. So, for those reasons, a no vote."

Representative Matsumoto rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"This measure proposes a significant change to our electoral process, potentially threatening an already delicate balance within the Elections Commission. Although I support election reforms that make the process more efficient and transparent, I believe this is a step in the wrong direction for creating a bipartisan process where the voices of both parties are heard. For this reason, I vote in opposition."

Representative Alcos rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Muraoka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Shimizu rose to speak in opposition to the measure, stating:

"Thank you, Madam Chair. I rise in opposition with brief comments, please. Although one might say there are theoretical advantages to this change, the minority party will be held to more scrutiny in a chamber that has little representation. So, I believe the current arrangement is appropriate and reduces any political intentions. I'm not trying to say that it happens, but just in case, it would be good to avoid that. Thank you, Madam Chair, I yield."

Representative Tam rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In support. The Elections Commission is not just some average commission that does wield no influence. It has enormous influence. It oversees the elections in the state. It oversees the election workers and the chief elections officer. Similarly, there are many commissions in the state, such as the Real Estate Commission, the Status of Women Commission, as well as the LGBTQ+ Commission that requires advice and consent.

"The advice and consent is a transparency process that allows members of the public to weigh in and testify on people that are going to be sitting on these commissions. And I think something so important, such as the Elections Commission, deserves public scrutiny, deserves people to have to weigh in on who's going to sit on it to ensure that our elections are free and fair. Thank you, Madam Speaker. And for those reasons, I rise in support."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. And at the same time, this is definitely not trying to secure or going against Second Amendment rights in that sense. And it is pertaining to ghost guns being used in the commission of a felony. I think we may all agree that that's probably great that we go against that. Thanks."

So, giving kids access to life saving education in school will help so many families, particularly Native Hawaiian families or students whose families may not be able to afford after-school or out-of-school swim lessons, which on average cost anywhere between \$150 to \$200 a month, something that many families in Title I schools can't afford. So, I also want to thank the chair of Education for allowing this to move forward and supporting water safety access. *Mahalo*."

Representative Hussey's written remarks are as follows:

"Much of the testimony on this measure raises concerns about developing geothermal resources on the island of Hawai'i, or Moku o Keawe. Moku o Keawe is the home of Pelehonuamea, who is the sacred personification of magma, lava, and other destructive and creative natural forces. As a Kanaka Maoli with deep roots on the Big Island, I respectfully object to geothermal development on the island of Hawai'i.

"However, the bill (as an excellent example of general legislation, which is required by our constitution) does not explicitly describe geothermal development on the island of Hawai'i, but rather more broadly supports the Department of Hawaiian Home Lands to explore for geothermal resources on their lands. Because of the broad nature of this wording, I am voting in favor with reservations.

"Early-stage geothermal and hydrothermal research has identified resources throughout the *pae 'āina*. Some of the resources are here on O'ahu, which is where we most urgently need geothermal. I support this bill moving forward with the hopes that it can be utilized to identify geothermal resources on O'ahu and speed our transition to renewable energy."

Representative Amato rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Shimizu rose to speak in opposition to the measure, stating:

"Thank you, Madam Chair. I rise in opposition with brief comments, please. In concept, in all due respect to the good representative from Sand Island, this concept sounds like a great idea, but this endeavor should be done through another entity. We already have HB 1020 that is looking into geothermal, and maybe even promote private industry to get involved with tax incentives or seed money.

"I believe DHHL should be focused on providing living units for their constituents, the Native Hawaiian community. This would be a very costly experiment that will surely require future funding. And the overwhelming testimony of the people in the community do not support this idea and feel a proper communication and opportunity for their involvement was not provided for them. And that is the reason I'm opposing this bill. Thank you, Madam Chair, I yield."

Representative Souza rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

"I just want to quickly say, because this is a bill to look at identifying geothermal resources on DHHL land, that DHHL is the appropriate entity to do that. And I think there is work to be done regarding bringing the community along and making sure there's appropriate consultation. But it's

an incredible opportunity if we can make geothermal energy work in Hawai'i, that could open all kinds of opportunities in the state."

Representative Garcia rose to a point of order, stating:

"Point of order, Madam Speaker. Was it in support or opposition?"

Representative Lowen rose, stating:

"In support."

Representative Poepoe rose to speak in opposition to the measure, stating:

"Thank you, Speaker. In opposition. My opposition isn't a position on geothermal, rather just a concern about the consultation process with beneficiaries. I do think that more needs to be done to engage beneficiaries up front and provide information and a forum for meaningful feedback and engagement. And I think that that information, to me at least, and to many of us, would be helpful in understanding a path forward. So, that's the reason for my opposition. Thank you."

Representative Iwamoto rose to speak in opposition to the measure, stating:

"Thank you, Madam Speaker. I'd like to have the words of the representative from Moloka'i entered in as my own," and the Chair "so ordered." (By reference only.)

Representative Iwamoto continued, stating:

"And I'd like to also add, I am in opposition, as the representative from Moloka'i. So, after reading the bill, it isn't clear where this geothermal exploration would be looked at. And so, I too don't take a stand against geothermal, I just want to see more consultation with the beneficiaries of DHHL.

"Also, perhaps my vote will change when it comes back on this bill will change if the bill clearly states that it's for O'ahu. If that is what this bill is going to evolve, then I'd like that clear. Because right now I understand that the community on Hawai'i Island, there is some confusion, because I believe DHHL has already taken a few steps to look at geothermal on that island, but not on O'ahu, so it might be kind of confusing. Thank you."

Representative Hussey rose to respond, stating:

"Madam Speaker, still with reservations. If I could expound a little bit on my position. One of the things that I really appreciate about the construction of our state constitution is that it precludes the Legislature from passing special legislation that only targets one particular area. At least, we're not supposed to do that. And so, the thing I appreciate about this bill is that it is actually quite broad.

"I also oppose geothermal development on the island of Hawai'i for cultural and religious concerns, but I do think that we need geothermal here on O'ahu. We have a lot of people and not enough land to build the appropriate amount of solar farms and renewable energy plants that we need. So, for that reason, I still stand with reservations, and I appreciate the work of the chair of this committee for moving this measure forward. Thank you."

Representative Kapela rose to speak in support of the measure with reservations, stating:

"Thank you, Madam Speaker. With reservations. I would like to adopt the words of the representative from Moloka'i as if they were my own. And then I would also like to add that I am extremely disappointed in the Department of Hawaiian Homelands for not doing its due diligence and consulting beneficiaries. I recognize that there may have been listening sessions that were done, but there is a process for consulting beneficiaries. And I'm hoping that they'll be able to make sure that they utilize that process in the future. Thank you."

Representative Belatti rose to speak in support of the measure with reservations, stating:

"Thank you in support with reservations. And the reasons for my reservations is for the reasons set forth by the representative from Moloka'i. Thank you."

Representative Grandinetti rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Holt rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In support. I'd just like to note to the body that we're very preliminary in the process. I'm sure the department will do their due diligence and consult with the beneficiaries, and at this point we're still very early in the process, so I would urge my colleagues to vote in support. Thank you."

Representative Souza rose to respond, stating:

"Second time, Madam Speaker, with reservations. And I would like to just note that I am an introducer on this bill and the testimony in the last committee, which is Finance, it wasn't necessarily all in opposition, it was actually a lot of support. And I would like to note also that I do have concerns about the community engagement as well and I do have concerns also about the location. Because I had a lot of letters written to me saying that this would affect Mauna Kea on Hawai'i Island. So, I do have concerns about that. I would also like to insert the words of the representative from Moloka'i into the Journal is my own so ordered. Thank you," and the Chair "so ordered." (By reference only.)

Representative Lowen rose to respond, stating:

"Thank you, Madam Speaker. Still in support. I just want to say, again, his bill is specific to DHHL, but the question of whether there should be additional geothermal expansion on Hawai'i Island I think would be up to a decision between DHHL leadership and the beneficiaries who I think still have to be properly consulted. This is very early stages, so I don't think, if there's been a lack of consultation, it may partly be in part to the fact that funds haven't been appropriated and things are still really at the start of the process.

"But I will say that the idea that my wonderful fellow representatives from O'ahu think there should be no additional expansion of geothermal on Hawai'i Island in general, I think that's a decision for the people of Hawai'i Island. It would help bring our energy costs down if done right. We have incredibly high cost of electricity, higher than here, and could also expand a lot of economic opportunities. So, that's a decision for the people of Hawai'i Island. And that is what I wanted to add. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 1307, HD 2, entitled: "A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS," passed Third Reading by a vote of 39 ayes to 8 noes, with Representatives Amato, Belatti, Grandinetti, Hussey, Kapela, Perruso, and Souza voting aye with reservations, with Representatives Alcos, Garcia, Iwamoto, Matsumoto, Muraoka, Poepoe, Reyes Oda, and Shimizu voting no, and with Representatives Cochran, Pierick, Templo, and Ward being excused.

Representative Tarnas, for the Committee on Judiciary & Hawaiian Affairs, presented a report (Stand. Com. Rep. No. 892) recommending that H.B. No. 1098, HD 1 pass Third Reading.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and H.B.
