## ORDER OF THE DAY

### SUSPENSION OF RULES

On motion by Representative Morikawa, seconded by Representative Garcia and carried, the rules were suspended for the purpose of considering certain House Bills for Third Reading by consent calendar. (Representatives Cochran, Pierick, Templo, and Ward were excused.)

"Thank you. With reservations, brief comment. Madam Speaker, reservations based on previous comments related to the Affordable Care Act and the Prepaid Health Care Act. But I'd also like to note my reservations because of the complex area of the law that this bill addresses. I support fertility preservation and in vitro fertilization services 100% and believe coverage should be something that is available to all.

"There's not much that I agree with coming out of Washington, D.C. these days, but with even the latest executive order around infertility procedures and possibly coverage for these procedures, if there is, in fact, a mandate that comes from the federal government, this would, in fact, then preserve our Prepaid Health Care Act. And so, in this area of fertility services, I just, again, continue to urge caution. Thank you, Madam Speaker."

"I oppose on this bill. I like this bill because it helping the youth and finding a safe house for our kids, and our kids is very important on it. And I like the intent of this bill. But I want to work with is that the parents don't have a right to know where your child is for 90 days. If your child run away and you take away their phone and they feel like it's end of the world, and as a parent, and my wife would be telling me to find my daughter, where is she, she cannot sleep at night. There be anxiety going over, stress on the family. Just not knowing where your child is.

"I would like to see this bill have more parent's right to understand that they're safe, they're in a good place. And we can work with knowing where they are, for 90 days not knowing where they are, or 60 days, just even one day. We just wanna know that our kids are safe, and parents have a right to know where the kids are. Thank you."

Representative Tam rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In support. This bill codifies the state Safe Spaces for Youth program, which sunsets this summer. It's a very wildly successful program that started with Act 130 in 2022. This primarily is about establishing youth homeless shelters. It's not about a bill that would allow runaway kids to just hide away from their parents. I think that that would constitute, probably, like a very small minority of children. And even if they are running away from their parents, it's better for them to be in a shelter where they're safe than on the streets where they can be subjected to violence.

"I also want to make mention that we do not make policy that will affect the vast majority of many of our runaway youth who could potentially be

leaving households riddled with domestic violence or other harmful things, only because 2% or 3% run away because their cell phone was taken away. That's bad policy.

"I also want to point out that according to the National Network for Youth communities, that establishing safe spaces for homeless youth reports higher success rates in terms of improved housing, stability, increased school enrollment, and a reduction in risky behavior. Thank you so much, Madam Speaker."

Representative Kapela rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In strong support. I recently had the privilege of visiting an opening of one of these safe spaces on Hawai'i Island. At this opening, there was a young woman who shared her story as a homeless youth. The really touching thing about this, while I watched this young woman shake uncontrollably to the point where someone from the shelter had to come and stand and hold her as she delivered this speech, talking about the pain that she experienced as a homeless youth, talking about within one day when her entire family became homeless, how her life changed. How she lived on the streets in a tent at 13 years old with her parents. And the thing that stuck out the most was that it was actually her father who was the person who turned her and her three younger siblings over to the state to a safe space like this with the Neighborhood Place of Puna so that they could have an opportunity to not have lice, to go to school, to be fed.

"Spaces like this save lives because that young woman might not be alive. She might not be someone who's now leading other young youth in safe spaces like this if programs like this weren't available. Programs like this save lives. Thank you."

Representative Alcos rose to respond, stating:

"Second time, in opposition. It's not that we don't care about the kids. We do. I agree with the program that looking for one safe space for the kids. I just wish that there is parents to know more about the information and where the kids are. Even though if that's parent might be the one hurting them, then that's maybe take in consideration. But yeah, thank you."

Representative Chun's written remarks are as follows:

"Madam Speaker, I rise in strong support of House Bill 702, House Draft 1, which provides funding to increase Medicaid reimbursement rates for in-home services. At the beginning of the legislative session, this was identified as one of the top priorities for the Legislative Kūpuna Caucus and I want to

thank both the chair of Human Services and the chair of Finance for their work in moving this measure forward.

"As a co-convenor of the Kūpuna Caucus, I believe this bill is critical in ensuring that our *kūpuna* can remain in their own homes with the care they need.

"Aging in place is the preferred option when it comes to housing and care. However, without adequate reimbursement rates, providers are unable to sustain these vital services, making it harder for Medicaid clients to access in-home care.

"HB 702, HD 1 addresses this by increasing Medicaid reimbursement rates to align with the highest scenario modeled in the 2022 Milliman study. By doing so, we can ensure that in-home service providers are paid fairly, help address workforce shortages and ultimately give more *kūpuna* and individuals with disabilities the ability to live at home rather than in institutional settings. Additionally, these funds will be matched by federal dollars, further maximizing the impact of our state's investment.

"For these reasons, I strongly support House Bill 702, House Draft 1. Thank you, Madam Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.B. No. 702, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HUMAN SERVICES," passed Third Reading by a vote of 47 ayes, with Representatives Cochran, Pierick, Templo, and Ward being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 966) recommending that H.B. No. 703, HD 1 pass Third Reading.

"Madam Speaker, I rise in strong support of House Bill 703, House Draft 1, which extends the sunset date for the State Rent Supplement Program for our *kūpuna*. At the beginning of the legislative session, this was identified as one of the top priorities for the Legislative Kūpuna Caucus and I want to thank both the chair of Health and Human Services and the chair of Finance for their work in moving this measure forward.

"As a co-convenor of the Kūpuna Caucus, I believe that this bill is crucial for ensuring continued support for *kūpuna* who struggle to secure or to maintain affordable housing. Many *kūpuna* rely on fixed incomes and, as rental prices have increased dramatically statewide, face difficult financial circumstances that have profound negative effects on their health and well-being.

"HB 703, HD 1 addresses this by extending the sunset date of the State Rent Supplement Program for qualified participants. In this way we can not only mitigate the risk of homelessness in our *kūpuna*, but also extend the intent of Act 98, Session Laws of Hawaii 2023.

"For these reasons, I stand in support of House Bill 703, House Draft 1. Thank you, Madam Speaker."

And I would suggest that there are other options that would be able to address, specifically, those in need. Those are my comments. Thank you, Madam Speaker. I yield."

Representative Marten rose to speak in support of the measure, stating:

"Thank you, Speaker. In support. This bill would cover about 500 pregnant women to receive prenatal services. The minute those babies are born, they are US citizens, and we would like them to have a good start in life and save us money by having that prenatal care that prevents bad outcomes at birth. Thank you."

Representative Perruso rose to speak in support of the measure, stating:

"In support. To follow up on what the previous speaker was mentioning, I think it's important that we talk about what it really looks like to support life and to support families. And we know that right now, hundreds of pregnant women in Hawai'i are denied Medicare coverage. Not because they don't need it, not because they don't qualify financially, but simply because of their immigration status. And these are people who are living and working and contributing to our communities, yet we're denying them lifesaving prenatal care.

"This bill is important because the cost of inaction is severe. Without prenatal care, we know that babies are at a much higher risk of premature birth and neonatal death. And we also know that we spend up to \$8,000 a day on neonatal intensive care, when those costs can easily be prevented with basic early intervention. This bill is not just the right thing to do morally, but it's also the smart thing to do financially.

"I know and I've heard that some of my Republican colleagues question whether we should extend public benefits to non-citizens, and I welcome that debate. But before we get there, I think that we should ask, should any baby born in Hawai'i, regardless of their parent's status, be set up for failure from the start? Thank you, Madam Speaker."

Representative Shimizu rose, stating:

"Thank you, Madam Speaker. Thank you, representatives for sharing that important information. I would like to change my opposition to support. Thank you."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, in strong support. And may I have the words of the representative from Wahiawā entered into the Journal as if they are my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Souza rose to speak in support of the measure, stating:
