THIRTY-SECOND DAY

Friday, March 14, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:06 p.m., with Vice Speaker Ichiyama presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Holt, and Ward, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-First Day was deferred.

ORDER OF THE DAY

INTRODUCTION OF RESOLUTIONS
(FLOOR PRESENTATIONS)

The following resolution (H.R. No. 206) was announced by the Clerk and the following action taken:

H.R. No. 206, entitled: "HOUSE RESOLUTION HONORING AND COMMENDING HERB LEE, JR., FOR HIS CONTRIBUTIONS TO EDUCATION, CULTURAL PRESERVATION, AND COMMUNITY DEVELOPMENT IN THE STATE OF HAWAII," was offered by Representative Marten.

Representative Marten moved that H.R. No. 206 be adopted, seconded by Representative Matayoshi.

Representative Marten recognized Herb Lee for his leadership, his work perpetuating and preserving Native Hawaiian culture, and his support of many cultural, educational and community service organizations; thanked him for his remarkable contributions to our state; wished him joy in his next chapter; and congratulated and introduced honorees who were seated on the Floor of the House:

Herb Lee, Director, Pacific American Foundation;
Wendy Lee, his wife;
Megan Lee, his daughter;
Thelma Lee, his mother; and
Ethan Cooper, Board Member, Pacific American Foundation

Representative Lee honored Herb Lee as a mentor and role model; and shared his appreciation for everything Herb has done for him and our community.

Representative Matayoshi commended Herb's tireless nature; recognized him as a hard worker; and extended his congratulations.

The motion was put to vote by the Chair and carried, and H.R. No. 206 was adopted, with Representatives Cochran, Holt, and Ward being excused.

At 12:26 p.m., the Chair declared a recess to allow the members to meet and congratulate the honorees.

The House of Representatives reconvened at 12:34 p.m.

REPORTS OF STANDING COMMITTEES

Representative Garrett, for the Committee on Higher Education, presented a report (Stand. Com. Rep. No. 1214) recommending that S.B. No. 1146, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Water & Land.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 1146, SD 1, HD 1 pass Second Reading and be referred to the Committee on Water & Land, seconded by Representative Morikawa.

Representative Pierick rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Tam rose in support of the measure and asked that his written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Tam's written remarks are as follows:

"Madam Speaker, I rise in strong support of SB 1146.

"When heavy rains hit urban Honolulu, debris from upstream waterways of the Ala Wai Watershed flow down into the Ala Wai Canal. This debris can consist of organic matter such as leaves and branches, incidental small trash items and often large items such as discarded furniture and mattresses. The debris clogs stream deltas flowing into the canal. These blockages leave the Department of Transportation scrambling to remove the blocking debris before the next rain fall—which could happen within a few hours. Urgency is essential to prevent the blockages from causing major flooding in urban Honolulu.

"The area around the Ala Wai Canal includes primarily high rise residences, housing both working families and visitors. Flooding poses not just damages, but significant hardships to those residing in those areas as elevators cannot operate in flood conditions. This poses a major risk to our *kūpuna* and disabled community members, most especially in the event of an emergency.

"Flooding also negatively affects insurance rates. In a time where insurance rates for homeowners are skyrocketing, a major factor causing insurance carriers to leave the market or charge higher premiums is due to increased likelihood of weather-related disasters making it almost impossible for them to have the capacity to insure homeowners. Insurance carriers must be confident that the state and county are taking proactive measures to prevent weather-related damages for carriers to begin to lower rates and/or re-enter the market. This bill is a proactive measure that manages future debris, supports water quality in the Ala Wai Canal, and mitigates disastrous flooding.

"For these reasons, I stand in strong support of this measure."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. Representative Garrett, for the Committee on Higher Education, presented a report (Stand. Com. Rep. No. 1215) recommending that S.B. No. 1232, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Energy & Environmental Protection.

Also, we know that the 14th Amendment, the due process clause, states, 'nor shall any state deprive any person of life, liberty, or property, without due process of law.'

"I fully support this measure. And for anybody who wants to do further reading on due process and immigration proceedings, the Ninth Circuit published 80 pages worth, may the record reflect that I'm showing 80 pages worth of due process and immigration proceedings that goes back to all of the case law that explains why, perhaps, a bill like this is important. Thank you."

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In strong support. May I have the words of the previous speaker adopted as if they were my own. Brief remarks. Now, more than ever, this type of funding is going to be critical. We are already hearing reports of individuals in our community being detained, potentially, unlawfully. And it's going to be precisely this kind of funding that we're going to need to ensure that the constitutional rights of our citizens are protected. We are already hearing and learning about instances of individuals who are lawfully present in other states and are being detained. And it's going to be here, happening on our shores, if it is already not happening. Thank you, Madam Speaker," and the Chair "so ordered." (By reference only.)

Representative Hussey rose to speak in support of the measure, stating:

"Standing in opposition. So, I very much appreciate the work that this body has done around farm-to-school over the past years. And I do though oppose this particular measure because for a couple of reasons. One has to do with fiscal considerations, which I discussed in the committee hearing a couple of days ago. But what I want to really emphasize today is the process question. So, this measure will allocate an additional \$55 million, in addition to other allocations, but \$55 million to expand the already funded Whitmore Village centralized kitchen from 30,000 feet to 45,000 feet.

"And it's hard to convey the kind of impact that that will have on that community on Whitmore Village without having visited it. But it is a community that is a ways in off of Kamehameha Highway and there is only one road in and out. And they are already subject to a great deal of traffic because of the military at NCTAMS. So, this traffic consideration has been a source of objection for the community for years around conversation around this project.

"And the further process question has to do with the fact that this did not come from our community. Like, this is new information. When I talk to community members, like, did we have meetings that I missed about this? There were no meetings, there was no conversation. So, I really think that we can do better in terms of how we develop policy and really try to build it from the community up so that we can have better outcomes. And for those reasons, I oppose this measure, and I'd like to make a request to insert written comments."

Representative Perruso's written remarks are as follows:

"I am opposed to SB 874, a bill that, while well-intentioned, presents significant challenges for the Whitmore Village community and places an extraordinary financial burden on the state at a time when federal funding is increasingly uncertain.

"Let's start with Whitmore Village. This bill proposes a massive expansion of the Whitmore Village regional kitchen, growing the footprint from 30,000 to 45,000 square feet to produce 60,000 meals per day—on just four acres of land—to feed the students not only in Central O'ahu but in Leeward and Windward complex areas as well. This is increased, not decreased, centralization. While I fully support investing in farm-to-school programs and increasing access to fresh, local food for our *keiki*, this scale of industrialization in the middle of a small, rural community raises serious concerns. Whitmore Village is a residential area, not an industrial food processing zone. The expansion would bring increased traffic congestion, large-scale food distribution operations, and a heavy infrastructure footprint to a community already struggling with limited resources and aging roads.

"Furthermore, the financial implications of this bill are staggering. The \$55.65 million price tag in FY 2026—with millions more to follow in FY 2027—is simply unsustainable given the budget constraints our state faces. We are entering a period of fiscal tightening, with federal funding streams drying up and our state budget already struggling to meet core obligations. Instead of committing to a single-site, high-cost kitchen model, we should be exploring more decentralized and cost-effective solutions, such as empowering existing school kitchens to source and prepare local food directly, rather than funneling everything through a single industrial hub.

"We need accountability in spending and equity in infrastructure development. If we truly want to invest in local agriculture and school nutrition, we should be supporting distributed food hubs across the islands that ensure resilience and sustainability without overburdening one community. We should also be ensuring that local farmers—especially small and mid-sized producers—are at the center of this effort, not just large agribusiness interests that benefit from centralized procurement models."

So, it has no impact on ratepayers besides to help offset electric bills for low-income individuals. So, just correcting the record. Thank you."

"This also harms the biodiversity of the shoreline area with the net loss to tourism, our economy, our quality of life for our community. When it comes

to tourism, let's not kill the goose that laid the golden egg. I vow to protect the environment. I urge anyone who cares about our ocean, environment, or tourism to vote no. Thank you."

"In the testimony before the Water & Land Committee, we were asked to fund the federally funded positions for SOEST. This is not just about climate change and left agendas, pro-environment agendas. When we look at the testimony, the work of SOEST impacts, has economic impacts to the work we do in our community. We rely upon their data for real estate transactions. We rely upon their data for required analysis of sea level rise under the Hawai'i Environmental Policy Act. We depend upon the work of this critical government agency and employees to be able to comply with shoreline setback ordinances.

"As we see our universities, our research institutions gutted, we are going to have economic impacts, and it's going to be bills like this, measures like this that we are going to have to pass, because it is not government fraud, waste, or abuse. It is essential to the running of our economy. So, in strong support for measures like this and many more that will likely have to come given our current situation. Thank you, Madam Speaker."

Representative Souza rose in support of the measure and asked that the remarks of the previous representative be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)
