#### THIRTY-THIRD DAY

#### Monday, March 17, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:05 p.m., with Speaker Nakamura presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, La Chica, and Ward, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Second Day was deferred.

Representative Kahaloa, for the Committee on Agriculture & Food Systems, presented a report (Stand. Com. Rep. No. 1282) recommending that S.B. No. 1547, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1547, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO SPECIAL PURPOSE REVENUE BONDS TO ASSIST ALOUN KAUAI FARMING, AN AGRICULTURAL ENTERPRISE, IN THE FINANCE, OPERATION, AND MAINTENANCE OF A PROJECT TO REVITALIZE THE DAIRY INDUSTRY," passed Second Reading and was referred to the Committee on Finance, with Representatives Cochran, Lowen, Reyes Oda, and Ward being excused. Representative Belatti, for the Committee on Public Safety, presented a report (Stand. Com. Rep. No. 1283) recommending that S.B. No. 1377, SD 2 pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1377, SD 2, entitled: "A BILL FOR AN ACT RELATING TO VETERANS CEMETERIES," passed Second Reading and was referred to the Committee on Finance, with Representatives Cochran, Lowen, Reyes Oda, and Ward being excused.

Representative Belatti, for the Committee on Public Safety, presented a report (Stand. Com. Rep. No. 1284) recommending that S.B. No. 1382 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1382, entitled: "A BILL FOR AN ACT RELATING TO THE NATIONAL GUARD," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Cochran, Lowen, Reyes Oda, and Ward being excused.
