THIRTY-FIFTH DAY

Wednesday, March 19, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:09 p.m., with Speaker Nakamura presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Holt, and Ward, who were excused.

ORDER OF THE DAY

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 849, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO WILDLIFE CONSERVATION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Cochran and Ward being excused.

Representative Hashem, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1373) recommending that S.B. No. 268, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 268, SD 1, HD 1 pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs, seconded by Representative Morikawa.

Representative Amato rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Reyes Oda rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Souza rose, stating:

"Thank you, Madam Speaker. A disclosure. My brother is the vice chair of the Board of Trustees at the Office of Hawaiian Affairs, and this is part of OHA's bill package."

The Chair addressed Representative Souza, stating:

"Thank you for the disclosure. No conflict. And this applies for the rest of session on this item."

Representative Shimizu rose to speak in opposition to the measure, stating:

"Thank you, Madam Speaker. I rise in opposition with comments, please. This bill would remove two positions on the island burial councils. These two positions belong to landowners who serve together, with an additional seven positions that belong to Native Hawaiian interests. During our Water & Land hearing, I heard compelling testimony from Native Hawaiian beneficiaries that have served or are serving on the council, raising their strong support and defense for the great importance of the participation on the council from these two landowner positions.

"They shared that the landowner members were diligent in their meeting attendance that helped provide quorum that would not have been reached without them. It was also noted and clarified that the landowner council member would recuse themselves if the project being voted on was their project. Madam Speaker, I believe it is very important that the minority interests have a voice and representation, and I can relate to that."

Representative Souza rose to a point of order, stating:

"Point of order, Madam Speaker. I think that it's inappropriate to talk about the minority interests when I'm also a minority member sitting on the Water & Land Committee. Thank you."

The Chair addressed Representative Shimizu, stating:

"Representative Shimizu, please continue and stick to your concerns, your personal concerns."

Representative Shimizu continued, stating:

"Thank you, Madam Speaker. Apologize to my colleague for any offense, none intended. With these two positions remaining on the council, the other seven still hold a controlling majority. So, I ask this body to please protect the voice of this representation of this two serving members. And thank you for the opportunity to share."

Representative Muraoka rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Hashem rose to speak in support of the measure, stating:

"Speaker, I stand in support. As the Water & Land chair, I acknowledge that the large landowner interest may be a good balance. However, if you look at the testimony, there were no testimony received from large landowners. So, if it's not important enough for them to write testimony and to fight for their own interest to be on the board, then it's not worth us trying to fight to keep them on. Thank you."

Representative Shimizu rose to respond, stating:

"Thank you, Madam Speaker. I rise still in opposition. And with respect to my Water & Land chair, my understanding is the three testifiers that really compelled me to vote no were representatives of the landowners that served on the island burial councils. Thank you."

Representative Garcia rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 268, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO ISLAND BURIAL COUNCILS," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representative Amato voting aye with reservations, with Representatives Garcia, Muraoka, Reyes Oda, and Shimizu voting no, and with Representatives Cochran and Ward being excused.

Representative Hashem, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1374) recommending that S.B. No. 411, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 411, SD 2, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Amato rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. I rise in support. Our Kihei Small Boat Harbor is falling apart and extremely dangerous. It is so bad, I had to send my chief of staff to meet with concerned community members and we are sending a very detailed report to the DLNR director. We have leaking pipes, and the ramp is so badly degraded that a few weeks ago we had a serious accident that sent someone to the hospital with incredibly serious injuries. The person, I want to add, was a personal injury attorney. We need to repair our small boat harbors before someone dies or the state gets sued. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 411, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO CAPITAL IMPROVEMENT PROJECTS AT STATE SMALL BOAT HARBORS AND STATE PARKS," passed Second Reading and was referred to the Committee on Finance, with Representatives Cochran and Ward being excused.

Representative Hashem, for the Committee on Water & Land, presented a report (Stand. Com. Rep. No. 1375) recommending that S.B. No. 15, SD 1, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 15, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Cochran and Ward being excused.

Representative Kila, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 1376) recommending that S.B. No. 97, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Judiciary & Hawaiian Affairs.

No. 97, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO MOTOR VEHICLES," passed Second Reading and was referred to the Committee on Judiciary & Hawaiian Affairs, with Representatives Amato and Reyes Oda voting aye with reservations, with Representatives Garcia and Pierick voting no, and with Representatives Cochran and Ward being excused.

Representative Kila, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 1377) recommending that S.B. No. 934, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 934, SD 2, HD 1 pass Second Reading and be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Pierick rose to speak in opposition to the measure, stating:

"In opposition. This bill would expand the limitations for spending on the rail. We've already spent \$12 billion. We've already sent, from the state to the county, \$572 million recently, and this is going to expand that, so I'm voting no."

Representative Garcia rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Muraoka rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Shimizu rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Amato rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Matsumoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 934, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Second Reading and was referred to the Committee on Finance, with Representatives Alcos, Matsumoto, Muraoka, and Shimizu voting aye with reservations, with Representatives Amato, Garcia, and Pierick voting no, and with Representatives Cochran and Ward being excused.

Representative Kila, for the Committee on Transportation, presented a report (Stand. Com. Rep. No. 1378) recommending that S.B. No. 1526, SD 2, as amended in HD 1, pass Second Reading and be referred to the Committee on Finance.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 1526, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE DRUG AND ALCOHOL TOXICOLOGY TESTING LABORATORY," passed Second Reading and was referred to the Committee on Finance, with Representatives Cochran and Ward being excused.
