THIRTY-SEVENTH DAY

Friday, March 21, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:10 p.m., with Vice Speaker Ichiyama presiding.

"As the representative for Whitmore Village, I must enter into the record my deep concerns with SB 894. This bill proposes a massive regional kitchen expansion in our small, rural community—one that is misaligned with the values and vision of what a truly sustainable farm-to-school program should be.

"The Department of Education has offered testimony in support of this bill, emphasizing logistical efficiency, high-volume production, and centralized food processing. But that is exactly the problem. SB 894 proposes to turn a model rooted in community-based food sovereignty into a top-down industrial warehouse system—right in the heart of Whitmore Village.

"As a local community member recently testified, this is not the 'farm to school' we were promised. She asked, 'Where are our small farmers in this scenario?' She's right to raise the alarm. In this bill, they are left out. Instead of empowering small, local farmers to serve their nearby schools, we are asked to fund a massive corporate-style distribution facility—at a time when our people are crying out for justice, accountability, and economic prudence.

"The regional kitchen model proposed here will produce up to 60,000 meals per day from one site in Whitmore Village, yet that food will not necessarily be grown in Central O'ahu, nor cooked by local residents for local children. It will be distributed across Central, Leeward, and Windward O'ahu by fleets of vehicles contributing to congestion, emissions, and further wear on our infrastructure—all funneled through a single-lane road already overwhelmed by military and community traffic.

"This model is not resilient. It's not local. And it certainly isn't community-centered.

"Farm-to-school should mean just that: farm. to. school. Grown in the community, prepared by local workers, and served fresh to the *keiki* down the street. This approach supports our small farms, creates real jobs in school complexes, and reduces carbon emissions by keeping food systems decentralized and hyper-local.

"Moreover, the Whitmore community is already bearing the burden of pesticide exposure. Central O'ahu has the highest reported pesticide use on the island, and we are being asked to welcome more agricultural infrastructure that could exacerbate this crisis. There is a legitimate fear in the community that this centralized hub will open the door to larger corporate agricultural players—those who push GMO products and pesticide-laden produce under the greenwashed label of 'farm to school.' That is unacceptable.

"The federal government is cutting funding. Nonprofits are closing. Civil servants are being laid off. Our working families are still reeling from COVID and the Lahaina fire. And now we are being asked to spend \$55 million in one fiscal year—to expand the already huge footprint of one mega-facility when we could have invested all of these now hundreds of millions into renovating our school production kitchens? I respectfully dissent."

Representative Grandinetti rose to speak in support of the measure, stating:

"Thank you, Speaker. Standing in strong support. Madam Speaker, immigrants are an integral part of our community. And many of them, both documented and undocumented, are living in fear because of the current federal administration. In my office, this issue hits close to home. And with permission from my office manager, Emily Cristobal, I wanted to share that her and her family are navigating the difficult process of trying to help her auntie who is currently detained at an ICE facility in Tacoma, Washington.

"Her auntie is a green card holder, a permanent resident who is legally allowed to live in the United States. She moved to Hawai'i when she was just 14 years old. And now at 64 years old, she's stuck at a detention center, forced to wear a yellow uniform with minimal contact with her family. When she was first detained in February, Emily's aunt didn't know her rights and was unaware that she needed to seek legal counsel, which is costly and unaffordable for many. Emily and her family are paying thousands and thousands of dollars to secure legal representation for her aunt. And even with representation, they were told just this week that the next available immigration court hearing is not until July. As of right now, Emily's aunt is preparing to wait at this detention facility for four long, uncertain, and terrifying months. She won't be able to go to her work as a lab tech at the University of Washington, and she could lose her job.

"The targeting of our immigrant community is not just something happening on our phones and TV screens. This is a reality that's impacting our staff, our friends, our families, and our loved ones. It not only impacts people's livelihoods, but most importantly, can tear families apart.

"Under the Sixth Amendment of the Constitution, all people who live in the United States have the right to legal counsel in criminal proceedings regardless of immigration status. Ironically, because immigration-related proceedings are civil, not criminal, this right is not guaranteed in cases like the one Emily's family is encountering. This measure would respect the rights of our immigrant community and ensure they have access to the resources they need for a fair and just court proceeding. For this reason, and out of respect for my office manager, Emily, and in solidarity with her 'ohana, I stand in strong support of this measure. Thank you."

Representative Reyes Oda rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Garcia rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Pierick rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

"Thank you, Madam Speaker. I rise in support with reservations. I'd like to acknowledge the previous testimony in support, but I do have reservations. Thank you."

And I believe that we disenfranchise voters who make the effort to register to vote. And sometimes there are valid reasons why a voter may choose to leave it blank. They're undecided, they're not sure. I can give an example of recent amendments that are worded in a way that is so confusing that a voter does not know what to do. So, I can relate to that. And even as I vote here, sometimes I'm not sure, and I wish there was an option to check the undecided. So, for that reason, I feel that we should not disqualify people who leave a blank vote. Thank you."

Representative Reyes Oda rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Perruso rose to speak in support of the measure, stating:

"In strong support. Madam Speaker, it occurs to me that voting is both a right and a responsibility. And I think that one thing I very much appreciated about the extension of time that voters have with their ballots, with our mailin voting process, because we have additional time to do research, and we have additional time to try to better understand the nuances of the measures before us and the candidates before us. So, I think that it's reasonable to ask voters to, just as we are asked in this body to vote either yes or no on the measures before us, that we can have that same expectation for voters who have time now to do their homework. Thank you."

Representative Garcia rose to respond, stating:

"In opposition. Thank you, Madam Speaker. One of the biggest reasons why people leave their CONAM questions blank is because they simply don't understand what it's saying. I mean, I'm sure all of us here have had family and friends reach out, how do I vote on this? Because nobody understands the lingo.

"In recent years, the Supreme Court struck down a proposed CONAM from this building because the language wasn't simple enough to understand for the average person. If this bill passes, by the way, Hawai'i already has a very low voter engagement, always under 40%-ish. If this bill passes, we are going to give those who do participate in voting on those CONAMs, about 15% to 20% of our entire state population, the ability to amend our state constitution. I don't think this is a good idea. No vote."

Representative Souza rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. Strong support, and can I have the words of the representative from Wahiawa inserted into the record as my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Shimizu rose to respond, stating:

"Thank you, Madam Speaker. Still in opposition. I acknowledge my colleague who was in support. I would agree in theory that people have, quote, enough time to do their research. But it's been my experience, especially as a campaigner going door to door, talking to people, regular people like us, they're so busy, they don't have the time to research.

"And it's not any fault of theirs, it's just that life is very busy. Both parents working jobs trying to pay bills, for them to be aware and confident of their vote for every single candidate for every single issue can be a stretch, and I would hope that the voters would take the time to research, and that would be a great goal, But I think we're not there yet. And I believe that by, again, disqualifying blank votes is a disqualification of people, well-meaning people, that should not be erased. Thank you."

Representative Muraoka rose in opposition to the measure and asked that the remarks of his colleague from 'Ewa and Varona Village be entered into the Journal as his own, and the Chair "so ordered." (By reference only.)

Representative Perruso rose in opposition to the measure and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Perruso's written remarks are as follows:

"I stand in strong opposition to SB 891, SD2, HD1, which proposes to establish a Tourism and Gaming Working Group under the Department of Business, Economic Development, and Tourism.

"While I acknowledge that the House has amended this measure to require the working group to examine strategies to mitigate gambling addiction and financial harm, and to allow some flexibility in appointments and membership, these changes do not go far enough. They may gesture toward public concern, but they fail to shift the fundamental orientation of the bill: a policy process being engineered to serve powerful offshore gaming interests rather than the people of Hawai'i.

"Let's be clear—gambling is not a neutral economic tool. I come to this issue not just as a policymaker, but as someone who has personally witnessed the devastation gambling can wreak on individuals and families. It is not just a matter of revenue—it is a matter of public health, social equity, and long-term economic justice. Legalized gambling disproportionately targets working families, exacerbates poverty, and has cascading consequences for communities already struggling with housing insecurity, food insecurity, and untreated mental health issues.

"The amendments—while well-intentioned—are insufficient because they do not address the fundamental problem: the structure of this working group still enables and even encourages the domination of policy outcomes by corporate gaming entities, many of which have no stake in the well-being of our islands. It is not enough to 'study' the harms of gambling if those sitting at the table are the same ones who will profit from minimizing or externalizing those harms.

"We already see this pattern in the bill's trajectory: public members removed, corporate seats preserved, and the voices of frontline communities and Native Hawaiian leaders diminished. This is not the *pono* way to craft major public policy. It violates the spirit of the Aloha Spirit Law (HRS 5-7.5), undermines community self-determination, and opens the door to a predatory economy that monetizes addiction.

"We have seen this play out across the country: the promises of jobs and revenue too often fail to materialize for local communities, while profits are extracted by mainland corporations. The harms—addiction, bankruptcy, increased crime, and family breakdown—stay right here in our neighborhoods.

"If Hawai'i is to even consider legalizing gambling, it must be done from the ground up—with a framework built by, for, and with our communities. That means centering Native Hawaiian economic sovereignty, creating real regulatory protections before inviting industry input, and ensuring that any decisions about our economic future reflect the values and lived realities of our people.

"SB 891, SD2, HD1 fails to do that. It remains a vehicle for industry-led policy masquerading as community consultation.

"I urge the committee to reject this bill. Hawai'i deserves a better, fairer, and more transparent process for considering such a consequential policy shift."

Representative Grandinetti rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

So, I'd like to oppose this bill as a protest to HECO's raises. Thank you."

Having served the great people of East Honolulu for nearly 27 years, it is with a heavy heart that I have decided to step away from my role in what I have always considered the people's House.

"Embedded in the preamble of our State Constitution, which we have all sworn to uphold, states, 'we reaffirm our belief in a government of the people, by the people and for the people.'

"Remember that the seat you now sit in is not your own, but the people's. Advocate for your constituents' concern with the passion and humility they deserve. It has been the utmost privilege to serve the great people of Hawai'i Kai, Kalama Valley, and Portlock. I wish you all well, continuing to serve the people of Hawaii. With the warmest *aloha*, your friend and colleague, Gene Ward."
