THIRTY-EIGHTH DAY

Monday, March 24, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:06 p.m., with Speaker Nakamura presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Garrett, Lowen, Tarnas, and Ward, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Seventh Day was deferred.

SENATE COMMUNICATIONS

Representative Alcos shared his experience with the work of the Kapolei Neighborhood Security Watch and recognized them as amazing watchdogs for the community, and thanked them for their work.

Representative Alcos rose to speak in support of both measures with reservations, stating:

"Chair, with reservations. Having the rail going to the west side, probably we would like to see it going to make it to Ko Olina, and hopefully the rail can go a little bit more in town. We spent millions of dollars already into the rail. Hopefully that a lot of the money that we spent goes directly to construction, instead of how much of it that will go to management and overhead.

"I would hope to see that this rail serve my grandkids later on down the road. Right now, we fight traffic just coming out here, maybe in traffic about an hour and a half just getting to 'Ewa Beach sometimes on a bad day. I can see if my grandkids get older, it's going to be maybe two hours. Quality time for our families is important, and hopefully that we can cut construction and our costs because when this rail was first introduced, it was way lower, but now within the billions of dollars that it cost. I would like to see the cost drop and find a better solution in building this rail. Thank you."

Representative Pierick rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R.
