Thursday, March 27, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:09 p.m., with Vice Speaker Ichiyama presiding.

The Roll was called showing all members present with the exception of Representatives Hussey and Ward, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Ninth Day was deferred.

"No vote, brief comment. There are certain issues that I see in this particular resolution. The first is that, on the first page, it talks about sanctuary locations. So, it's unclear whether this resolution is meant to create locations or just one location, which it talks about as the resolution goes on. It says that it's asking the governor's coordinator on homelessness to designate a specific location on state or county land. And I guess the question is, prematurely, where would this be? This sounds a lot like the HONU program with the city, and that currently is set up in Kapolei.

"And I also take issue with the fact that we're asking the governor's coordinator on homelessness to contract with qualified churches as one of the entities. So that could be a slippery slope with the Establishment Clause. So, in opposition, thank you."

Representative Shimizu rose to speak in support of both measures, stating:

"Thank you, Madam Speaker. I rise in strong support with comments. This is just an idea and a vision of, again, helping our homeless population and providing a place where they would be cared for and attended to, instead of them having to find places that they think are safe and defecating wherever they are just because they have no place to go. It's interesting that before the previous homeless coordinator was replaced, I did have a meeting with him and presented this resolution. And he was very excited about it, and was saying that he would do his best to try and implement some of these ideas

"Of course, the exact location has to be determined, and that is up for discussion. But again, this is a tool, a option, to help, again, our homeless population. That is a problem that is exploding all around us in all of our communities, I'm sure we experience it. And this is just a proposal to try can say, this is an option, let's consider it. Thank you, Madam Speaker."

Representative Souza rose to respond, stating:

"Second time, thank you, Madam Speaker. Just in rebuttal, I do believe that this resolution is asking for what we already have in place, which is the HONU program. It's asking the governor's coordinator on homelessness and the City & County of Honolulu, who actually is responsible for the HONU program, to basically come up with a sanctuary pilot program that does the exact same thing, from my understanding, that the HONU program does. Thank you."

Representative Garcia rose to speak in support of both measures, stating:

"In support. I just want to mention that it was mentioned that this resolution might have a concern regarding the Establishment Clause because it mentions working with churches. But the State of Hawai'i has for decades worked with nonprofit organizations and they receive both federal and state grants to address homelessness. Many churches do, and I think we should continue working with our nonprofit entities, which includes faith-based organizations. Thank you."

Representative Shimizu rose to respond, stating:

"Still in strong support with comment, please. It was mentioned that this is the same program as the HONU program, which it is not. The HONU project is a temporary model that moves from place to place. This would be more of a, well, it wouldn't be a temporary thing that would be moving around, it would be something that would try to be established.

"And again, this is a two-year pilot program, something that again is really an experiment to see, is this something that will work? It's interesting that the HONU project was mentioned. I did have opportunity to meet in person with the current director of the Law Enforcement, Mike Lambert, who was previously with HPD and involved very intimately with the HONU project, had conversation with him, and tried to learn from him the things that could be put in place that would make this program an advancement to what HONU started to do. So, those are things that I'd like to present to the body. And I appreciate the kind consideration. Thank you, Madam Speaker."

Representative Marten, for the Committee on Human Services & Homelessness, presented two reports:

(Stand. Com. Rep. No. 1607) recommending that H.R. No. 180, as amended in HD 1, be referred to the Committee on Finance; and

(Stand. Com. Rep. No. 1608) recommending that H.C.R. No. 187, as amended in HD 1, be referred to the Committee on Finance.

Representative Todd moved that the reports of the Committee be adopted, and that H.R. No. 180, HD 1 and H.C.R. No. 187, HD 1 be referred to the Committee on Finance, seconded by Representative Morikawa.

Representative Garcia rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Muraoka rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Pierick rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record a no vote for him on both measures, and the Chair "so ordered."

Representative Shimizu rose to speak in opposition to both measures, stating:

"Thank you, Madam Speaker. I rise in opposition with comment, please. With all due respect to my colleague from Lanikai, I appreciate the idea of this resolution and I support it in wholeheartedness. What I oppose is the belief that there will be cuts to Medicaid, which I believe at this time it is untouchable. And as a member of even the Minority Caucus, I would strongly voice my opposition to any administration that would be considering cuts to Medicaid benefits. So, because of that, I rise in opposition. Thank you, Madam Speaker."

Representative Marten rose to speak in support of both measures, stating:

"Thank you, I rise in support. And I would encourage any of my colleagues, should there be cuts to Medicaid, to consider switching parties. Thank you."

Representative Garcia rose to respond, stating:

"In opposition. Thank you, Madam Speaker. I understand there is a lot of concern and fear across our country, and even here in Hawai'i, because the media touts lots of information, which is not true, in that the current administration, the Trump administration, is trying to cut funding to various programs. This reso mentions Medicaid services.

"Madam Speaker, the president has said publicly and openly time and time again during the campaign and since he was sworn in that services which go directly to people, Medicaid, Medicare, Tricare, Social Security, will not be touched, period. All this fearmongering on social media and on the fake news networks is saying that the current administration plans to slash funding is simply inaccurate. Thank you."

Representative Belatti rose to speak in support of both measures, stating:

"Thank you, Madam Speaker. In strong support. It's not simply what the federal president says. The federal congress, in a federal blueprint, has specified amounts of monies they need to cut. People across the nation understand that these programs that support working families, that had been promised to the working people of America, are under threat.

"So, this resolution is not simply about talking about what the federal president has said he may or may not do, but it is in fact part of the blueprint of the congressional budget that we are rallying against. And so, for those reasons, people across the country need to raise their voice. And this chamber should stand up and also register and tell our governor to start planning, because the federal cuts that are coming will likely come in September, and we need to be ready as a state, because it is going to be us and perhaps only us who will be able to help protect our working families. Thank you, Madam Speaker."

Representative Souza rose to speak in support of both measures, stating:

"Thank you, Madam Speaker. I rise in support of the resolution. And I also just want to reiterate that there have already been funding cuts. Go ask the East-West Center, who is operating on their current reserves because the funding has been cut to their cause. And also tell Native Hawaiians who have already received funding cuts to certain nonprofit programs that—"

Representative Garcia rose to a point of order, stating:

"Point of order, Madam Speaker. The current discussion is not regarding cuts in the Medicaid program. That's what the resolution is talking about. Not the East-West Center, not Native Hawaiian nonprofits, Medicaid."

Representative Souza rose to a point of order, stating:

"Madam Speaker, point of order, if the minority floor leader can talk about the Republican perspective and the media narrative and all of the things that he wants to talk about, I can sure as hell do the same thing."

At 12:59 p.m., the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:01 p.m.

Representative Souza continued, stating:

"Thank you, Madam Speaker. I just wanted to reiterate that federal funding cuts have already been happening. And it's important to note too, and I'm going to go to my point of order if that's okay, is that allowable?

"Okay, I'm going to make a point of order on basically what the minority floor leader was saying when he was talking in his speech, if that's okay. My point is that he was making an argument that was not germane to the actual resolution, and he was taking about the media narrative and the Trump administration and his personal views on the matter, which I believe that he also tried to say that I was not entitled to talk about. Thank you, Madam Speaker.

"I just also want to reiterate, too, that as a Republican, I do have another perspective. And I do acknowledge what is currently happening at the federal level, which is germane to this actual resolution. Thank you."

At 1:02 p.m., Representative Garcia requested a recess, and the Chair declared a recess subject to the call of the Chair.

The House of Representatives reconvened at 1:05 p.m.

Representative Perruso rose to speak in support of both measures, stating:

"In strong support and I'd just like to enter the words of the representative from Makiki as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Amato rose to speak in support of both measures, stating:

"Thank you, Madam Speaker. I rise in strong support. I would also like to request the words of the representative from Makiki entered in the Journal as my own, and an additional brief comment, if I may," and the Chair "so ordered." (By reference only.)

Representative Amato continued, stating:

"Thank you. Just today, HHS announced the cut of another 10,000 positions to the health departments. They're taking staffing from regional offices from ten employees down to five. We are naive and foolish if we think that is not going to impact patient care.

"Today here on the floor, we were honoring healthcare heroes. If we don't think this can impact them, we are being extremely short-sighted. I urge our colleagues to vote in support. Thank you."

Representative Matsumoto rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. "Thank you, Madam Speaker. I rise in opposition with a brief comment. I am all for studying ways that we can improve the life of our Native Hawaiians, which we owe our *aloha* culture to. What I am in opposition is to consider gaming. I am totally against gambling, and I believe that that should be taken out of the resolution. But again, to my colleague from Sand Island, Iwilei, I understand options that are being considered. And again, I am all for studying how we can improve the quality of life, which our Native Hawaiian peoples so deserve. But again, I am totally against gaming. Thank you, Madam Speaker."

Representative Pierick rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and H.C.R. Representative Souza's written remarks are as follows:

"I am in opposition to HR 117 and HCR 121, Requesting the United States Department of Defense, United States Army, United States Navy, and State Department of Transportation to work with the appropriate State and County

departments and agencies to expand, plan, and coordinate work related to using Kolekole Pass as an expanded emergency exit route.

"I am in agreement that in the event of an emergency, residents on the westside (specifically west beyond District 43) need another route for ingress and egress aside from Farrington Highway. However, if this issue is significant for the communities on the westside, mainly referring to the communities that comprise House District 44 and House District 45, then having another route for ingress and egress on the mountain in Makakilo in House District 43, should be of equal importance in the event of an emergency or wildfire. The Makakilo Drive Extension was promised to Makakilo residents decades ago and would be a second route for the well over 20,000 residents of Makakilo to have access off the mountain in the event of an emergency. The current mitigation plan of utilizing an access road in the Makakilo Quarry owned and operated by Grace Pacific LLC is not sustainable and merely serves as a bandage for a longstanding problem. I introduced two resolutions this session, HR 9, Requesting the Director of Transportation to establish the Makakilo Drive Extension Task Force to address issues delaying the construction of the Makakilo Drive Extension Project, and HR 14, Requesting the City and County of Honolulu to transfer its authority to construct a Makakilo Drive Extension to the State, in addition to bills I introduced also relating to the Makakilo Drive Extension.

"Equity for all communities is important, especially when it comes to providing safety measures for communities. One community is not more important than another community. It is unfathomable that the safety of my community is not being prioritized when it comes to providing a second point of access for Makakilo residents."

The motion was put to vote by the Chair and carried, and the reports of the Committees were adopted and H.R.
