FORTY-FIFTH DAY

Thursday, April 3, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:05 p.m., with Vice Speaker Ichiyama presiding.

The Roll was called showing all members present with the exception of Representatives Cochran, Hussey, and Woodson, who were excused.

The House of Representatives reconvened at 12:56 p.m.

ORDER OF THE DAY

SUSPENSION OF RULES

At this time, the Chair stated:

"Members, please note that per committee referral sheet number 27, House Resolution No. 128 and House Concurrent Resolution No. 133 have been re-referred solely to the Committee on Public Safety. The Committee on Water & Land waived its referral to these measures and therefore it's appropriate for the House to consider action for adoption."

On motion by Representative Todd, seconded by Representative Morikawa and carried, the rules were suspended to reconsider action previously taken on H.R. No. 128 and H.C.R. No. 133. (Representatives Cochran, Ilagan, and Woodson were excused.)

RECONSIDERATION OF ACTION TAKEN

On motion by Representative Todd, seconded by Representative Morikawa and carried, the House reconsidered its action previously taken pursuant to the recommendation contained in Stand. Com. Rep. Nos. 1678 and 1679, recommending referral to the Committee on Water & Land. (Representatives Cochran, Ilagan, and Woodson were excused.)

UNFINISHED BUSINESS

H.R. No. 128 and H.C.R. No. 133:

Representative Todd moved that H.R. No. 128 and H.C.R. No. 133 be adopted, seconded by Representative Morikawa.

Representative Iwamoto rose to speak in opposition to both measures, stating:

"Thank you, I rise in opposition. I did some research on this floating dock in Pearl Harbor. And the little minimal research I did, did alert me to the possibility that it could be used to further the military's inclusion of more nuclear submarines, more nuclear energy, and the community does have some concerns with that. So, I'll be voting in opposition. Thank you."

The motion was put to vote by the Chair and carried, and H.R. No. 128, entitled: "HOUSE RESOLUTION STRONGLY SUPPORTING THE CONSTRUCTION OF A FLOATING DRYDOCK AT PEARL HARBOR," was adopted, with Representative Iwamoto voting no, and with Representatives Cochran, Hussey, and Woodson being excused; and

(Stand. Com. Rep. No. 1824) recommending that H.C.R. No. 121 be adopted.

Representative Todd moved that the reports of the Committee be adopted, and that H.R. No. 117 and H.C.R. No. 121 be adopted, seconded by Representative Morikawa.

Representative Souza rose in opposition to both measures and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative Souza's written remarks are as follows:

"This pair of resolutions, HR 117 and HCR 121, requests the United States Department of Defense, United States Army, United States Navy, and State Department of Transportation to work with appropriate state and county departments and agencies to expand, plan, and coordinate work related to using Kolekole Pass as an expanded emergency exit route. Another resolution this session, HR 43, HD 1, urging the City and County of Honolulu to work with stakeholders to construct an emergency access road on the Wai'anae Coast, has also moved in the legislative process this session.

"However, resolutions related to the Makakilo Drive Extension, HR 14 and HCR 14, requesting the City and County of Honolulu to transfer its authority to construct a Makakilo Drive Extension to the State, and HR 9 and HCR 9, requesting the Director of Transportation to Establish the Makakilo Drive Extension Task Force to address issues delaying the construction of the Makakilo Drive Extension Project, did not receive a hearing in the House Committee on Transportation this session. These resolutions were introduced in addition to HB 821, which would require the City and County of Honolulu to transfer to the State the City and County of Honolulu's authority to construct a Makakilo Drive Extension.

"At the very least, creating a task force in HR 9 and HCR 9 would allow us to continue the discussion with stakeholders regarding the Makakilo Drive Extension. I absolutely support an emergency access road for the Wai'anae Coast, but no community should be left behind, especially when it comes to safety. The Makakilo community is being left out of the discussion when it comes to our community having an access road. The safety of all communities is important and my 'no' vote on this measure simply reflects the lack of equity for all communities and my continued advocacy for the safety of all Hawai'i residents."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. One portion of these resolutions states: 'WHEREAS, out-of-state vehicles that are not properly registered in Hawaii avoid contributing to the costs associated with maintaining public roadways, which creates an unfair burden on law-abiding residents.' This language assumes that all residents are law-abiding when it comes to registering vehicles, and non-residents or those who have out-of-state vehicles are not law-abiding when it comes to registering vehicles. These resolutions should be calling for each county police department to increase enforcement against all vehicles operating on public roadways that have not been properly registered in the appropriate county, not just out-of-state vehicles. This ensures everyone operating on

public roadways is contributing to the costs associated with maintaining these roadways."

The motion was put to vote by the Chair and carried, and the reports of the Committee were adopted and H.R. With more resources, we can increase collaboration in relation to law enforcement efforts at every level of government. In 2022, the Office of Hawaiian Affairs, in conjunction with the Hawai'i State Commission on the Status of Women, published the Missing and Murdered Native Hawaiian Women and Girls Task Force Report, which stated that 'Native Hawaiian women and girls experience violence at rates disproportionate to their population size.' The Office of Hawaiian Affairs' testimony in support of this measure when it was heard in the House Committee on Judiciary & Hawaiian Affairs referenced the aforementioned report and asserted that 'this report underscored the urgent need for systemic changes, increased data collection, and enhanced federal coordination to address this crisis.' HR 8 and HCR 8 will continue to lay the foundation in the effort to ensure that missing and murdered indigenous persons have a voice as we continue to seek justice for them."

"Madam Speaker, in support. This resolution urges the Department of Health to offer education, outreach, and vaccination access in schools with vaccination rates under 30%. Again, to be clear, this resolution does not force or mandate or require anyone to get vaccinated. It simply addresses a pressing issue, which is that those families with children who do wish to be vaccinated but maybe face certain barriers such as transportation, perhaps they don't have the time, their work schedules don't allow them to do so, or perhaps they're unable to make an appointment with their primary care provider or don't even have health insurance. So, we amended this resolution in committee to also include partnerships with community health centers, federally qualified health centers which are already the providers where our vulnerable populations already go to for healthcare access.

"Again, it's really creating that informed choice so that those that do want to be able to secure vaccinations for their children have the ability to do so. Hawai'i is already facing one of the highest rates in the nation for the lowest vaccination rates for our kids. We have had, in the last couple of years, the highest non-medical exemptions too for our kindergartners. So, it's simply a way for us to provide more public health access and assist our families who are unable to get the care that they need. So, for those reasons, urge my colleagues to support. Thank you, Madam Speaker."

Representative Kapela rose to speak in support of both measures, stating:

"Thank you, Madam Speaker. In strong support, and I would like to adopt the words of the vice chair of Education as if they were my own," and the Chair "so ordered." (By reference only.)

Representative Marten rose to speak in support of both measures, stating:

"Thank you, in strong support. And I just want to note, while this particular bill is trying to increase access, it is not about education. We can hear from the comments we've heard here that there is a lot of misinformation, conspiracy theories, *et cetera*, that are being propagated in our state and are causing people to not take advantage of these life-saving measures that have been around for decades, are known to be safe, are known to be effective, as opposed to general health behaviors, which are great for staying healthy, but do not protect us at all from these childhood diseases that are viruses, *et cetera*. Thank you."

Representative Shimizu rose to respond, stating:

"Thank you, Madam Speaker. Still in opposition with comment, please. I'd like to appreciate the comments made by the vice chair of Education and I acknowledge those important comments. I'd also like to commend the introducer for introducing this in a way because what came out in the hearing for the HB 1118, which was an outpouring of testimony against that bill, was the fact that there was a large percentage of students that are not vaccinated. So, I commend the introducer for highlighting that fact and acting upon that. Again, my opposition is not against the concept, it's just

offering a different point of view to consider. So, thank you, Madam Speaker."

Representative Iwamoto rose to speak in support of both measures, stating:

"Thank you, I rise in support with comments. First of all, I'd like to have the words of the representative from Mililani, Waipio entered into the record as my own. And I also would like to echo the appreciation to the representative from Kaimukī for drafting this important resolution. I strongly support education and access, that's so important with changing behavior. So, I really appreciate this approach. Thank you so much," and the Chair "so ordered." (By reference only.)

Representative Alcos rose to respond, stating:

"In opposition, Thank you. Some of us speak about in getting access to this. So far, if I wanted to take my kids to the hospital, having access was always there. And all of us have access right now to take our families, or whoever wanted to get vaccinated. I just wonder who in this building have 72 shots of vaccination in their body right now. And maybe we don't. Maybe not all of us have. But we took couple vaccination for the measles or some other stuffs like that.

"But this is almost asking the kids that a lot of these guys got to take this shots. I know the bill changed where the parent is supporting, I mean if had the parents right or not. But having this vaccination in our schools, and why we got to pay the extra labor and extra for the medicines and have another department to go out there when you can just simply go to the hospital.

"Now, one department said that, Department of Health said that there was only about five cases in Hawai'i that had suffered some of these disease out here in Hawai'i. But that's probably like a 0.1% or something like that. And we spending all these millions of dollars in vaccinating and all this effort in trying to help all our families. And I feel that we should be paying for maybe more beds for in the hospitals. Maybe helping the doctors more in certain way. But this is the reason why I am in support, thank you. In opposition."

Representative Souza rose in support of both measures and asked that the remarks of the vice chair of Education be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative Grandinetti rose in support of both measures and asked that the remarks of the vice chair of Education be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

This resolution urges the governor to create a task force on military partnerships to develop and strengthen the public-military relationship in Hawai'i. The resolution, to me, it provides an opportunity for another photo-op between the governor and the military, the governor who represents us, the people of Hawai'i. And it's been clear many times that the military has, in one case even walked away from the table where there was a conversation happening, specifically about Red Hill. And we had a community election to elect our representatives to that panel, and the military was supposed to attend and they chose to pull back.

"So, there's a lot of opportunities for these conversations that the military has fallen short. And including on talking about housing, we know there's a lot of military dependents who live in the community instead of living in housing on base and that drives the price of housing up. There are a number of other issues that I wish this resolution went a little bit deeper into. Thank you so much."

Representative Shimizu rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. I rise in strong support with a brief comment. I acknowledge the previous words of my colleague and I would choose to look forward and not behind of past mistakes that have been made. And trying to establish common ground that we can move forward in a positive way that would benefit the people of Hawai'i and not be so maybe fixated and stuck on what has gone wrong. Yes, there is admission that things could have been better, mistakes have been made. But I would choose to, again, look for the common ground that we can build on something positive and look forward. That's my hope for this resolution. Thank you, Madam Speaker."

Representative Souza rose to speak in opposition to the measure, stating:

"Thank you, Madam Speaker. In opposition and just a brief comment. I think that there's just really broad language in this resolution, and I would prefer if it was limited to a specific issue or something of that nature. Thank you."

Representative Amato rose, stating:

"Thank you, Madam Speaker. I would like to, in opposition, I'd like to change my reservations to a no vote, please. And I would like to adopt the words of the representative from Kaka'ako as if they were my own. Thank you," and the Chair "so ordered." (By reference only.)

Representative Souza's written remarks are as follows:

"SB 1202 allows campaign funds to be used for a candidate's child care and vital household dependent care costs under certain conditions. I support this measure, as we should ease the financial burden for those who seek elected office and have child care and/or vital household dependent care costs. These costs could be a deterrent for individuals when determining whether they are able to run for office due to financial hardship. This bill would level the playing field for candidates in these situations."

Representative Kapela rose to speak in support of the measure, stating:

"Thank you so much. In support. I have 17-month-old. I came back to work, we started session when she was about a month old. And it was so difficult to be able to balance and juggle all of these different things. And I know that there are other young women out there who want to be about to serve their communities in this capacity. And bills like this will be able to allow them to utilize the campaign funds that they've raised to allow them to actually campaign in their communities and serve their communities to the best of their ability."

"For child care per month, I was quoted \$2,700. That's more than we make. That makes this job unattainable for young women. So, for me, I appreciate you giving me the grace to go back and talk about this bill, because this will make all the difference when it comes to changing what our body looks like over time and allowing young women and young men to be able to participate in this process. Thank you."

Representative Todd rose to speak in support of the measure, stating:

"In support. I just wanted to adopt the prior speaker's words and add that my daughter was born two months before the primary. I have an extremely fortunate family situation with grandparents able to help, but not everyone has that situation. And I'm hopeful that a measure like this would go a long way. Thank you," and the Chair "so ordered." (By reference only.)

Representative Kahaloa rose in support of the measure and asked that the remarks of the chair of the Culture & Arts Committee be entered into the Journal as her own, and the Chair "so ordered." (By reference only.)

Representative La Chica rose to speak in support of the measure, stating:

"Same request, in support, adopt the words of the chair of the Culture & Arts Committee and also brief comment. Madam Speaker, I too started campaigning for office with my first child. I remember being able to go around door to door pushing a stroller. Many in my community still remember us doing this and he's now eight years old. And if not for the actual change in rule with Campaign Spending Commission, they actually already are able to do this and review this on a case-by-case basis, but this would make the rule applicable to all candidates moving forward. And so, this would enable many of us who do not have family, such as myself, on the islands who are able to help care for our kids while we go out and campaign but enable those to be able to enter office and serve in their capacity, similar," and the Chair "so ordered." (By reference only.)

Representative Keohokapu-Lee Loy rose to speak in support of the measure, stating:

"Thank you, Madam Speaker. In support, same request to adopt the words of our Culture & Arts chair as my own, brief comment, please. Child care is tough. Child care for a special needs child is even tougher. What this policy does is really level the playing field for anyone interested to serve in these seats, have an opportunity, and know that their child will be taken care of. Thank you, Chair," and the Chair "so ordered." (By reference only.)

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1202, entitled: "A BILL FOR AN ACT RELATING TO CAMPAIGN FINANCE," passed Third Reading by a vote of 44 ayes to 4 noes, with Representatives Alcos, Garcia, Muraoka, and Shimizu voting no, and with Representatives Cochran and Woodson being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1925) recommending that S.B. No. 21, SD 2, HD 2 pass Third Reading.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. No. 21, SD 2, HD 2, entitled: "A BILL FOR AN ACT RELATING TO WATER CARRIERS," passed Third Reading by a vote of 45 ayes to 3 noes, with Representatives Amato, Iwamoto, and Lowen voting no, and with Representatives Cochran and Woodson being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1926) recommending that S.B. No. 934, SD 2, HD 1 pass Third Reading.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 934, SD 2, HD 1 pass Third Reading, seconded by Representative Morikawa.

Representative Reyes Oda rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Matsumoto's written remarks are as follows:

"As noted in the testimony from the Honolulu Authority for Rapid Transportation (HART) during the FIN Committee hearing, The park and ride project in Pearl Highlands has been deferred. This creates an issue within the bill, as the completion of the project was a required condition for the disbursement of funds from the Mass Transit Special Fund. I oppose this

measure because the proposed Pearl Highlands Park and Ride garage was removed from HART's amended FFGA project scope. This removal does a disservice to our community members of Mililani and central O'ahu who currently have no parking structure to use the Honolulu Skyline."

Representative Iwamoto rose and asked that the Clerk record an aye vote with reservations for her, and the Chair "so ordered."

Representative Shimizu rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Alcos rose and asked that the Clerk record an aye vote with reservations for him, and the Chair "so ordered."

Representative Iwamoto rose, stating:

"Madam Speaker, I made a mistake, I stood up in support with reservations, however, my actual vote should be no."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 934, SD 2, HD 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," passed Third Reading by a vote of 43 ayes to 5 noes, with Representatives Alcos, Reyes Oda, and Shimizu voting aye with reservations, with Representatives Garcia, Iwamoto, Matsumoto, Muraoka, and Pierick voting no, and with Representatives Cochran and Woodson being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1927) recommending that S.B. No. 1120, SD 1, HD 1 pass Third Reading.

Representative Todd moved that the report of the Committee be adopted, and that S.B. No. 1120, SD 1, HD 1 pass Third Reading, seconded by Representative Morikawa.

"Thank you, Madam Speaker. I rise in opposition with a brief comment, please. As I had previously shared, I believe that vaccine immunization has a place. And my concern with this bill is investing in products that do have expiration dates, products that will be constantly being upgraded and updated with the mutation of any particular disease. Again, just the concern of looking at things from a more naturopathic way. So, that's my concern and my opposition to this. Thank you, Madam Speaker."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 1434, SD 1, HD 1, entitled: "A BILL FOR AN ACT RELATING TO UNIVERSAL IMMUNIZATION FUNDING PROGRAM," passed Third Reading by a vote of 40 ayes to 8 noes, with Representatives Alcos, Garcia, Kong, Matsumoto, Muraoka, Pierick, Reyes Oda, and Shimizu voting no, and with Representatives Cochran and Woodson being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1933) recommending that S.B. No. 1443, SD 1, HD 1 pass Third Reading.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B. However, I wasn't elected to come here and state my views, I was elected to amplify the voices of my community. And my community has reached out to me incredibly forcefully, with a lot of communication saying they do not want the securitization bill. And for those reasons, my personal views don't apply. I have to follow the wishes of my community, so I have to vote no. Thank you."

The motion was put to vote by the Chair and carried, and the report of the Committee was adopted and S.B. No. 897, SD 3, HD 2, entitled: "A BILL FOR AN ACT RELATING TO ENERGY," passed Third Reading by a vote

of 43 ayes to 5 noes, with Representatives Amato, Garcia, Ilagan, Iwamoto, and Pierick voting no, and with Representatives Cochran and Woodson being excused.

Representative Yamashita, for the Committee on Finance, presented a report (Stand. Com. Rep. No. 1935) recommending that S.B. No. 1500, SD 2, HD 1 pass Third Reading.

On motion by Representative Todd, seconded by Representative Morikawa and carried, the report of the Committee was adopted and S.B.
