Thursday, March 27, 2025

The House of Representatives of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 12:09 p.m., with Vice Speaker Ichiyama presiding.

The Roll was called showing all members present with the exception of Representatives Hussey and Ward, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Thirty-Ninth Day was deferred.
