The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mrs. Hannah B. Harris of the Ke Alaula Oka Malamalama Church, after which the Roll was called showing all Senators present with the exception of Senator Saiki who was excused.

The President announced that he had read and approved the Journal of the Second Day.

At this time, Senator Taira introduced to the members of the Senate a group of Juniors and Seniors from the Political Science Class at Moanalua High School, with their teacher, Mr. Eric Heu.

At 11:36 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:40 o'clock a.m.

SENATE RESOLUTIONS

The following resolutions (S.R. Nos. 4 and 5) were read by the Clerk and were disposed of as follows:

A resolution (S.R. No. 4), entitled: "SENATE RESOLUTION COMMENDING MAJOR GENERAL HARRY W. BROOKS, JR., THE MEN OF THE 25TH INFANTRY DIVISION, UNITED STATES ARMY AND THE WAHIAWA COMMUNITY AND BUSINESSMEN'S ASSOCIATION FOR THEIR HIGHLY SUCCESSFUL PROGRAM CELEBRATING NATIONAL BROTHERHOOD WEEK", was jointly offered by Senators Kuroda, Ching, Young, F. Wong, Chong, Hara, R. Wong, Yamasaki, Hulten, Yim, Henderson, Rohlfing, Leopold, Nishimura, Takitani, Taira, George, Toyofuku, O'Connor, Ushijima,

King, Anderson, Saiki and Kawasaki.

On motion by Senator Kuroda, seconded by Senator Ching and carried, S.R. No. 4 was adopted.

Senator Kuroda then introduced to the members of the Senate Major General Harry W. Brooks, Jr. and his wife, Doris. Major General Brooks was then escorted to the dais by Senator Kuroda where he was presented with the resolution just adopted. Major General Brooks then addressed the members of the Senate accepting the resolution on behalf of the officers and men of the 25th Infantry and the Wahiawa Community and Businessmen's Association and expressing their appreciation for this honor.

A resolution (S.R. No. 5) entitled: "SENATE RESOLUTION EXPRESSING SYMPATHY TO THE FAMILY OF ELIZABETH C. 'BETTY' WONG", was jointly offered by Senators Ching, Anderson, Chong, George, Hara, Henderson, Hulten, Kawasaki, King, Kuroda, Leopold, Nishimura, O'Connor, Rohlfing, Saiki, Taira, Takitani, Toyofuku, R. Wong, Yamasaki, Yee, Yim, Young and Ushijima.

On motion by Senator Ching, seconded by Senator Taira and carried, S.R. No. 5 was adopted by a rising vote.
