

NINETEENTH DAY

Monday, February 10, 1975

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1975, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Anselm Gouveia of St. Augustine's Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Eighteenth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Taira introduced a group of thirty Juniors and Seniors from the Problems of Democracy Class at Damien High School, with their teacher, Mr. John Kelly.

Senator Yee then introduced 80 students from the Ninth Grade at Sevenson Intermediate School, with their teachers, Mrs. Libby Lum, Mrs. Arlene Peiterson and Mr. Ron Abe.

Senator Saiki introduced Mrs. Jane Burgio, Republican Assemblywoman from New Jersey, who is serving her first term in the Assembly.
