The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Bill Tipton of the First Baptist Church of Honolulu, after which the Roll was called showing all Senators present with the exception of Senator Anderson who was excused.

The President announced that he had read and approved the Journal of the Fifth Day.

At this time, Senator Yee introduced to the members of the Senate 30 junior and senior students from St. Louis High School and their teacher, Mr. Rod Santos.
