Wednesday, February 4, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Norman Hammer of the Prince of Peace Lutheran Church, after which the Roll was called showing all Senators present, with the exception of Senators Kawasaki and Soares, who were excused.
