

FORTY-FOURTH DAY

Tuesday, March 23, 1976

The Senate of the Eighth Legislature of the State of Hawaii, Regular Session of 1976, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Bishop Yoshiaki Fujitani of the Honpa Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senator George who was excused.

The President announced that he had read and approved the Journal of the Forty-Third Day.

At this time, the following introductions were made to the members of the Senate:

Senator Kuroda introduced 11 enlisted men of the Second Artillery Battalion, Eleventh Regiment, U.S. Army, who are students of the American Government Class, St. Louis High School Adult Education program at Schofield Barracks, and their teacher, Mrs. Cavanaugh.

Senator Hulten introduced 60 second and third grade students from Laie Elementary School, together with their teachers, Mrs. Oshima, Mrs. McCullen and Mrs. Hill, and parents, Mrs. Kelleher, Mrs. Beatty and Mrs. Lingwall.

Senator Kawasaki then introduced Mr. Frank Oda, past President, United Japanese Society of Hawaii.

Senator Kawasaki also introduced Mr. Takayoshi Mizushima, Chairman of the Board of Directors, Hakubi Kyoto Kimono School and Kyoto Kimono Consultant Association, of Kyoto, Japan.

Mr. Takayoshi Mizushima then presented to the Senate a yellow and red floral bouquet of chrysanthemums, irises and roses. The President thanked him on behalf of the Senate for the "beautiful bouquet".
