## EIGHTEENTH DAY

Friday, February 11, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Father Patrick H. Freitas of the St. John Vianney Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Seventeenth Day.

At this time, Senator O'Connor introduced to the members of the Senate the Honorable Cecil Heftel, recently elected United States Senator, State of Hawaii, stating that he did so "with a great deal of Aloha and pride".

The President appointed Senator O'Connor to escort Congressman Heftel to the rostrum, where he was presented with a red carnation lei by Senator King.

The President then stated:

"It certainly is our pleasure to welcome you to the Senate Chambers this morning. This is the first time for you to address the members of the Senate, and we know that you have a message to convey to us. Welcome, again."

Congressman Heftel addressed the members of the Senate as follows:

"Mr. President, Honorable Members of the Senate:

This is a very interesting and sensitive moment, because I have been in office but a month and this is my first time to address our State Senate.

You gain a feeling for the legislative process, which can only be explained after you have been a part of the process ...and it is evident, in just a short month, that the best thing Hawaii's representatives in Congress can do for the people of Hawaii is to work together—work together with each other, with you, and with our House of Representatives.

Hawaii is a small state in terms of people, and a long way from Washington in terms of miles...and no one or two individuals, acting as individuals, are going to provide the legislative needs for Hawaii in Washington, just as no one or two individuals will provide

our needs in our own Hawaii Legislature.

Personally, I am looking forward to our first meeting on Tuesday as a delegation with the Governor, with this Body, with the House of Representatives, with the City Administration, and then with the administrations of each of our Neighbor Islands.

Hawaii is very much one State. Someone was saying something about how do you represent one half of the State versus the other, in terms of interests. I said, 'The only thing I know is that if I only feed the top half of my body, I'm going to die. I think we have to look at Hawaii the same way. This is one integral unit. Whatever happens anywhere within it affects all of us'.

As far as personal awareness of the legislative process is concerned, it feels good after fifty to be a freshmanto be learning again, to be reminded of how much I didn't learn, and how much there still is to learn.

I hope that, as time passes, our delegation of four in Washington, working with our leadership in Hawaii, can make positive, sensible decisions, and find how best to express our needs to the new Administration in Washington ...how to resolve our problems so that when we ask for solutions, we are not in conflict with each other.

And then, so you may all smile with me...and some of you will smile more than others...one of the first bills that came to Congress upon my arrival was a judgment of the Pay Commission that the wages of those in Federal office and Federal appointed offices should be increased. I could only sit there and say, 'What an interesting irony for me, personally'.

Also, I am learning a compassion for those who suddenly realize you are working with a group, and have to think in terms of that group—that you can't just act or think as an individual. I am quickly learning how to best operate as a part of a group trying to do that which is best for Hawaii.

Normally, when you work together in a legislative body, when you work together in a delegation representing a state, you do the best possible job for the people. As time passes, we'll have a number of problems. I hope we find proposals that we can agree upon together, so that we can find the best solution for everyone--not

perfect solutions, but the best solutions available.

My thanks to you, Mr. President, for inviting me, and to you, Members of the Senate, for joining with me. I hope we will have much dialogue with the passing of time. Mahalo."

At this time, the following introductions were made to the members of the Senate:

Senator Ching introduced student observers from Wheeler Intermediate School.

Senator Yee introduced 90 third grade students from Ala Wai School, accompanied by their teachers, Ms. Joanne Liu, Ms. Mary Ann Ane and Ms. Ruth Izawa, and a parent, Mrs. Yamada.

Senator Chong introduced Mrs. Maxine Ting Ting Hong Kingston, author of "The Woman Warrior: Memoirs of a Girlhood Among Ghosts". He then presented her with a red carnation lei and a certified copy of Senate Reflution No. 168, which was adopted on Thursday, February 10, 1977.

At 11:46 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:47 o'clock a.m.

At this time, Senator Young introduced to the members of the Senate 31 sixth grade students from Mililani Uka Elementary School, accompanied by their teacher, Mrs. Elsie Tanaka, and a student observer, Mr. Gilbert Hara.
