

FIFTY-NINTH DAY

Tuesday, April 14, 1977

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1977, convened at 11:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Ned Brown of the Pali View Baptist Church, after which the Roll was called showing all Senators present with the exception of Senator Anderson who was excused.

The President announced that he had read and approved the Journal of the Fifty-Eighth Day.

At this time, the following introductions were made to the members of the Senate:

Senator Kawasaki introduced a group of fifth grade students from the Social Studies class at Aliamanu Elementary School with their teachers, Herbert Matsumoto, Naomi Watanabe and Irene Taniguchi.

Senator Soares introduced members of the fourth grade at Aina Haina School, with their teachers, Mrs. Ruth Miyashiro, Mrs. Harriet Tanegawa and Mrs. Midori Onaga.

MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 462 and 463) were read by the Clerk and were disposed of as follows:

A message from the Governor (Gov. Msg. No. 462), transmitting a report entitled, "The Biology of Opihi", which was prepared by E. The Senate reconvened at 11:20 o'clock a.m.

The President then appointed Senator Kuroda to escort Brigadier General Schaefer to the rostrum where he addressed the members of the Senate as follows:

"Members of the Senate, thank you so much for bestowing this honor on me today.

It has really been my honor to have been able to serve the State and our country for these past thirty-five years. Believe me, it has been a labor of love.

Certainly, this service has been made more pleasant by the support of the National Body, our Legislature and State Administration have given us, and to the great people that have served with me through these many years in the National Guard.

This service that I have given certainly would not have been possible without the support and understanding of my family, and I acknowledge the presence of my wife here today,

who sat behind me all these years.

Senator King then rose to speak for the nominations as follows:

"Mr. Speaker, I rise to speak in support of the motion. I rise dismayed that I have to take the time of this body today to speak on behalf of the nominations before us.

One of the appointments is Dr. Ruth Gay, a researcher of plant physiology at the University of Hawaii and an instructor in botany.

The other is the appointment of Dr. Edward Shallenberger, Vice President and Director of Park Operations at Sea Life.

These two nominations have been deferred now for three days. The Senator who has been requesting the deferral and soliciting votes against the nominations has said he has nothing against the two individuals involved; that it has nothing to do with their merits or with them personally. He says that he is seeking a balance on the commission; that he doesn't want it dominated by 'pure

environmentalist' scientists; that he wants more on the commission who support aquaculture.

Dr. Shallenberger, of course, right now is working closely on aquaculture with the Oceanic Institute so I'm not sure what the problem is there. I'm not sure either just what a 'pure environmentalist' is. I tend to be leery of labels anyway--pure environmentalists, developer, politician, whatever. Labels, of course, are always much easier to deal with than individuals, but I think we owe people the fundamental respect due them to treat them as individuals, not categorize them.

This session, among the nominees sent to our Committee were two appointees to the Environmental Quality Commission which, coincidentally, we heard the same day as Dr. Shallenberger's and Dr. Gay's nomination. I suppose these other two nominees you could brand as 'developers'. One was President of Lone Star Hawaii, President of Island Construction, Vice President of Lear-Seigler, Hawaiian Properties Division. The other, now in real estate, was formerly sales manager for Kaiser Hawaii Kai Development Company. We duly noted that but we didn't categorize them.

We didn't take a broad brush and smear them with a label of our choosing, and then because they had that label, hang them. We looked at them as individuals, reported them out free and clear just as the committee reported out free and clear the nominations of Dr. Gay and Dr. Shallenberger. And when you look at people as individuals, Mr. President, you see differences.

Yesterday, just coincidentally, I received a copy of the latest minutes of the Animal Species Advisory Commission, and I found differences recorded in the minutes--differences between Dr. Ziegler and Dr. Gay. Individuals are different. (I won't take the time of this body to quote the minutes.)

I said I'm leery of labels--to the extent, however, Mr. President, that there is a group called environmentalists, and I'd like to say just a sentence about them.

First, I think anyone living in Hawaii can't help but be an environmentalist.

Second, there is something, it seems to me, strikingly and refreshingly different about this group from most of the people who come to see us, testify before us.

Like all of you, a lot of people come

to see me, call me, write me about something they want. Much of the time what they want, I like, often am enthusiastic about and would like to help implement. But it is, and this is no negative comment, it is mostly something that will help them, economically.

One group that doesn't ask something of personal economic benefit are the environmentalists. They come from all walks of life... computer analysts at Straub, housewife, whatever. They have their family and working lives but they give of their time and of themselves, not for their personal economic benefit, but for what they believe will be to the long range pleasure and satisfaction of all of us, including those of us yet to be. Agree with them or not, let's give them that.

To return to the nominations before us, the Legislature, in setting up the Animal Species Advisory Commission specified, 'The Commission shall consist of 11 members to be appointed by the Governor. Six of the members shall be scientists in the fields of botany, mammalogy, ichthyology, entomology, ornithology and invertebrate zoology.'

There is a reason for that. What we wanted on the Advisory Commission was a balance and so we specified all these different fields related to the purposes of the Commission.

Mr. President, when we put scientists on a commission, we don't want rubber stamps. Rubber stamps are a dime a dozen. We want from these scientists their very best judgment. We want them to use their collective specialized knowledge to help the State make the wisest decisions we can, both short and long range. We want them to help us consider aspects we might not have, and they would be derelict in their professional integrity and in their sworn responsibility to the State if they did otherwise.

It seems to me, Mr. President, that what's happening here is we're making token hostages of two qualified people. Token hostages to shoot down--to try to gain some other end.

It's true, that as Senators, we can vote up or down anybody we choose, for any reason we choose, but what the Senate of the State of Hawaii is, is up to us; depends on what we do and how we do it. What people feel about their government, we help determine by what we do;

why we do it.

The nominations of Dr. Edward Shallenberger and Dr. Ruth Gay are before us. Two individuals, respected in their fields, eminently qualified under the statutes, against whom no one says they have anything. After due notice, we had a public hearing and public decision-making. The committee report with signatures free and clear lies before us, part of the public record of the Senate.

I had been asked if I would recommit this matter. Of course I would have if there had been good cause, one involving the merits of the individuals themselves, but, no one says there is. The only way then that I would have recommitted it was if the individuals themselves had said that they would prefer it that way.

Tuesday afternoon at 6:30 p.m., I met with Dr. Shallenberger and Dr. Gay in my office and explained the situation to them. I told them they might well be voted down on the floor and mentioned to them the alternative of recommitment. Their immediate unwavering response, 'We'd rather have it out in the open. We'd rather have it out in the open then quietly pulled back into committee without it ever being clear why; the reason shrouded over the epitaph, "Mr. President, I recommit."'

If we want to change the statute to call for other qualifications, Mr. President, let's change the statute. Because the nominations of these two eminently qualified people happen to come when they did, let's not shoot them down--token hostages!

Thank you, Mr. President."

Senator Yim rose to speak in opposition thereto as follows:

"Mr. President, I rise to speak against the reappointment of Ruth Gay and the appointment of Dr. Shallenberger to the Animal Species Advisory Commission.

Mr. President, the Animal Species Advisory Commission was established by law within the Department of Land and Natural Resources to serve in an advisory capacity to the Fish and Game Division. The Commission is composed of eleven members, six of whom must be scientists with a specific expertise.

I am deeply concerned about the composition of this Commission because of the serious effect it might have on our emerging aquaculture industry.

As you well know, this 1977 Legislature has been in full support of aquaculture development. At present, only one member of the Commission has shown an inclination to encourage aquaculture in this State. The other five may be termed, as I personally classify them to be, 'environmentalists' in the purest sense.

On May 28, 1976, the Animal Species Advisory Commission held a meeting with eight of the eleven members present. At that meeting, one of the persons under consideration for confirmation, Ruth Gay, introduced a resolution, seconded by Alan Ziegler, opposing Senate Resolution No. 257. Senate Resolution No. 257 was adopted by this honorable body during the 1976 Legislative session, requesting the Federal government to consider allowing only commercial fishing within the northwest Hawaiian waters. The vote on Ruth Gay's resolution was five in favor and three opposed. All five members of the Commission who voted in favor are what I consider to be 'pure environmentalists.'

In addition, the Animal Species Advisory Commission's voting record reveals frequent opposition to introduction of exotic species into this State. When one considers that the Tahitian and Malaysian prawns, as well as sugar and pineapple were once exotic species, one can readily appreciate the potential danger these individuals pose to our economy. The Malaysian prawns, as developed by Takuji Fujimura, traces its origin back to the two original parents. Therefore, there is an obvious need to improve the genetic strain. To do this, we must import prawns from Australia, Taiwan, and the Philippines.

In a few weeks, Kahuku Farms will be selling oysters on the local market. Continued success of this achievement depends upon Kahuku Farm's ability to import oysters and clams from outside the State.

In the Aquaculture Development Plan under consideration this session, there are provisions for research on the marine salt water shrimp. In two years, it could be a major breakthrough, with world-wide impact and that is, the breeding of salt water shrimps under laboratory conditions. But to accomplish this, we must import shrimps from all over the world for experimental purposes. If we allow the environmentalists to go unchallenged, then these importations might not be possible. If this be so, we should then forget about developing an aquaculture industry

in Hawaii.

I oppose the confirmation of Ruth Gay and Dr. Shallenberger not because of their lack of integrity, character, or the necessary experience, but I oppose them because they are closely allied to what I call the 'pure environmentalists.' I oppose them simply on the grounds of equity, fairness, and balance.

On the Animal Species Advisory Commission, three of the six scientists so noted by law, should be persons who favor aquaculture development. This State is blessed with a great number of scientists with impeccable credentials who have encouraged aquaculture and demonstrated a strong concern for preserving the environment.

Mr. President, in summary, I merely want to present the need for a variety of opinions to be expressed in the Animal Species Advisory Commission. Simply put, I am only asking for equity and balance in the Commission.

For these reasons, Mr. President, I will vote against the confirmation of Ruth Gay and Dr. Edward Shallenberger.

Thank you."

Senator Kuroda then rose to speak against the confirmations as follows:

"Mr. President, in speaking against the confirmations, I share the concerns of the previous speaker about the future economic development of the State--namely, aquaculture.

Like the two previous speakers, I don't think we're taking action on these people on the basis of the person, the merit.

In 1972, I was a member of the Senate Judiciary Committee. At that time, there was a bill to eliminate this very special Commission that we are now discussing. I happen to be the swing vote on the Judiciary Committee. My vote would have decided whether this Commission would remain or would be abolished--although, one could not predict how the votes would have come out on the floor of the Senate.

At that time, I felt that there was a need for people to talk and discuss things rather than just merely eliminate this Commission.

It happens to be the same kind of concern today as in 1972. The purists are, in this case, the scientists

vs. the hunters.

After the session in 1972, I followed up my concern and attended the meetings of this Commission. I have followed up with personal discussions and correspondences and I found that these attitudes expressed by the scientists left no room for the hunters to express their concerns.

This experience then has remained with me and when the Senator from the Fifth District shared his concern with me, he called my attention to the fact that we face a difficult time today and if these people on the commissions, although advisory, are going to affect the economic growth of Hawaii, then I think that we need to re-evaluate these people who occupy very important commissions.

Thank you."

Senator King then stated, "Mr. President, just for the record, I'd like to say that I'm staunchly in support of an expanding aquaculture industry for the State and that the environmentalists I know are all enthusiastic supporters of an aquaculture industry for the State."

Senator King then asked if the Senator from the Fifth District would yield to a question, to which Senator Yim replied that he would.

Senator King then queried if the Senator had ever spoken about his views to Dr. Shallenberger.

Senator Yim answered as follows: "No, but I would be much happier if such names as Dr. Colin Nash, Dr. Stephen Smith, Dr. Spencer Malecha and Dr. Robert May--any of those combinations--would be excellent representation for the State as far as aquaculture is concerned."

Senator King then added, "The answer is No. Thank you, Mr. President."

With the impending collective bargaining package that may come

down this afternoon, the word is out that the Senate wants to have an extension. We have discussed the matter, Mr. President, and we have not taken a position one way or the other on it as yet.

I think it is premature for us to make any statements to this effect. We want to see when the package arrives and how we will handle it; after that, it is problematical.

We hope that we can resolve the problem with the Body across the way and the Governor, but we have not asked for an extension. We do not feel that an extension is absolutely necessary because mechanically, it can be handled.

However, there are other extenuating circumstances and these have to be taken into consideration before we decide as to what we are going to do in the days to come.

Thank you."

Senator R. Wong then rose on a point of personal privilege and remarked as follows:

"Mr. President, in line with the remarks of the Majority Leader, I would like to say that in terms of the budget, the Senate is prepared to conclude its business and adjourn sine die tomorrow.

This is how it can be done, Mr. President:

First, with the Senate budget now in the House and the combined House/Senate adjustments in revenues and the 1976-77 expenditures, we have a balanced financial plan with a surplus of \$21 million; and

Second, this surplus should be adequate to meet the costs of the collective bargaining package expected to be submitted tonight. We can deck the collective bargaining bill tonight for the 24-hour lay-over.

If the House is serious about going home tomorrow, I presume they are prepared to accept this proposal. However, Mr. President, I hope they realize that this precludes an opportunity for public hearing and input on the collective bargaining package.

If this is what they want to do, Mr. President, so be it.

Thank you."

At 12:31 o'clock p.m., the Senate stood in recess until 8:00 o'clock p.m. this evening.

In accordance with Article III, Section 16, of the Constitution of the State of Hawaii, the 24-hour notice was given on H.B. No. 264, H.D. 1, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO CONSTRUCTION AND MAINTENANCE OF SIDEWALKS".

At 8:31 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 8:32 o'clock p.m.

Senator Takitani, for the majority of the Committee on Higher Education, presented a report (Stand. Com. Rep. No. 1152), recommending that Senate Resolution No. 410, as amended in S.D. 1, be adopted.

Senator Chong then rose to speak against the resolution as follows:

"Mr. President, I rise to speak against this resolution specifically calling for a study of the tenure system at the University of Hawaii.

At the hearing held on this yesterday, it was pointed out that not a single University in the entire country has abolished, or does not have, a tenure system.

The mere fact that this resolution calls for this Committee to look into this system would severely affect the morale of the University of Hawaii faculty. It would affect the quality of applicants that you would have at our University and, it would, in general, create a terrible situation on campus, especially among the faculty and ultimately for the students.

I urge all Senators to vote against this resolution."

Senator Kawasaki then stated as follows:

"Mr. President, I did not intend speaking on this particular resolution, but I think the statements made by the previous speaker are just preposterous!

As I recall some years ago, it was threatened that there might be a mass exodus and I said 'be my guest'. Now if there is any member of the faculty at the University of Hawaii who feels very insecure because we are asking for a legitimate study of the tenure system at the University, then I repeat my invitation, 'be my guest'.

I know there are many brilliant young scholars, intellectuals, who can become capable faculty members and who are interested in serving at the University of Hawaii.

Mr. President, my staff compiled the breakdown of the number of jobs over at the University that pay in excess of \$30 thousand a year in compensation. We found that there are 548 positions paying over \$30 thousand a year. With this 4.2% increase in compensation contemplated by the collective bargaining contracts just agreed to, this brings that figure up higher.

I compared the compensation of the faculty at the University of Hawaii with some leading colleges in the nation, and I must say I can well understand why people who want to serve on the faculties of universities find job positions at the University of Hawaii very much to their liking.

I don't particularly worry about the unrest that we are going to create at the University of Hawaii by a call for a study of the tenure system.

I think this was long overdue.

I think that this condition where over 80% of the faculty are tenured at the University of Hawaii is quite an unusual situation in the nation, and this resolution is justified.

As I said, if anyone is uneasy about the permanency of their job because of a study that is required, then, 'be my guest. Feel free to leave.'

Thank you."

Senator O'Connor then remarked as follows:

"Mr. President, I did not intend to speak on this either until the earlier speaker had something to say.

I would encourage everyone to vote in favor of this resolution.

I am informed that today, 60% of the faculty at the University of Hawaii voted in favor of ratifying a contract, which in fact abrogate tenure for a considerable percentage of people at the University. If such be the case, then certainly we should study this matter in the interim since tenure is in fact a tenuous situation, at best, at the University.

Thank you, Mr. President."

MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. No. 467) transmitting the cost data on wage increases agreed to with Units 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 and 13, in accordance with Section 89-10(b), Hawaii Revised Statutes; noting that the wage increases agreed to for the fiscal biennium 1977-79 including additional employers' Social Security (FICA) contribution will be funded from the following sources: for FY 1977-78, General Fund; \$7,114,745; Federal Funds, \$1,243,576; Special Funds, \$1,321,772; and Other Funds, \$831,127; for FY 1978-79, General Fund, \$12,943,362; Federal Funds, \$2,161,898; Special Funds, \$2,306,082; and Other Funds, \$1,557,032; stating that the increased cost of the employer's contribution to the Employees' Retirement System has not been included in the above compilation as the cost will not be reflected in the Executive Budget until FY 1979-80 and FY 1980-81 and at that time, it will be \$3,433,531 and \$6,639,068, respectively, was read by the Clerk and was referred to the Committee on Ways and Means.
