The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Ned Brown of the Pali View Baptist Church, after which the Roll was called showing all Senators present with the exception of Senators Kawasaki and Young, who were excused.

The President announced that he had read and approved the Journal of the Fourth Day.
