#### THIRTY-THIRD DAY

### Monday, March 6, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Jack F. Belton of the Ewa Beach United Methodist Church, after which the Roll was called showing all Senators present with the exception of Senator Leopold, who was excused.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

The following introductions were then made to the members of the Senate:

Senator Yamasaki introduced thirty-seven senior citizens from Maui, with twenty-five of them from Paia and twelve from Haliimaile, with their leaders, Mr. and Mrs. Edwin Nakamoto. Among those in the group were Mr. and Mrs. Alfred Boteilho from Paia who are the parents of Mrs. Linda Cravalho, member of the Clerk's Staff.

Senator Chong then introduced a group of senior citizens from the Makule Aikane Club from the Moiliili Community Center.

Senator Yee introduced 86 students from the eighth grade at Hawaii Baptist Academy, with their teachers, Mrs. Joyce Wong and Mr. Malcolm Harris.

Senator Kawasaki introduced Mr. and Mrs. David Blumenthal from Palo Alto, California. Mr. Blumenthal is the official NFL photographer for the New York Jets. He has been a professional sports photographer for the past thirty years and is the originator of the slow motion analysis of sports. Mrs. Blumenthal is an artist specializing in oriental designs.

Senator Anderson introduced forty members of a group of senior citizens from the Hui Lima o'Halewai from Waialua.
