

FORTY-SEVENTH DAY

Tuesday, March 28, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Eiji Ikenaga of the Honolulu Myohoji Temple, after which the Roll was called showing all Senators present with the exception of Senators Nishimura and Yee, who were excused.

The President announced that he had read and approved the Journal of the Forty-Sixth Day.

Senator Toyofuku introduced to the members of the Senate Mr. and Mrs. Paul Shinseki and their son, Kyle, from the Island of Kauai.

MESSAGES FROM THE GOVERNOR

Senator Leopold then spoke against the measure as follows:

"Mr. President, I have serious concerns about this bill for two reasons.

First, I don't think that people

will come to this State specifically to get on our State program for the Unemployed. I think that when they do come, they have a difficult time in finding a job and I think it is better that they are able to participate in such a program rather than to have them go on our welfare rolls, as the latter would place an even greater burden on our taxpayers.

Secondly, the definition of 'residency' by the terms of the Committee Report is to be determined by the Department of Labor and Industrial Relations. I think this presents us with a possibility for arbitrary definitions with one department defining residency one way and another department defining residency another way.

Mr. President, for these two reasons, I would like to record a 'no' vote on this bill. Thank you."
