The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:36 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Pam Vessels of the Hawaii Council of Churches, after which the Roll was called showing all Senators present with the exception of Senator J. Wong.

ORDER OF THE DAY

THIRD READING

Senate Bill No. 603, S.D. 1:

Senator Hee moved that S.B. No. 603, S.D. 1, be recommitted to the Committee on Judiciary, seconded by Senator Menor.

Senator Hee then rose to speak on the recommittal as follows:

"Mr. President, Senate Bill 603, S.D. 1, Relating to Drug Paraphernalia, is the bill that I'm asking this body to consider to recommit and the reasons are very simple. We now know that the House will act upon Senate Bill 151 which was passed in 1987, which would outlaw the sale of drug paraphernalia. In essence, Senate Bill 151 would do very similar things as S.B. 603.

"Relying on the faith of the Senate President and the Speaker of the House, our caucus is confident that Senate Bill 151 will come back to the Senate with the language of the model act inserted. To that degree, Senate Bill 603 becomes a superfluous vehicle at this time.

"As chairman of the Senate Judiciary Committee, I want to assure all members on the committee and in this body that this Senate took the position of outlawing drug paraphernalia in 1987, not yesterday. We acted quickly; we acted swiftly. Senate Bill 603 which was decked on Friday, two days prior to the Governor's State-of-the-State address, was simply a means to provide our intent once again to the House that the Senate is committed to the ban on any sale of drug paraphernalia and has demonstrated that commitment in 1987, and we will demonstrate that commitment in 1988.

"Thank you, Mr. President."

Senator Holt also rose to speak in support of the recommittal and said:

"Mr. President, in support of the motion and as a member of the Judiciary Committee, I just would like to say that I'm doing it with the expectation that Senate Bill 151 will come over from the House immediately and not two weeks from today."

The motion was then put by the Chair and carried and S.B. No. 603, S.D. 1, entitled: "A BILL FOR AN ACT

RELATING TO DRUG PARAPHERNALIA," was recommitted to the Committee on Judiciary.

RE-REFERRAL OF HOUSE BILL

The President re-referred H.B. No. 842 to the Committee on Business Development and Pacific Relations, then to the Committee on Ways and Means.

Senator Holt rose on a point of personal privilege and said:

"Mr. President, the Senate Tourism Committee finally received the state administration's consultant contracts today, and for this body's information the three contracts total \$503,000. These contracts are not site selection studies, but rather are site assessment studies.

"The three preliminary agreements were entered into on December 1. We are assuming that the consultants have been working without a signed contract for about seven weeks, as these contracts were just notarized on or about January 20, 1988. Performance of services on all three contracts in each one of these contracts shall be completed -- I think it's an important point -- by June 30 of 1988.

"Last year, Mr. President, in this article by Jerry Burris on May 1: '"The just completed session which began with high hopes and ended 63 days later on a note of high drama gave the administration a blueprint for its own initiative on the convention center," Waihee said. "We will select a site next session," the Governor vowed.'

"I guess by the dates of the contracts when these services will be completed, this body will not be receiving any specific site recommendation from the Governor this session. The only hope, and a slim one at that, is for the House to come up with its alternative site recommendation then we can compare it to the Ala Wai.

"Mr. President, as I said, I'm flexible. The House Tourism chairman has publicly said that he will pick a site within two weeks. Now, since the Governor and the House seem to be having difficulty in selecting a site, maybe we should turn this over to the Mayor because he said he could do it cheaper and faster.

"Mr. President, in rising on this point, I just would like to say that we will be having a public hearing tomorrow morning at 9:30 a.m., of joint houses, an informational briefing on the convention center site assessment studies. The Director of the Department of Business and Economic Development will be there to testify and answer why the Governor started these contracts in December when he could have started it as early as May of 1987. Thank you."
