At 11:45 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:47 o'clock a.m.

Senator Matsuura then rose on a point of personal privilege and said:

"Mr. President, this is in regard to the editorial 'Reconsider Penebacker' in this morning's Advertiser. I would like to read a portion of this editorial because I firmly agree with it. It says:

'Despite official statements to the contrary, the state Ethics Commission says no opinion was asked for or given before Board of Education member John Penebacker was appointed deputy state librarian.

'That should be grounds enough for the BOE to rescind the controversial appointment, if it wants to do the right thing.'

"And it goes on and says:

'Problems with the new deputy state librarian's post began when it was first advertised as requiring a library science master's degree and five years' experience. If the job had asked for knowledge of the libraries' problems plus political and community relations experience, no one would say Penebacker, a longtime government union workers, was unqualified.

'But as things stand, this looks like another case in which there is a hidden agenda and political muscle

counts for more than merit in filling a state job. That's bad, especially in education.'

"It is time some of us who are in public office stand behind these professional librarians and support their concerns and their disappointment. I say this because professional people, especially librarians need to be heard. We don't want to dampen their enthusiasm, their optimism or their dedication. I want it on record that I stand behind them and I agree with the content of this morning's editorial regarding the selection procedure.

"Thank you, Mr. President."

Senator Holt also rose on a point of personal privilege and said:

"Mr. President, pardon my ignorance, but in the last year we've been looking at a lot of tourism related legislation and we've been studying the legislative intent and history of passing a transient accommodations tax. I have not found any reference to us using a 5 percent tax to build a world-class zoo.

"And if anybody here can help me out, Senator Yamasaki, and tell me where in any committee report or any legislation you can find any reference to using the tax dollars that we collect and the proceeds from the transient accommodations tax to build a world-class zoo, I'd appreciate it. Thank you."

Senator A. Kobayashi also rose on a point of personal privilege and said:

"Mr. President, this is a follow-up to our remarks the other day from the women of the Senate and we do have our letter ready that will be going out to Mr. Bartholomew Kane. We're sending it out today and I'd like to read it:

'Dear Mr. Kane,

'The women of the Hawaii State Senate wish to register their extreme disappointment with the recent action by your office and the Board of Education that not one qualified applicant could be found from the pool of professionally educated and certified librarians for the position of Deputy State Librarian. In a profession which is predominantly female, we are very concerned about the lack of women in any administrative position in your office.

'Based on testimony submitted at the meeting of the Board of Education of January 28, 1988, we have learned that, with the exception of the secretary and her assistant, all the administrative officers in the office of the State Librarian are male.

'This situation has prompted us to question your hiring procedure. In particular, we would like your immediate response to the following:

- '1. When filling vacancies for administrative positions in the office of Library Services, is there a selection committee which assist in this process?
- '2. What policies and guidelines are used in the final selection process?
- '3. Please send job descriptions for all administrative positions in your office.

'We would greatly appreciate your prompt attention and action to this request. We look forward to hearing from you in the very near future.'

Senator B. Kobayashi also rose on a point of personal privilege and stated:

"Mr. President, like a lot of us here I think, some of my friends are librarians, and recently I got an earful from one of them about the Penebacker appointment.

"Generally, I would agree with the prior speakers that the appointment should be reconsidered. I think at this point we are embarking on a delicate situation in which we are tempting to change a situation after the fact. Nonetheless, the library system has long suffered under a variety of difficulties including its leadership with regard to how it fits in to the Department of Education.

"I think the appointment has not helped the situation from the public perception even though it may help the situation from the point of view of relations with the Board of Education. Thank you."

Senator A. Kobayashi then responded to the previous speaker's comments and said:

"Mr. President, the women of the Senate are not asking for reconsideration. We just would like to know the hiring procedures and we'd like to insure that this does not happen again in the future."

Senator Matsuura then introduced Mr. Shigeru Kansako and his two "ronin" who are representatives of the sugar industry in Hawaii.
